Statistics

Arrests included: 4 for public intoxication, 3 for shoplifting, 6 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 3 for domestic violence, 4 for possession of a controlled substance, 4 for DUI, 7 for warrants, 3 for trespassing and 1 each for; violating probation or parole, battery and assault with a deadly weapon. Probation or parole holds were placed on 2 of these arrests.

Officers investigated 2 traffic collision.

Officers investigated and took reports of: 8 found property, 5 missing persons, 2 death investigations, 4 abandoned vehicles, 2 suspected child abuse, 2 mental health evaluations, 3 vandalisms, 2 thefts, three animal bites and 1 each for; elder abuse, city code violation, domestic dispute, transportation of marijuana, burglary, and vehicle theft. theft.

Officers assisted the Mendocino Major Crimes Task Force and the Mendocino County Sheriff's Office.

The Patrol Division's average response time to in-progress calls was about 4 ½ minutes. The average response time to all other calls was a little less than 16 minutes.

Highlights for the Week

On 02/26/2015, at about 445 PM, a Ukiah Police Department Officer was dispatched to 824 Waugh Ln. regarding an adult male seen jumping from the roof of AA Storage (830 Waugh Ln) 824 Waugh Ln. Upon the officer's arrival the male was observed on the roof of 824 Waugh Ln and asked to come down. The male complied and was identified as 23 year old Daniel Taylor. Taylor claimed he had been retrieving a ball that had gone over the fence. While the officer spoke with Taylor, Taylor displayed symptoms of being under the influence of a controlled substance. A records check of Taylor indicated that he was currently on Post Release Community Supervision (PRCS). The officer evaluated Taylor and determined that he was under the influence of a controlled substance. Taylor was arrested for being under the influence of a controlled substance and violation of his PRCS terms. Taylor was booked into the Mendocino County Jail. 15-0623

On 02/27/15 at about 119 AM, a Ukiah Police Department Officers heard Mendocino County Sheriff's Office dispatch broadcast a multi-person fight at the Discovery Inn, 1340 N. State St. Officers were nearby the location and responded to assist until the deputies arrived. Upon arrival, officers contacted a subject that appeared to have been involved in the fight. This subject pointed to two other subjects in red sweat shirts and exclaimed that the two were involved as well as, one of them possibly being armed with a firearm. Officers contacted these two subjects with one being identified as 20 year old Isaac Aparicio. A records check revealed that Aparicio had a warrant for his arrest from West Covina Superior Court. Sheriff's deputies arrived and completed the investigation regarding the altercation. Aparicio was issued a citation to appear in the West Covina Superior Court and released. 15-0638

On 02/28/2015 at about 126 PM, Ukiah Police Department Officers were dispatched to Wal-Mart (1155 Airport Park Blvd) regarding a physical disturbance in progress. Upon arrival Officers contacted the victim, who is a Wal-Mart employee and the suspect who was identified as 23 year old Derek Moyer. During the investigation officers learned that Moyer was attempting to place a money order at Wal-Mart, but that Moyer was failing to follow directions. Wal-Mart staff attempted to explain to Moyer what he needed to do to complete the transaction but Moyer became increasingly hostile with Wal-Mart staff and was asked to leave the store. Moyer refused to leave the store when requested to do so and continued being hostile towards employees. The victim employee then approached Moyer and told Moyer that he and his dog needed to leave the

store as he was being disruptive. After Moyer refused to leave the store, the employee took hold of Moyer's dog leash and asked Moyer to leave the store once more. When the employee did this, Moyer pushed the employee in the chest with two hands causing the employee to fall backwards into a wall. When officers attempted to speak with Moyer regarding the matter, he became argumentative and officers noticed that Moyer was displaying symptoms of alcohol intoxication. Moyer was placed under citizen's arrest for battery and booked into the Mendocino County jail. 15-0641

On 03/01/2015, at about 304 PM, a Ukiah Police Department Officer observed 38 year old Amber Thomasson seated at the bus stop, on the corner of Mason Street at Clara Avenue. The officer was aware that Thomasson was wanted for several Mendocino County arrest warrants. The officer stopped and contacted Thomasson. Thomasson was placed under arrest for the warrants and during a search of her person she was found to be in possession of a controlled substance. Thomasson was booked into the county jail. 15-0649

On 3/2/2015 at about 1204 PM, Ukiah Police Department was dispatched to the 1100 block of S. State St. regarding a fight between two males in which one of the males was armed with a knife. This male was later identified as 19 year old Thomas Hanover. Once officers were in the area Hanover had fled and was located in the 800 block of S. State St. During the investigation officers learned that Hanover had been following two females and appeared to be arguing with one of them. The victim observed this and attempted to get Hanover to stop following and arguing with the females. At this point Hanover and the victim began arguing at which point Hanover reportedly displayed a knife and threatened to kill the victim. Hanover was arrested and booked into the Mendocino County jail for terrorist's threats and assault with a deadly weapon. 15-0666
