#### **Statistics**

**Arrests included: 8 for warrants, 2 for public intoxication, 2 for vandalism, 2 for burglary, and 1 each for; being under the influence of a controlled substance and/or possessing drug paraphernalia, possession of a controlled substance, DUI, battery, resisting arrest, trespassing, and felon in possession of ammunition. Probation or parole holds were placed on 5 of these arrests. 2 were additionally charged with resisting arrest.**

**Officers investigated 3 traffic collisions.**

**Officers investigated and took reports of: 6 found property, 2 missing persons, 2 elder abuse, 2 abandoned vehicles, 2 suspected child abuse, 2 use of force, 2 suspicious circumstances, 2 battery, 4 thefts, 2 burglary, 3 animal bite and 1 each for; death investigation, mental health, vehicle theft, and transportation of marijuana.**

#### **Highlights for the Week**

On 03/05/2015, at about 1036 AM, Ukiah Police Department responded to 700 E. Gobbi St. regarding a vandalism and trespassing that had just occurred. Upon officers arrival witnesses directed them to a vehicle occupied by 28 year old James Belden and 22 year old Angel Vasquez. When officers began speaking with the two regarding their involvement in the matter both identified themselves with false names. Officers were able to properly identify the two from prior photographs and learned that both had warrants for their arrest. During a search

Belden was found to be in possession of a controlled substance, drug paraphernalia, and was in violation of his probation. Vasquez was additionally charged for providing a false name along with her warrant. Both were booked into the Mendocino County jail. 15-0697

On 03/09/15 at about 1259 AM, Ukiah Police were dispatched to the City of Ukiah softball fields, 100 City Well Rd., for a report of a burglary alarm activation in the facilities maintenance room. On arrival officers found the doors to the maintenance building forced open. Officers began searching the area and found 42 year old Jerome Wolter and 44 year old Jenifer Borges in a parked vehicle in the area. Wolter and Borges claimed to have been sleeping in the vehicle. While officers spoke with Wolter and Borges both were displaying symptoms of being under the influence of a controlled substance. Both were evaluated and arrested for being under the influence of a controlled substance. Borges was determined to be on probation and additionally charged with violation of her probation. During a search of the vehicle additional evidence linking the two to the burglary of the building was found. Both were booked into the Mendocino County jail. 15-0721

On 3/10/15 at about 1242 PM, Ukiah Police were dispatched to American Agcredit, 455 E. Gobbi St, regarding a male subject wearing an orange jacket causing a disturbance both inside and outside of the business. This subject was identified as 56 year old Pablo Mora. When officers arrived, Mora appeared very agitated was kicking a shopping cart strewn garbage and his belongings into the street and on the property. Officers attempted to contact Mora regarding the disturbance he was causing and discarding the trash and belongings. Mora was agitated and continued with his behavior refusing to stop. When officers attempted to talk with Mora he began walking away. Mora was asked and told to stop several times but continued walking away from officers while yelling and mumbling. Officers followed after Mora and arrested him for resisting arrest. Officers additionally learned that Mora is currently on probation for this same reason and he was charged with violation of his probation. Mora was booked into the Mendocino County jail. 15-0731

On 3/11/15 at about 551 AM, Ukiah Police were dispatched to 585 E. Perkins Street (Shell Gas Station) regarding a transient male subject who was refusing to leave the business. This subject was identified as 47 year old Robert Verville. Due to his behavior, Verville had been asked to leave and not to come into the business again by the employee. When officers arrived Verville was found inside the restroom and asked to leave several times by the officers. After Verville

refused to leave the business officers went to place him under arrest and he began struggling with them. Verville was arrested for trespassing and resisting arrest. 15-0738

On 03/11/15, at about 1050 AM, Ukiah Police had stopped a blue Honda Civic being driven by 41 year old Glenn Jenkins for a traffic violation. Also in the vehicle at the time was 28 year old Alicia Gallups. Officers knew that Gallups was wanted as she had a warrant for her arrest. Gallups was arrested without incident for the warrant. After arresting Gallups officers contacted Jenkins and learned that he was currently on PRCS (Post Release Community Supervision) and subject to search and seizure. A search of his person and of the vehicle was conducted. It was during this search that drug paraphernalia was found along with ammunition for a .22 caliber firearm. Jenkins was then arrested for being in possession of ammunition and possession of drug paraphernalia. Jenkins was also charged with violation of his PRCS terms. 15-0742
