Statistics

Arrests included: 5 for warrants, 4 for public intoxication, 4 for shoplifting, 3 for domestic violence, 3 for being under the influence of a controlled substance and/or possessing drug paraphernalia and 1 each for; DUI, violation of probation, possession of a controlled substance, threats, child endangerment, resisting arrest, possession of an illegal weapon, violation of a domestic violence court order, and assault on a peace officer.

Probation or parole holds were placed on 6 of these arrests. 1 was additionally charged with resisting arrest.

Officers investigated 3 traffic collisions.

Officers investigated and took reports of: 3 found property, 3 death investigations, 2 abandoned vehicles, 2 suspected child abuse, 4 elder abuse, 3 city code violations, 2 suspicious circumstances, 3 mental health evaluations, 2 thefts, and 1 each for; missing person, use of force, animal bite, drug registration, vandalism, burglary, ID theft, molestation, threats.

The Patrol Division's average response time to in-progress calls was about 4 minutes. The average response time to all other calls was a little less than 14 minutes.

Highlights for the Week

On 3/12/15 at about 641 PM, Ukiah Police responded to 1275 N. State St, regarding a domestic battery. Upon arrival, officers learned that the battery had occurred in the 100 block of Empire Dr. The victim reported to officers that a Rusty Ramsing had assaulted her while involved in a verbal argument. Ramsing reportedly grabbed the victim by the hair and struck her in the face causing injury. Ramsing was located and arrested for domestic battery. 15-0762

On 3/13/15 at about 1114 PM, a Ukiah Police Department officer was flagged down at the intersection of E. Gobbi St. and S. Main St. The victim reported to the officer that he had just been a victim of a theft and directed the officer's attention to a black Honda leaving the Safeway parking lot. The victim reported to the officer that the driver of this vehicle had stolen his property. The officer was able to stop the vehicle, which was being driven by Tomas Reyes. During the investigation the officer found that Reyes was in possession of the victim's property, was in possession of a dangerous weapon and was driving without a license. Reyes was arrested and booked into the Mendocino County jail for possession of stolen property, possession of an illegal weapon and driving without a license. 15-0769

On 03/14/15, at about 0745 AM, Ukiah Police responded to 310 S. State St. (Alex Thomas Plaza) in regards to a report of an adult male screaming at others in the park and causing a disturbance. This male was located and identified as Gregory Medvin. Medvin initially claimed he was screaming at himself to aid in calming himself. While speaking with Medvin officers were contacted by the victim. The victim explained to officers that Medvin had been yelling threats at another subject in the park. It was during this that the victim had asked Medvin to calm down and stop. In response to this Medvin threatened to assault the victim. The victim felt threatened by Medvin's threats and his aggressive behavior. Medvin was placed under citizens arrest and booked into the Mendocino County Jail for threats. 15-0770

On 3/15/15 at about 1210 AM, Ukiah Police observed a gold Acura speeding northbound on N. State St. When the officer attempted to stop the Acura for the speeding violation, the vehicle accelerated away, reaching a speed of 50 MPH. The officer pursued after the Acura using lights and siren. While pursuing after the vehicle the officer observed the vehicle turn into a driveway at 680 N. State St. The Acura sped down the driveway where it came to a dead end.

When the Acura reached the dead end, the driver identified as Jaime Rodriguez, immediately exited the vehicle and began running northbound through the property. The officer chased after ordering Rodriguez to stop. Rodriguez refused to stop and subsequently climbed a fence leading into the parking lot of 720 N. State St. (Slam Dunk Pizza). Officers followed after Rodriguez as he climbed over another fence into the back of the business at 780 N. State St. A perimeter was then established and Rodriguez was found hiding behind the Parole Office (798 N. State St.). As officers took Rodriguez into custody they noticed he displayed symptoms of being under the influence of alcohol. Rodriguez completed a field sobriety test and was found to not have a drivers license. Rodriguez was arrested and booked into the Mendocino County jail for resisting arrest, driving without a license and DUI.

On 3/17/15 at about 723 OM, Ukiah Police responded to 211 N. Orchard Ave due to a report of an intoxicated female exposing herself in the parking lot. Upon arrival, officers located Erin Blackwell, who spoke with slurred speech, had a strong odor of alcoholic beverages coming from her person, and had an alcoholic beverage sitting between her legs. Blackwell was found to be on summary probation with an order to abstain from alcohol. Blackwell was arrested for public intoxication and violation of her probation. Blackwell was booking into the Mendocino County jail. 15-0807

On 03/18/15 at about 416 AM, Ukiah Police responded to Lucky Supermarket, 504 E. Perkins St., for a report of a male subject yelling profanities at store employees and refusing to leave. Upon officers arrival they contacted Robert Verville, standing in the middle of the driveway in front of the main entrance to Lucky. When officers went to contact Verville he attempted to flee from them. Officers chased after and stopped Verville at which time he struck one of the officers in the face with the back of his hand. Verville was arrested and booked into the Mendocino County jail for assault on a peace officer, resisting an officer and violation of his probation. 15-0810
