#### **Statistics**

**Arrests included: 11 for warrants, 5 for public intoxication, 8 for shoplifting, 3 for driving under the influence (DUI), 5 for domestic violence, 4 for violation of probation/parole, 5 for being under the influence of a controlled substance and/or possessing drug paraphernalia, and 1 each for; possession of a controlled substance, possession of burglary tools, and evading a peace officer.**

**Probation or Parole holds were placed on 6 of these arrests and 2 were additionally charged with resisting arrest.**

**Officers investigated 4 traffic collisions with one being DUI related and one being a hit and run.**

**Officers investigated and took reports of: 10 found property, 2 city code violations, 5 suspected child abuse, 3 mental health evaluations, 2 transportation of marijuana, 2 vandalism, 5 thefts, 2 unlawful intercourse with a minor, and 1 each for; abandoned vehicle, death investigation, drug registration, vehicle theft, burglary, hit and run, animal bite, and Domestic Violence.**

**The Patrol Division's average response time to in-progress calls was about 6½ minutes. The average response time to all other calls was about 14 minutes.**

### Highlights for the Week

During the past month our community has seen a rise in vehicle thefts within both the city limits and in the county. Citizens are advised to not leave keys or valuables in their vehicles and above all do not leave your vehicle running while unattended, as this can present an opportunity for the criminal element within our community to take advantage of us. Anyone with information regarding these thefts are encouraged to contact the Ukiah Police Department or the Mendocino County Sheriff's Office.

On 03/26/15 at about 1102 AM, Ukiah Police were dispatched to Umpqua Bank (607 S. State St) regarding a male subject sleeping in one of the parking lot spaces of the business. Upon officers arrival they recognized the responsible person to be Edward Johnson. Johnson was sleeping in a parking lot space on the east side of the building. Officers awoke Johnson and while speaking with him, noticed his speech was heavily slurred, he had a strong odor of alcohol coming from his person and was in possession of an open bottle of whiskey. Due to prior law enforcement contacts with Johnson, officers were aware that he was on probation and subject to abstaining from alcohol. Johnson was placed under arrest for public intoxication and violation of his probation. 15-0902

On 03/27/15 at about 616 AM, Ukiah Police were dispatched to 401 S. State St (Hospice) regarding an active burglary in progress. Officers were advised that a subject was seen attempting to pry open a large storage container located behind the business. Upon officers arrival they contacted Wesley Dickson starting to leave the area on a bicycle. Dickson claimed he was only in the area for a short time and that he had been looking for donations. Dickson was detained and found to be in possession of multiple tools. These tools included a pair of channel locks, a punch, a screwdriver, and 2 crescent wrenches. After detaining Dickson, officers spoke with the witness who reported to officers that Dickson had been seen prying on the doors of the container in an attempt to open it. Officers checked the container and found that the door on the container had damage that appeared to be recent and was consistent with being pried on. Dickson was arrested then arrested for attempted burglary, prowling, possession of burglary tools, and later found to be on probation and therefore charged with violation of his probation. 15-0911

On 03/28/15 about 501 PM, Ukiah Police were dispatched to 1000 Cunningham St. regarding two subjects entering an abandoned building. Upon arrival Officers contacted the two subjects

one of which was identified as Morgan Ammerman. During this contact Ammerman displayed symptoms of recent drug use. Officers evaluated Ammerman and found that she was under the influence of a controlled substance. Ammerman was also determined to be on probation and was arrested for being under the influence of a controlled substance and violation of her probation. The other subject was released without any charges. 15-0926

On 03/29/15 at about 915 AM, Ukiah Police were dispatched to the 700 block of West Smith Street, regarding a suspicious female subject inside a white sedan. This female was later identified as Naomi Mannonen. Officers were advised that Mannonen had parked in the driveway of a residence and when the resident attempted to speak with her she refused to explain why she was parked in the driveway. Due to this odd behavior the police were called.

Upon officers arrival Mannonen began driving away from the area. When officers attempted to stop Mannonen she refused to yield and a pursuit ensued. Mannonen proceeded to lead officers through the residential streets of N. Spring St, Walnut Ave, N. Bush St, N. Pine St, Grove Ave, and Snuffin St. reaching a speed of 60 MPH. Once at Snuffin St and N. Oak St, Mannonen turned southbound onto N Oak St and began driving south reaching a speed of 50 MPH as her vehicle passed through the intersection of Scott and N. Oak St without stopping and continued southbound on N. Oak St. through the intersections of Standley and Oak, Perkins and Oak, to W. Clay and Oak where she passed a stopped vehicle on the left and continued to W. Mill St turning Eastbound to S. State St.

Mannonen proceeded to lead officers north onto S. State St weaving through traffic as she proceeded north to the highway 101 northbound off ramp. Once here Mannonen turned onto this off ramp passing oncoming traffic as she drove southbound in the northbound highway 101 lanes. Mannonen continued south to River Street where she attempted to make a U-turn colliding with a dirt embankment. Upon colliding with the embankment Mannonen's vehicle became stuck and officers assisted by the CHP and MCSO were able to block Mannonen's vehicle preventing further flight. Mannonen was ordered from the vehicle yet she refused to comply. Due to this officers approached her vehicle and were forced to remove Mannonen from the vehicle. Once removed Mannonen continued to refuse officers orders and resisted them when they went to place her in handcuffs. Once handcuffed, Mannonen was found to be in possession of drug paraphernalia commonly used for smoking methamphetamine. Mannonen

was arrested and booked into the Mendocino County Jail for evading a peace officer, resisting arrest, and possession of drug paraphernalia. 15-0930

On 03/30/15 at about 1236 PM, Ukiah Police were dispatched to Mendocino Pl. regarding a stolen vehicle. Upon officer's arrival, they learned that the owner had left the vehicle parked along the curb in front of the residence. The owner had left the windows down and the keys inside of the vehicle. Officers checked the area and were able to locate the vehicle parked along the curb on Pomolita Way. 15-0948

On 4/1/15 at about 725 PM, Ukiah Police responded to the Ukiah Skate Park, regarding an intoxicated male causing a disturbance. Upon arrival officers contacted witnesses that identified Armando Llamas. Witnesses reported to officers that Llamas was intoxicated and had been confronting others inside the skate park in an attempt to get them to fight him. Officers contacted Llamas and found that he was displaying symptoms of alcohol intoxication. Llamas was also found to be on probation. Llamas was arrested for public intoxication and violation of his probation. Llamas was booked into the Mendocino County Jail. 15-0980
