Statistics

Arrests included: 6 warrant arrests, 4 for public intoxication, 4 for shoplifting, 2 for violating probation or parole, 2 for stolen vehicle, and 1 each for; for being under the influence of a controlled substance and/or possessing drug paraphernalia, possessing marijuana, possessing methamphetamine, possessing a narcotic, trespassing, possessing methamphetamine for sale, failure to register as a sex offender, and threats. Probation or parole holds were placed on 4 of these arrests.

Officers investigated 3 traffic collisions and 1 injury traffic collision.

Officers investigated and took reports of: 6 found property, 4 vandalism, 3 domestic violence, 3 child neglect, 2 abandoned vehicles, 2 stolen vehicles, and 1 each of; burglary, theft, rape, animal bite, and identity theft.

Officers assisted the Mendocino Major Crimes Task Force with a vehicle search.

The Patrol Division's average response time to in-progress calls was about 5 minutes. The average response time to all other calls was about 12 1/2 minutes.

Highlights for the Week

On April 3rd at about 5:40 PM a Ukiah Officer noticed a black 2000 BMW that had been reported stolen from Red Bluff, parked in the 800 block of Cypress Avenue. The officer called for assistance, and a high risk stop was performed and the vehicle's two occupants were arrested. The driver of the vehicle, 29 year old Terry Lee Cobb, of Redding, had a methamphetamine smoking pipe in his pocket and was charged with the stolen vehicle and possessing drug paraphernalia. The passenger, 22 year old Bailey Ann Davis, also of Redding, was arrested for the stolen vehicle. 15-0991

On April 5th at about 1:40 PM Ukiah Police responded to Walgreen's, at 308 East Perkins Street, for a suspicious person. Officers learned a male subject had approached a female employee, working inside the store, from behind and hugged and kissed her. The employee confronted the subject, who didn't say anything but tried to hug the employee again. The subject was located by officers near-by, and he was identified as 38 year old Harvey McCarty who was found to be on parole for domestic violence. McCarty's parole officer was contacted and he was subsequently arrested for violating parole. 15-1006

On April 6th at about 3:30 PM a Ukiah Police Officer stopped a bicyclist in the 200 block of South Orchard Avenue. The subject verbally identified himself to the officer, and the officer noticed the subject seemed to have difficulty spelling his name and providing information related to his age. The subject denied having identification though he later produced a wallet and opened it at the request of the officer. The officer saw a driver's license in the wallet with a name different than what the subject had provided. The subject suddenly turned and tried to run away and the officer grabbed the subject, who continued to struggle to get away. The officer was able to bring the subject to the ground and request emergency assistance, and attempted to take the subject into custody. The subject continued to physically resist, and with the assistance of other officers was finally taken into custody and arrested. The subject was identified as 22 year old Esteban Jorge Camarillo, of Ukiah, and he was found to be on probation for drugs and burglary, and to have a felony warrant for his arrest. Camarillo had a methamphetamine smoking pipe in his possession as well as a small scale and empty plastic baggies. Camarillo was arrested for providing false identity to a police officer, resisting arrest, possessing drug paraphernalia, violating probation, and the warrant and was transported to the County Jail. It was discovered Camarillo had a commercial amount of methamphetamine weighing over 10

grams hidden on his person, and he was additionally charged with possessing methamphetamine for sale. 15-1022

On April 7th at about 3:40 AM Ukiah Police responded to a residence in the 200 block of Irvington Drive for a suspicious subject in the backyard. Responding officers were advised the homeowner was in a physical fight with the subject, and that the subject had tried to enter the residence. Officers located 27 year old Eric Michael Roberts on the side yard and noticed he was extremely intoxicated and unable to stand on his own. Roberts had blood on his face and was arrested for public intoxication and for violating terms of his Post Release Community Supervision which prohibit him from drinking. Officers learned Roberts had been heard pounding on the bedroom windows and trying to enter the residence. The homeowner confronted Roberts, who tried to push past the resident and then struck the resident, and a fight ensued until Roberts fell and the resident closed the door. The homeowner sustained minor injuries and declined prosecution. Roberts was booked into the County Jail for public intoxication and violating PCRS. 15-1027
