### **Statistics**

**Arrests included: 6 for public intoxication, 5 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 4 for violating probation or parole, 3 warrant arrests, 2 for shoplifting, 2 for domestic violence, 2 for assault with a dangerous weapon, 2 for possessing methamphetamine, and 1 each for; possessing marijuana, resisting arrest, possessing a knife at school, trespassing, battery, providing a false name to law enforcement, robbery, vandalism, possessing stolen property, and prowling. Probation or parole holds were placed on 9 of these arrests.**

**Officers investigated 3 traffic collisions.**

**Officers investigated and took reports of: 4 stolen vehicles, 4 found property, 4 thefts, 3 child neglect, 2 vandalisms, 2 burglaries, 2 suicidal subjects, 2 domestic violence, and 1 each of; missing person, fraud, counterfeit bill, robbery, abandoned vehicle, stolen vehicle recovery, and identity theft.**

**The Patrol Division's average response time to in-progress calls was about 5 minutes. The average response time to all other calls was about 15 minutes.**

### **Highlights for the Week**

On April 17<sup>th</sup> at about 4:00 PM a Ukiah Police Officer encountered a group of subjects in the 800 block of Waugh Lane who appeared to be involved in some sort of altercation. The officer saw one of the subjects, 26 year old Alva Reeves, had his fists clenched and was yelling and behaving aggressively towards the remaining subjects. Reeves saw the officer and suddenly turned and walked away, and ignored commands to stop instead running with the officer in foot pursuit. Reeves ran across the street and into an apartment complex where the officer caught up to him, and subsequently took him into custody. Reeves had been drinking and was on probation and prohibited from doing so, and was charged with resisting arrest and violation of probation. 15-1118

On April 17<sup>th</sup> at about 7:55 PM Ukiah Police responded to the 600 block of Holden Street for a stabbing. The victim reported having an on-going dispute with a neighbor, 31 year old Kevin Gary Pike, and that evening suspected Pike had thrown a soda container at the victim's house. The victim found Pike in his front yard and confronted him. Pike respond by spitting on the victim, then stabbed the victim in the stomach with scissors. Officers determined Pike was on probation for threats and subject to search and seizure but found Pike was not at his residence. At about 10:30 PM officers learned Pike was seen entering his residence, and arrived to hear voices inside. After an extended period of time Pike's girlfriend answered the door, and Pike was locked in a room inside the residence. Pike argued through the door with officers and finally opened the door and took a fighting stance. Pike resisted the officers and was eventually handcuffed but remained physically resistive and yelled loudly. Pike was arrested for assault with a deadly weapon, resisting arrest, and violating probation. 15-1121

On April 19<sup>th</sup> at about 5:10 PM Ukiah Police responded to the Ukiah Valley Medical Center Emergency Room for a restraining order violation. Offices learned 26 year old Kelisha Sheree Alvarez had been transported to the Emergency Room by ambulance, and was evaluated and found not to have any medical emergency or condition whatsoever. Alvarez was refusing to leave the facility. Alvarez is on probation and prohibited from being at or contacting the hospital except for a medical necessity as she has a history of feigning illness and wasting medical resources. Alvarez was arrested for violating probation. 15-1136

On April 19<sup>th</sup> at about 10:05 PM Ukiah Police responded to 390 East Gobbi Street for a fight. Arriving officers contacted one person at the scene, who stated she had been approached by 35 year old Crystal Knight who requested money then a cell phone from the victim. Knight grabbed the backpack being worn by the victim and pulled the straps, and ended up dragging the victim into the street before removing the backpack and fleeing on a bicycle. On April 20<sup>th</sup> at about 3:10 PM a Ukiah Police officer spotted Knight in the 200 block of Cherry Street, and saw she had the stolen backpack with her. Knight was arrested for robbery and for violating probation. 15-1139

On April 21<sup>st</sup> at about 11:10 AM a Ukiah Police Officer tried to stop a bicyclist in the 500 block of East Perkins Street. The bicyclist, later identified as 20 year old Robert Curtis James, fled into the Pear Tree Shopping Center with the officer in pursuit on foot. James continued behind Home Depot and onto Hamilton Street before officers were able to catch up with him, and he physically resisted as he was taken into custody and arrested for restricting arrest. James was on probation, and a hypodermic syringe containing liquid methamphetamine was located in his possession. The bicycle James was riding was later determined to have been stolen recently. James was charged with resisting arrest, possessing methamphetamine and drug paraphernalia, and violating probation. A charge of possessing stolen property is being sought with the District Attorney's Office. 15-1153

On April 22<sup>nd</sup> at about 3:10 AM Ukiah Police responded to the 1300 block of Hastings Road for a prowler seen inside the fenced yard of a construction company. Arriving officers located 36 year old Jeremiah Victor Mcosker standing in the shadows near a building. Mcosker could provide no reasonable explanation for being on the property at that time. Mcosker was on Post Release Community Supervision and was arrested for prowling and for violating PRCS. 15-1161
