Patrol Division Weekly Activity Report 4/23/15 to 4/29/15

Statistics

Arrests included: 10 for public intoxication, 10 warrant arrests, 8 for shoplifting, 6 for domestic violence, 5 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 3 for violating probation or parole, 3 for assaults at school, 2 for resisting arrest, and 1 each for; possessing methamphetamine, providing a false name to law enforcement, vehicle tampering, possessing an illegal weapon, possessing a narcotic, indecent exposure, hit and run, violating a court order, and prowling. Probation or parole holds were placed on 11 of these arrests.

Officers investigated 3 traffic collisions and 2 hit and run traffic collisions

Officers investigated and took reports of: 6 vandalisms, 4 found property, 3 burglaries, 3 suicidal subjects, 3 abandoned vehicles, 2 for fraud, 2 for recovering stolen property, and 1 each of; domestic violence, theft, missing person, stalking, animal bite, stolen vehicle recovery, and battery.

The Patrol Division's average response time to in-progress calls was almost 7 minutes. The average response time to all other calls was about 15½ minutes.

Highlights for the Week

On April 23rd at about 9:50 AM Ukiah Police responded to the 700 block of South State Street for a theft from a vehicle. The victim reported leaving his vehicle unlocked near a business, and returned to find his cell phone and wallet had been removed from his vehicle. The victim began checking the area and confronted 44 year old Sherri Neely, who could be seen trying to conceal a cell phone under her arm. The victim was able to get Neely to return his cell phone as well as one of his credit cards. Officers located Neely and subsequently arrested her for theft, vehicle tampering, and violating her probation. The victim's wallet was later recovered by a citizen who found it hidden in the area. 15-1184

On April 28th at about 12:10 AM Ukiah Police responded to the area of 500 South Main Street for an attempted burglary, wherein a rock had been thrown through the window of a business. Officers located a subject lying on the ground near that business and identified him as 30 year old Blue Firecloud Abreu. Officers found Abreu had been drinking in violation of his probation, and arrested him for prowling and for violating probation. 15-1235

On April 28th at about 9:15 AM Ukiah Police responded to the 700 block of South State Street for a subject who'd jumped from a moving vehicle. Officers learned the 40 year male from Washington had recently tied an extension cord around his neck, and had drank anti-freeze before jumping from the moving vehicle in an apparent suicide attempt. The subject was detained for medical reasons and released to the custody of Mental Health. 15-1236

On April 28th at about 7:50 PM Ukiah Police responded to the Wal Mart parking lot, at 1155 Airport Park Boulevard, for a subject exposing himself. Officers learned the subject, identified as 25 year old Travis Joseph Humphrey, had pulled his pants down and exposed his bare buttocks to a passing vehicle containing a male and two female occupants. Humphrey reportedly spread his buttocks with his hands and yelled to the passing motorists, asking them how they "liked this". Humphrey was reportedly wearing a long jacket and cowboy style hat, and was located in the Wal Mart lot. Humphrey admitted to the incident and was placed under citizen's arrest for indecent exposure. 15-1243

On April 29th at about 8:10 AM Ukiah Police responded to a hit and run traffic collision at the intersection of South State and Mill Streets. Officers learned a 2014 Toyota RAV4 was being driving eastbound through the intersection when a burgundy 1991 Toyota pick-up being driven northbound, failed to stop for the red light and collided with the RAV4. The Toyota's driver reversed direction then fled the scene, and was followed by a witness to the 200 block of Carleton Street here he was stopped by Ukiah Police Officers. The Toyota's driver, 20 year old Alfonzo Ayala, was unlicensed and was identified as the fleeing driver by witnesses, and the Toyota's front license plate had been dislodged from the collision and was located at the collision scene. Ayala was arrested for driving without a license and for hit and run. 15-1249

On April 29th at about 9:35 PM a Ukiah Police Officer observed 20 year old Rafael Maldonado-Mata in the 200 block of Irvington Drive. Mata was on probation and subject to search and seizure, and had recently been arrested for illegal weapons possession. The officer contacted and spoke with Mata, who repeatedly put his hands into his pants pocket during the contact, then suddenly ran away with the officer in foot pursuit. The officer caught up to Mata and was able to take Mata to the ground, but Mata continued to physically resist, and with the assistance of a second officer and after a continued struggle, Mata was placed into custody. Mata was found to have a methamphetamine smoking pipe inside his pants pocket, and was arrested for possessing drug paraphernalia, resisting arrest, and violating probation. 15-1262
