Statistics

Arrests included: 6 for public intoxication, 2 warrant arrests, 3 for shoplifting, 4 for DUI, 3 for violation of probation, 2 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 4 for possession of methamphetamine, 2 for possession of methamphetamine for sale, 2 for resisting arrest, and 1 each for; possessing heroin, providing a false name to law enforcement, vehicle tampering, possessing an illegal weapon, possessing a narcotic, violating a court order, child endangerment, failing to register and trespassing. Probation or parole holds were placed on 3 of these arrests and 1 was additionally charged with resisting arrest.

Officers investigated 2 traffic collisions

Officers investigated and took reports of: 6 found property, 3 suspected child abuse, 2 thefts, and 1 each of; missing person, abandoned vehicle, suspicious circumstances, mental health evaluation, battery, check fraud, vandalism, vehicle theft, rape, burglary, attempted rape, robbery, and animal bite.

The Patrol Division's average response time to in-progress calls was 5 minutes. The average response time to all other calls was about 15 minutes.

Highlights for the Week

On 05/02/15 at about 857 AM to Ukiah Police responded to Motel 6, 1208 S. State Street room 120 for a report of a verbal domestic occurring in the room. Upon arrival Officers contacted a Scott Faber and Nicole Wright. During this initial contact officers learned that no physical altercation took place yet Wright was found to be on probation and Faber was on Post Release Community Supervision (PRCS). Both Faber and Wright were subject to search and officers searched their persons and the room. During this time officers located suspected methamphetamine, drug paraphernalia, and assorted mail that did not belong to either Faber or Wright. The two were arrested for possession of methamphetamine, drug paraphernalia, possession of stolen property and identity theft. Each were additionally charged with violation of the probation or parole terms. 15-1276

On 05/02/15 at about 404 PM, Ukiah Police responded to 136 Ford St. regarding a report of a possible domestic disturbance. Upon arrival officers spoke with involved parties and witnesses and learned that Feather Fallis had been drinking with friends and that she had become physically abusive hitting her boyfriend when they tried to get her to stop drinking. After assaulting her boyfriend, Fallis left the residence in a vehicle and in so doing collided with a parked vehicle. Officers began searching the area for Fallis and located her at 1201 N. State St. Fallis was found unconscious in nearby bushes and an ambulance called. Fallis was later arrested for DUI, hit and run and domestic battery. 15-1278

On 5/3/15 at about 1249 Am, a Ukiah Police Officer was driving in the 600 block of S. State St. when a gray Ford Focus passed by at a high rate of speed. The officer followed after and found the vehicle was traveling at 60 MPH as it drove northbound towards the downtown. The officer was able to get the vehicle to stop in the 100 block of N. State St and contacted the driver Timothy Toloy. Toloy displayed symptoms of intoxication and was arrested for DUI. 15-1286

On 05/04/15 at about 126 PM, Ukiah Police responded to 113 S. State Street for a report of a traffic collision, involving a City of Ukiah vehicle. Upon arrival officers contacted the involved parties and learned that Margarito Ruiz had rear ended the city vehicle as it was stopped in traffic. While speaking with Ruiz officers saw that he displayed symptoms of intoxication. Ruiz was arrested and for DUI and found to have a suspended license. 15-1299

On 5/4/15 at about 1107 PM Ukiah Police responded to 650 S. State St, Sunrise Inn, regarding Julie Legendre screaming at her young child who was bleeding from his nose. Upon arrival Officers contacted witnesses who advised that Legendre was seen cursing and kicking her child in the face causing a bloody nose. After speaking with witnesses Legendre was contacted and found to be under the influence of a controlled substance. Legendre was arrested for being under the influence and child abuse. The child was placed in safe custody with Child Protective Services. 15-1304

On 05/05/15 at about 623 Am, Ukiah Police responded to the 1600 block of Elm St regarding a vehicle theft. Upon arrival officers contacted the victim and learned that the owner was warming the vehicle up and had gone inside their residence. While inside the owner heard a vehicle speeding away from the area and went back out to investigate and found their vehicle gone. The vehicle was later located in a nearby residential area. 15-1305

On 5/6/15 at about 1054 PM, Ukiah Police responded to 998 S. State Street, Express Mart, regarding an attempted robbery. Upon arrival officers contacted the victim and learned that while inside the store a man described by the victim as approximately 5 foot 11 inches tall, thin build, wearing all black clothing, gloves, and a mask enter the store. The victim reported that the suspect was holding a round object under his jacket with his right hand, and pointing it at the victim. This caused the victim to believe the suspect was attempting to make it look as though he had a firearm under the jacket, yet never saw a firearm.

The suspect told the victim to put his hands up, but the victim believed the suspect was joking and walked away from him going behind the counter. The suspect told the victim to place the money from the register into a bag. Again the victim refused telling the suspect to do this himself. The suspect attempted to open the register but failed and fled the scene. 15-1324
