Statistics

Arrests included: 10 warrant arrests, 6 for public intoxication, 6 for possessing methamphetamine, 5 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 4 for shoplifting, 2 for domestic violence, and 1 each for; resisting arrest, violating probation or parole, trespassing, vehicle pursuit, possessing of heroin for sale, robbery, and possession of a narcotic. Probation or parole holds were placed on 12 of these arrests.

Officers investigated 1 traffic collision and 1 hit and run traffic collision.

Officers investigated and took reports of: 11 found property, 3 for domestic violence, 3 child neglect, 3 thefts, 3 transportation of marijuana, 3 missing persons, 3 vandalisms, 2 embezzlement, 2 abandoned vehicles, 1 each for; battery, identity theft, child abuse, display of a firearm, assault with a dangerous weapon, suicidal subject, and elder abuse.

Ukiah Police Officers were assisted by the Mendocino County Sheriff's Office with several in-progress calls.

The Patrol Division's average response time to in-progress calls was about 5 1/2 minutes. The average response time to all other calls was about 17 minutes.

Highlights for the Week

On 5-29-15 at approx. 7:15 PM, UPD officers were dispatched to the area of Wal-Mart regarding a shoplifting that had just occurred. The female suspect had fled into the passenger seat of an awaiting vehicle and left the area in silver SUV with dealer paper plates. A UPD officer quickly located the vehicle behind a large dirt mound at the South end of Airport Park Blvd. The officer attempted to initiate a traffic stop on the vehicle; however the vehicle sped up and began driving erratically N/B in the dirt lot. The vehicle drove over a culvert at a high rate of speed, which appeared to have damaged the vehicle. As the driver attempted to flee at a high rate of speed, the driver attempted to drive through a wire fence (located on the South side of Les Schwab Tires) and got stuck. The vehicle was “boxed in” by the patrol car. The driver, Charles Kesselring, attempted to flee on foot, but was quickly apprehended. The passenger, Jennifer Wall was taken into custody at the scene. The vehicle was previously reported stolen out of Humboldt County. Officers located suspected methamphetamine in the vehicle. Kesselring was wanted out of Humboldt County for carjacking, robbery, and terrorist threats. Kesselring was also on active PRCS probation (Post Release Community Supervision) for auto theft. Kesselring and Wall were lodged at the county jail, where Kesselring was additionally held on the Humboldt County charges. 15-1547

On May 29th at about 11:50 PM a Ukiah Police Officer was driving through the parking lot at Motel 6, at 1208 South State Street, and observed 3 subjects climbing the fence into the lot. One of the subjects was wearing clothing commonly associated with gang membership, and dropped a baseball bat to the ground. The subject fled with the officer in foot pursuit, and continued running to the parking lot at 1290 South State Street before surrendering. The subject was taken into custody and identified as a 16 year old male juvenile from Potter Valley. Officers located the bat and two twelve packs of beer the subject had left behind, and the juvenile admitted to belonging to a criminal street gang. The juvenile suspect was arrested for resisting arrest and for being a minor in possession of alcohol. 15-1553

On May 30th at about 5:20 PM Ukiah Police responded to the 800 block of Waugh Lane for a driver passed out in a vehicle. The responding officer found a white Toyota Avalon stopped at a stop sign, and the driver slumped to the right and unconscious. There was an opened and partially consumed bottle of alcohol inside the vehicle. The officer was able to

awaken the driver, identified as 20 year old Rafael Maldonado, and found he had been drinking. Maldonado was found to be too intoxicated to drive and was arrested for DUI. 15-1559

On June 2nd at about 12:55 AM a Ukiah Police Officer contacted a subject in the bushes along the side of the Safeway store, at 653 South State Street. The subject was identified as 34 year old Michael Shaun Foxworth, who stated he had recently been released from prison and was going to camp in the bushes. Foxworth was on Post Release Community Supervision as well as probation for felonious assault, and was prohibited from drinking alcohol. Foxworth was found to have been drinking and was arrested for violating PRCS and probation. 15-1584

On June 2nd at about 1:25 AM Ukiah Police responded to the Safeway parking lot, at 653 South State Street, for a reported robbery. The victim, a 46 year old male, reported a subject known to him as 37 year old James Miles approached him in the lot and the two argued briefly. Miles took the victim's backpack and another item from the victim and walked away. Miles pulled a knife and displayed it when the victim followed Miles and tried to get his belongings back. Officers located Miles in the Sunrise Inn parking lot across the street, and found him in possession of a knife and the victim's belongings. Miles was arrested for robbery and for violating probation. While assisting investigate this incident, an officer was approached by a subject who reported the recent theft of stereo equipment from a vehicle parked at Round Table Pizza. The officer remembered stopping a vehicle within the hour in which Miles was a passenger, and that Miles had told the officer he was headed to Round Table Pizza. The officer noticed the vehicle parked in the Safeway lot, and upon inspection saw some of the stolen stereo equipment inside the vehicle which had not been there during the earlier traffic stop. Miles claimed he had purchased the stereo equipment but could not identify from whom. Charges of possessing stolen property are being sought against Miles with the District Attorney's Office and the stolen stereo equipment was returned to its owner. 15-1585

On June 2nd at about 2:20 AM Ukiah Police Officers were in the Safeway parking lot, at 653 South State Street, investigating a theft and brandishing of a knife and stolen stereo equipment. Officers were approached by a 21 year old male who was bleeding and behaving hysterically, claiming he had just been stabbed. Officers saw several lacerations to the victim's upper body, and the victim claimed he was walking from a fast food establishment when he was confronted by the suspect. The suspect questioned the victim about gang activity and the two

engaged in a fight. The victim later realized he had been stabbed and contacted a friend for a ride to the hospital. The victim was transported to the Ukiah Valley Medical Center for treatment to his injuries and the Ukiah Police Detectives were called out to further investigate the incident. 15-1586

On June 3rd at about 2:40 PM a Ukiah Police Officer observed 27 year old Anthony James Adobe-Crespo, of Pennsylvania, urinating in some bushes in the 700 block of South State Street. The officer contacted Adobe-Crespo and was preparing to cite him for the violation, when the officer was confronted by 24 year old Christopher Boice. The officer instructed Boice not to interfere, but Boice continued to approach and confront the officer about citing his friend. Boice continued to refuse to comply with the officer and was arrested for interfering with the officer. Adobe-Crespo was cited and released. 15-1610
