Patrol Division Weekly Activity Report 6/11/15 to 6/17/15

Statistics

Arrests included: 14 warrant arrests, 5 for public intoxication, 3 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 3 for shoplifting, 3 for violating probation or parole, 2 for domestic violence, and 1 for; possessing methamphetamine. Probation or parole holds were placed on 6 of these arrests.

Officers investigated 1 traffic collision, 1 DUI traffic collision, and 1 hit and run traffic collision.

Officers investigated and took reports of: 8 vandalisms, 6 found property, 4 child neglect, 3 missing persons, 3 animal bite, 2 thefts, 2 burglaries, and 1 each for; peeping, suicidal subject, abandoned vehicle, cultivation of marijuana, carrying a firearm in public, arson, and animal bite.

Ukiah Police Officers assisted the Mendocino Major Crimes Task Force with several narcotics investigations, the Fire Department with several structure fires, and the Mendocino County Sheriff's Office with a shooting.

The Patrol Division's average response time to in-progress calls was about 4 1/2 minutes. The average response time to all other calls was about 14 minutes.

Highlights for the Week

On June 11th at about 11:55 PM a Ukiah Police Officer was in the 100 block of North State Street and observed a vehicle traveling at a high rate of speed on Perkins Street through the State Street intersection. The vehicle continued west on Perkins Street and the officer attempted to catch up to the vehicle. The vehicle was seen turning north onto Dora Street then west on Grove Avenue and was traveling so fast the officer was unable to catch up to it and lost sight of it. Other officers responded to the area, and the vehicle was eventually located and stopped in the 500 block of Spring Street. The driver, 21 year old Madison Lee Havens, of Fort Bragg, had been drinking and was found too intoxicated to drive and was arrested for DUI. The passenger in the vehicle, 21 year old Donte Robert Smith, of Ukiah, had a warrant for driving on a suspended driver's license and was also arrested. Multiple containers of alcohol were located inside the vehicle. 15-1698

On June 13th at about 4:15 PM Ukiah Police responded to the Ukiah Valley Medical Center, at 275 Hospital Drive, for a probation violation. Officers learned 26 year old Kelisha Sheree Alvarez had been transported to the facility, and was on probation and prohibited from being at the hospital without a medical need. Hospital staff informed the officer Alvarez did not have legitimate medical condition and was therefore in violation of her probation. Alvarez was arrested for violating probation. 15-1714

On June 14th at about 7:35 AM Ukiah Police responded to the church at 750 Yosemite Drive for a burglary. Officers learned the church had been broken into two separate times over the weekend, the first by breaking a window, and the second by removing the plywood which had been placed over the broken window. Officers saw the suspect had forced open several rooms inside the church causing significant damage to the church, and several items had been removed from the church. Video surveillance of the suspect was obtained, and at about 2:00 PM the suspect was spotted near the Burger King, at 711 East Perkins Street. Officers responded and contacted 24 year old Michael Fredrick Ward, who had been identified as the suspect in the vandalism to a vehicle which occurred June 10th in the early morning hours on Myron Place. Ward had apparently bent the door of the vehicle, spray painted the vehicle, and caused other damage. Ward was arrested by the officers for that vandalism and for violating probation. Ward was found to have some of the stolen items from the church in his possession, and admitted breaking into the church and causing the damage on both occasions. Ward directed the officers

to another location where additional stolen property from the church was recovered. Ward was additionally charged with two counts of burglary and vandalism. 15-1676

On June 14th at about 9:05 PM Ukiah Police responded to the bus stop in the 200 block of North Orchard Avenue for a domestic violence incident wherein the victim had called and reported being struck in the face. Officers learned the victim and 31 year old Scotty Lee Willis were arguing, and Willis tried to walk away to end the argument. The victim followed Willis and continued arguing, and Willis turned and pushed the victim away. When asked why the victim report being hit in the face, the victim reported she meant to say that Willis had threatened to hit her although he hadn't. The victim stated she did not want Willis arrested or prosecuted, but that he had left with a shopping cart containing some of her belongings and she wanted the police to locate Willis and retrieve those items for her. Within several minutes an officer spotted Willis returning to the victim's location and contacted him in the JC Penney parking lot. Willis was arrested for domestic violence and for violating his probation which prohibited him from being near JC Penney. 15-1727

On June 16th at about 2:00 AM Ukiah Police responded to a domestic violence incident in the 600 block of Talmage Road. Officers could hear arguing inside, and found 30 year old Christina Leena McGrew and the victim arguing. Officers learned McGrew had struck the victim numerous times with her fists causing minor injuries to the victim's face and head area. McGrew was behaving strangely and provided an inarticulate statement to officers. An officer began taking McGrew into custody for domestic violence, and she suddenly turned and kicked an officer in the legs, grabbed at the officer's legs, and tried to bite them on the arms. McGrew was eventually restrained and additionally charged with resisting arrest with violence. 15-1742

On June 16th at about 4:00 PM Ukiah Police received numerous calls of a subject carrying a firearm in the 100 block of South Main Street. A responding officer located the subject holding a rifle on Main Street near Perkins Street. A high-risk contact was initiated, and the firearm was safely obtained from the subject and determined to be a pellet gun which lacked any identifiable features discerning it from a real firearm. The subject was cautioned on carrying an authentic appearing weapon in a congested area and released without charges. 15-1751

On June 16th at about 8:20 PM Ukiah Police responded to the Big Lots parking lot, at 225 South Orchard Avenue, for a male and female involved in an altercation and associated with two separate vehicles. Responding officers were advised the female had been seen driving one of the vehicles recklessly in the parking lot, “spinning doughnuts”, and was seen drinking an alcoholic beverage. Arriving officers located the vehicle being driven in the lot, and identified the driver as 46 year old Lorraine Lenn Fulmer, of Mendocino. Fulmer had been drinking and was found too intoxicated to drive and was arrested for DUI. The other vehicle reported to be involved was located parked at the scene but the male subject was not. At about 9:05 PM an officer located this vehicle being driven in the 100 block of North Orchard Avenue. The vehicle was swerving and the officer tried to stop the vehicle, which continued onto Bruch Street before finally yielding to the officer’s lights and siren. The driver, 54 year old Laurence Everett Smith, of Sacramento, had been drinking and was found too intoxicated to drive and was arrested for DUI. 15-1754/15-1755
