Patrol Division Weekly Activity Report 6/18/15 to 6/24/15

Statistics

Arrests included: 4 warrant arrests, 4 for public intoxication, 4 for violating probation or parole, 4 for possessing methamphetamine, 3 for domestic violence, 3 for assault with a dangerous weapon, and 1 for; shoplifting, being under the influence of a controlled substance and/or possessing drug paraphernalia, false identity to law enforcement, violating a court order, possessing stolen property, attempted burglary, vandalism, and hit and run. Probation or parole holds were placed on 8 of these arrests.

Officers investigated 1 traffic collision and 1 hit and run traffic collision.

Officers investigated and took reports of: 10 found property, 4 vandalisms, 4 abandoned vehicles, 4 child neglect, 3 burglaries, 2 animal bite, 2 suicidal subjects, and 1 each for; unlawful sales of alcohol, barking dog, battery, and elder abuse.

The Patrol Division's average response time to in-progress calls was about 6 minutes. The average response time to all other calls was less than 13 minutes.

Highlights for the Week

On June 20th at about 9:30 PM a Ukiah Police Officer was responded to an emergency call with lights and siren activated. A vehicle traveling directly in front the patrol car suddenly pulled to the side of road, in the 700 block of South State Street, and the driver quickly fled from the vehicle on foot. The driver ran around the Social Services building and was soon located with the assistance of a Police K9 hiding in some bushes. The driver again ran away briefly, but quickly surrendered to avoid having the K9 deployed. The driver was identified as 44 year old Donald McCloud, of Woodland, who believed the Police were after him as he had just stolen items from Wal Mart. Several items valued at over \$80.00 and confirmed to have been stolen from Wal Mart were recovered from McCloud's vehicle, and was he was arrested for possessing stolen property, violating parole, and driving without a license. 15-1785

On June 20th at about 10:50 PM Ukiah Police responded to a room at the hotel in the 400 block of South State Street for a reported burglary. Officers contacted 28 year old Rigo Berto Perez, who reported two male subjects had kicked in the door, assaulted him, and stole money from him. Perez admitted he had been drinking but denied drinking with the two suspects. Perez stated the two subjects left in a vehicle, and believed they went south on the highway because "that's what he would do". Perez was on probation and prohibited from drinking, and was arrested for violating probation. 15-1788

On June 22nd at about 9:15 PM Ukiah Police responded to the 200 block of Observatory Avenue for a reported verbal altercation. Officers contacted a resident who explained he'd engaged in an argument with his girlfriend, and the two exited the residence and continued arguing outside. The subject stated he heard what sound like a pellet gun being shot, and determined his step-son had shot a pellet gun at the subject's vehicle's windshield causing damage. Officers contacted 21 year old Brandon Curtis English-Clausen, who confirmed he shot the victim's windshield because "they didn't want him around anymore". English-Clausen was placed under citizen's arrest by the victim for vandalism, and was also charged with discharging a pellet gun within City Limits. 15-1807
