### **Patrol Division Weekly Activity Report 6/25/15 to 7/1/15**

### **Statistics**

Arrests included: 8 warrant arrests, 6 for violating probation or parole, 5 for public intoxication, 4 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 4 for shoplifting, 2 for assaulting public safety personnel, and 1 for; threats, possessing an illegal weapon, domestic violence, false identity to law enforcement, vandalism, brandishing a weapon, resisting arrest, destruction of evidence, and hit and run. Probation or parole holds were placed on 10 of these arrests.

Officers investigated 1 traffic collision.

Officers investigated and took reports of: 8 found property, 4 child neglect, 3 suicidal subjects, 2 thefts, 2 for assault with a dangerous weapon, and 1 each for; robbery, stolen vehicle, domestic violence, animal bite, and burglary.

The Patrol Division's average response time to in-progress calls was about 6 1/2 minutes. The average response time to all other calls was about 15 minutes.

Ukiah Officers assisted the Fort Bragg Police Department with a hit and run investigation.

### Highlights for the Week

On June 25<sup>th</sup> at about 3:45 PM Ukiah Police responded to the Wal Mart parking lot, at 1155 Airport Park Boulevard, for a vandalism to a vehicle. Officers learned 25 year old Travis Humphrey had been told by store employees to leave the area as Humphrey is known to cause many problems and has been arrested numerous times there. Humphrey was walking through the lot and jumped onto the hood of a security patrol vehicle while the security guard was seated in the vehicle, causing over \$1000.00 in damage to the vehicle's hood. Humphrey was arrested for felony vandalism. 15-1831

On June 26<sup>th</sup> at about 11:00 AM Ukiah Police responded to Todd Grove Park, at 600 Live Oak Drive, for a report of suspicious circumstances. Officers were advised a father was observed yelling and throwing items at his child. Officers contacted a 33 year old male subject who was accompanied by his 8 year old son. The adult male was behaving strangely and irrationally, and was determined to have been diagnosed with mental health disorders. The subject had not taken his prescribed medication since February. The son reported his father's behavior was normal to him and he was not frightened, but that his mother was difficult to get ahold of. Officers attempted to reach the mother without success. The child was released to the custody of Child Protective Services and the adult male was taken to the hospital for a medical condition. 15-1836

On June 26<sup>th</sup> at about 2:15 PM a Ukiah Police Officer was contacted by a subject who reported another subject had brandished a knife. The victim stated he was driving in the 100 block of Peach Street and observed 30 year old David Morris Calvo throw trash onto the ground. The victim confronted Calvo telling him to pick up the trash and that the victim was trying to keep Ukiah clean. Calvo refused and continued walking, and the victim exited his vehicle and confronted Calvo again. The two argued but Calvo agreed to pick up the trash. The victim saw Calvo did not retrieve the trash and confronted him yet again. Calvo apparently began walking towards the victim and pulled a knife and displayed it. Calvo was located and subsequently placed under citizen's arrest for brandishing a weapon. 15-1838

On June 27<sup>th</sup> at about 12:45 AM Ukiah Police responded to the apartment complex in the 100 block of Norton Street for a subject pounding on doors. Officers located 32 year old Benjamin Franklin Hoff at the top of a stair case, crouching behind a potted plant and muttering

about people being after him. There were several other potted plants overturned, and Hoff stated he had been trying to hide. Hoff was found to be under the influence of a controlled substance and was arrested. Hoff was on Post Release Community Supervision however Hoff's probation officer was unable to violate Hoff's conditional release pursuant to recent law requiring the offender first be afforded three opportunities for drug treatment. 15-1849

On June 27<sup>th</sup> at about 1:35 AM Ukiah Police responded to the backyard of a residence in the 100 block of Leslie Street for a subject petting and barking at the dog. Officers found 25 year old Travis Tripp, of Wisconsin, extremely intoxicated and he was arrested for public intoxication. 15-1851

On June 27<sup>th</sup> at about 12:25 PM Ukiah Police responded to the Wal Mart parking lot, at 1155 Airport Park Boulevard, for a subject spray painting two Ford Mustangs. Ukiah Police had previously received information from the Fort Bragg Police Department that had investigated a hit and run traffic collision earlier in the day, wherein an 82 year old female was injured. The suspect vehicles were described as two Ford Mustangs. Officers contacted 39 year old Timothy James King who was spray-painting one of the Mustangs, and a 17 year old male juvenile. Both subjects were arrested for hit and run, criminal conspiracy, and destruction of evidence at the request of the Ford Bragg Police Department. 15-1855

On June 28<sup>th</sup> at about 1:30 AM Ukiah Police Officers were assisting Ukiah Valley Medical Center Emergency Room staff with 28 year old Kelisha Alvarez, who insisted she required medical care. Alvarez refused to stop spitting, and became agitated and belligerent and proceeded to disrupt the facility. Alvarez lowered her head and bit one of the attending nurses in the lower torso, causing redness, and physically resisted the officers' attempt to restrain her. Alvarez was placed under citizen's arrest for battery upon medical staff, and also charged with resisting arrest and with violating her probation restricting her from being at the hospital. Alvarez continued spitting on the way to the jail while kicking and yelling for the officer to die. 15-1862
