Patrol Division Weekly Activity Report 07/16/15 to 07/22/15

Statistics

Arrests included: 12 warrant arrests, 8 for public intoxication, 3 for DUI, 2 for assault and battery, 2 for Domestic Battery, 3 for violation of probation, 8 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 4 for possession of a methamphetamine, 2 for possession of a dangerous weapon, 2 for violation of a domestic violence order, 2 for parole violation, and one each for prowling, possession of heroin, possession of marijuana for sale. Probation holds were placed on 12 of these arrests and 1 was additionally charged with resisting arrest.

Officers investigated and took reports of: 9 found property, 11 abandoned vehicles, 2 traffic collisions, 3 burglaries, 2 vandalisms, 2 thefts, 2 city code violations, 2 suspected child abuse, and one each of mental health evaluation, drug registration, transportation of marijuana, death investigation, vehicle theft, unlawful sexual intercourse, mayhem, and possession of child pornography.

The Patrol Division's average response time to in-progress calls was about 2 ½ minutes. The average response time to all other calls was about 10 minutes.

Highlights for the Week

On 07/16/15, at about 514 PM Ukiah Police stopped a silver Honda Accord being driven by 51 year old Lucerne resident Scott Walker due to a traffic violation. During the stop the officer learned that Walker's drivers license was suspended for a prior DUI and that he was displaying symptoms of alcohol intoxication. Also in the vehicle at the time were a female passenger and small child. Walker was asked to complete a series of field sobriety tests and determined to be too intoxicated to be driving a vehicle. Walker was arrested for DUI, child endangerment and driving on a suspended license. 15-2041

On 7/16/15 at about 1153 PM, Ukiah Police responded to 566 Stella Dr. due to the residents being awoken after hearing banging on the side of the home and then on the roof. The resident went outside to investigate and observed a male subject on the roof yelling and refusing to come down. Upon officers arrival they observed 44 year old Ukiah resident Corey Heine on the roof of the home. Heine was ordered off of the roof and arrested for prowling without incident. 15-2047

On 7/17/15 at about 1228 PM, Ukiah Police responded to Irvington Dr. regarding a neighbor dispute. Upon officer's arrival, they spoke with 37 year old Brianne McCain and 50 year old Estela Ayala both Ukiah residents. In speaking with the two officers learned that McCain and Ayala had been involved in a verbal argument due to Ayala's grandchildren throwing trash into McCain's yard. It was during this argument that both Ayala and McCain claimed that the other assaulted them. Both Ayala and McCain placed each other under citizens arrest and both were issued citations to appear in court for battery. 15-2054

On 07/19/15 at about 1221 AM, Ukiah Police observed 38 year old Ukiah resident Kellie Ristine behind 401 S. State St, Hospice, rummaging through items behind the building. Officers contacted Ristine and while speaking with Ristine she told officers that he had a methamphetamine pipe in her backpack. Officers searched Ristine and found that she was in possession of a methamphetamine pipe and a small amount of methamphetamine. Ristine was also determined to be on probation and was arrested for possession of methamphetamine, possession of drug paraphernalia and violation of her probation. 15-2069

On 7/19/15 at about 647 PM, Ukiah Police responded the 1200 block of W. Standley St regarding a male walking in the area nude. Upon officers arrival they contacted 67 year old Ukiah transient John Driggs. Driggs was not wearing any clothing. Officers asked Driggs why he was walking in public nude. Driggs explained that he was attempting to locate a spot in the nearby creek to take a bath and was unaware that he was in a residential neighborhood. Officers checked Driggs for warrants and probation and learned that Driggs was currently on parole for indecent exposure. Officers contacted the reporting party who did not desire prosecution. Officers contacted Driggs parole officer and a parole hold was placed on Driggs for violating his parole terms. Driggs was arrested and booked into the Mendocino County jail. 15-2078

On 7/20/15 at about 520 PM, Ukiah Police responded to 1208 S. State St, Motel 6, room 111 for a report of a possible burglary. Upon officer's arrival, they spoke with the male victim who was attempting to cover himself with a small towel. The victim explained to officers that he had come to the Motel with two female subjects after arraigning to have sexual intercourse in exchange for money. Once in the room the victim was asked by the two women to take a shower. While taking a shower the victim heard the two women leave the room. Upon exiting from the shower the victim discovered that the two women had taken all of his clothing, his shoes, cellphone, his wallet and all of the towels except the small towel he was attempting to cover himself with. Officers searched the area for the two women with negative results. During this search officers spoke with a witness who had observed two women running from the area. The witness said he followed the female subjects for a little while but eventually lost sight of them, although he did locate a pair of blue jeans and brought them back to the scene. This matter is still under investigation and anyone with information is asked to contact the Ukiah Police Department. 15-2089

On 07/21/15, at about 159 AM, Ukiah Police observed a black Honda CRV behind 628 S. State St, Happy Donut and Bagel. Upon checking the vehicle, officers observed 29 year old Ukiah transient Tomas Reyes inside the vehicle. Officers conducted a records check of Reyes and learned that Reyes was currently on probation and subject to search and seizure. A search of Reyes person and vehicle was conducted. Reyes was found to be in possession of a methamphetamine pipe and was subsequently arrested for possession of drug paraphernalia and violation of his probation. 15-2093
