Patrol Division Weekly Activity Report 07/23/15 to 07/29/15

Statistics

Arrests included: 11 warrant arrests, 6 for public intoxication, 2 for possession of a controlled substance and one each for shoplifting, Domestic Violence, violation of probation, being under the influence of a controlled substance and/or possessing drug paraphernalia, possession of a dangerous weapon, violation of a domestic violence restraining order, violation of parole, assault with a deadly weapon, assault on an EMT. Probation holds were placed on 3 of these arrests.

Officers investigated and took reports of: 6 found property, 6 abandoned vehicles, 2 city code violations, 3 suspected elder abuse, 10 suspected child abuse, 3 thefts, 2 burglary and one each for missing person, traffic collision, and vandalism.

The Patrol Division's average response time to in-progress calls was about 4 minutes. The average response time to all other calls was about 12 minutes.

Highlights for the Week

On 07/23/2015 at about 1019 PM, Ukiah Police Officers were dispatched to 998 South State St, the Express Mart, regarding an off-duty Mendocino County probation officer seeing a male juvenile probationer who was currently wanted for violating his probation. Upon officers arrival

they attempted to contact the juvenile, who turned away from the officers and began to run N/B through the parking lot a short distance before officers were able to stop the juvenile. As the officers went to take the juvenile into custody the juvenile began fighting with officers in an attempt to free himself. Officers were able to restrain the juvenile and took said juvenile into custody without further incident. The juvenile was later booked into the Mendocino County Juvenile Hall. 15-2134

On 07/24/2015 at about 217 PM, Ukiah Police observed 47 year old Ukiah transient David Kroll standing near the bus stop located in the JC Penny parking lot. Kroll was facing west towards N. Orchard Avenue urinating, as numerous vehicles passed his location. Officers contacted Kroll and found that he was intoxicated. Kroll was arrested and booked into the Mendocino County jail for public intoxication. 15-2139

On 07/25/2015 at about 900 PM, Ukiah Police responded to a report of a stabbing at 998 S. State St, The Express Mart. Upon officers arrival they contacted the victim who had sustained an approximately two inch long laceration on his left upper left chest. The victim reported to officers that he and the suspect, who was later identified by both the victim and witness, as 45 year old Ukiah transient John Zerangue, had been in an argument over \$100.00. The victim reported to officers that he had confronted Zerangue about Zereangue stealing the money. Zerangue then assaulted the victim with a knife. After the assault the victim and witness reported that Zereangue fled north going towards Safeway. An immediate search for Zerangue was conducted by officers and Zerangue was found hiding inside the Safeway restroom. Zerangue was arrested without incident and booked into the Mendocino County Jail for assault with a deadly weapon and violation of his probation as Zerangue is currently on probation. 15-2150

On 07/26/2015 at about 712 PM, Ukiah Police responded to Ukiah Valley Medical Center, 275 Hospital Dr, regarding a combative subject biting a paramedic. This subject was later identified as 32 year old Ukiah transient Scotty Willis. Upon officer's arrival they contacted the victim paramedic who was wearing the required Medstar uniform. The paramedic advised that after treating Willis for the medical emergency he had become combative. It was as the paramedic was attempting to secure Willis on the gurney that he reportedly bit the paramedic on the

left forearm causing an injury. A records check of Willis showed that he is currently on probation. Willis was later arrested for assault on an emergency medical technician and violation of probation.

On 07/27/2015, about 809 PM Ukiah Police responded to the New Life Church, 750 Yosemite Dr. regarding a male subject seen in the bushes. This subject was later identified as 31 year old Ukiah transient David Calvo. Due to prior contacts officers knew Clavo to be on probation and confirmed that the terms of his probation were still active. A search of Calvo revealed that he was in possession of a methamphetamine pipe, a hypodermic syringe containing methamphetamine and a small amount of heroin. Calvo was arrested for possession of a controlled substance, possession of drug paraphernalia and violation of probation. 15-2167

On 07/29/2015 at about 101 AM, Ukiah Police observed 42 year old Ukiah transient Kenneth Ewing urinating in the 500 block of S. Main St. Officers contacted Ewing and noticed that his eyes were bloodshot and watery, he had a strong odor of an alcoholic beverage emitting from his person and he had difficulty standing. As officers spoke with Ewing they noticed he had what appeared to be a fixed blade knife protruding from under his shirt inside his waist line. Officers searched Ewing and found that the knife was a replica Hitler Youth dagger. Ewing was arrested for possession of a dangerous weapon and booked into the Mendocino County Jail.
