Statistics

Arrests included: 9 warrant arrests, 6 for public intoxication, 2 for fighting in public, 2 for evading and/or reckless driving, 3 for Domestic Violence, 3 for violation of probation, 2 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 5 for possession of a controlled substance and one each for prowling, terrorists threats, resisting/delaying an officer, shoplifting, driving on a suspended license, burglary, violation of parole, and violation of a domestic violence restraining order. Probation holds were placed on 6 of these arrests.

Officers investigated and took reports of: 9 found property, 2 traffic collisions, 2 missing persons, 2 drug registrants, 6 abandoned vehicles, 3 stolen vehicles, 3 suspected elder abuse, and one each for suspected child abuse, mental health evaluation, disturbing the peace, embezzlement, theft, rape, use of force and suspicious circumstance.

Officer investigated 2 traffic collisions.

The Patrol Division's average response time to in-progress calls was about 5 minutes. The average response time to all other calls was about 12 minutes.

Ukiah Police Officers assisted and were assisted by the Mendocino County Sherriff's Office, CHP and the Mendocino Major Crimes Task Force.

Highlights for the Week

On 07/30/2015, at about 820 PM, Ukiah Police responded to 100 blk of East Gobbi Street regarding a physical disturbance near the Village Circle apartment complex's community garden. Upon officers arrival they began searching the area for the involved parties and were able to contact the victim walking N/B in the 500 blk of S. Main St. Upon contacting the victim he reported to officers that he was near the community garden when he was attacked by a white male adult. This subject was later identified as 24 year old Ukiah transient Robert Campbell.

The victim reported to officers that Campbell had approached him and suddenly began hitting and kicking the victim multiple times in the face, upper torso and back. After this attack the victim reported that Campbell took the victim's cell phone and fled the area. While officers spoke with the victim a second physical disturbance began in the Alex Thomas Plaza. The suspect in this second disturbance matched the description of Campbell. Officers responded to Alex Thomas Plaza and were able to locate and detain Campbell. Campbell was found to not be in possession of the victim's cell phone yet was identified as the suspect who had assaulted the victim. Campbell was arrested and booked into the Mendocino County Jail for robbery.

On 07/31/2015 at about 1250 PM, Ukiah Police responded to a physical disturbance between a male and female subject in the 1200 Block of S. State St. Upon officers arrival they spoke with the female victim, who reported that her boyfriend, 40 year old Mariposa resident James Diaz, had assaulted her. The victim reported to officers that while parked at the location she and Diaz had begun arguing. It was during this argument in which Diaz reportedly placed his arm around the victim's neck and proceeded to squeeze choking the victim. The victim in turn began struggling by kicking the vehicle's horn and struggling to free herself. The victim reported that she was able to free herself and flee from the vehicle running into a nearby store. Diaz fled the area and is currently being sought regarding questioning on this matter. 15-2211

On 8/1/2015 at about 926 PM, Ukiah Police observed two vehicles racing through the intersection of Talmage Rd and S. State St. Upon officers attempting to stop the vehicles for the violation, one stopped while the other fled. Officers pursued after this second vehicle which was a black Acura Integra being driven by 19 year old Ukiah resident William Villa. Officers pursued after the Acura southbound on S. State St to Washington Ave west to S. Dora St. and then northbound onto S. Dora St reaching a speed of 60 MPH. As officers pursued after the

Acura they observed it fail to stop at three separate stop signs at the intersections of Dora and Washington, Dora and Observatory and then Dora and Mill St.

As the Acura proceeded north on S. Dora St it passed other vehicles traveling in front of it on the right driving into the bicycle lane to make this pass. After passing through the intersection of W. Mill and S. Dora officers observed it turn east onto Jones St. and were able to block the vehicle's path and subsequently bring the pursuit to an end. Villa was arrested and booked into the Mendocino County jail for evading a police officer and reckless driving. 15-2226

On 08/02/2015 at about 329 AM, Ukiah Police observed 43 year old Ukiah transient Dwayne Mckenzie walking in the rear parking lot Umpqua Bank at 607 S. State Street. Officers contacted Mckenzie to determine what he was doing and learned that he was sleeping in the bushes along the property line. Upon conducting a records check on Mckenzie, Officers learned that Mckenzie is currently on probation for drug related charges. Officers conducted a search of Mckenzie's person and found that he was in possession of methamphetamine and a methamphetamine pipe. Mckenzie was arrested and booked into the Mendocino County jail. 15-2231

On 8/02/2015 at about 1120 AM, Ukiah Police were parked in the Mendocino Farm Supply, 303 Talmage Rd, monitoring traffic when they observed a red Nissan Sentra, being driven by 41 year old Ukiah transient Jose Acosta, exiting out of the parking lot and into eastbound traffic on Talmage Rd. at a high rate of speed. As the Nissan entered onto Talmage Rd the eastbound traffic had to abruptly stop to avoid a collision. Officers drove after the Nissan to initiate a traffic enforcement stop for the fail to yield violation as the Nissan turned northbound onto Betty St.

Betty St is a residential street that has several speed bumps to aid in controlling vehicle speed. As officers followed after the Nissan they observed it traveling at a high rate of speed as it drove over the speed bumps which in turn caused the Nissan to slightly be airborne as it drove over the separate speed bumps. Seeing that the Nissan was not stopping officers initiated a vehicle pursuit and continued following after the Nissan as it turned east onto Marlene passing a vehicle on the left as it also was turning left onto Marlene St. From Marlene St. the Nissan continued east to Lorraine St where it turned left and came to a stop.

Officers conducted a felony car stop, ordering Acosta from the vehicle. Acosta was arrested without further incident. Upon searching the Nissan officers discovered several articles of clothing that still had price tags attached. Officers suspected the articles of clothing had been stolen from the Farm Supply and contacted the store manager who confirmed that Acosta had just fled the store with multiple articles of clothing. Acosta was booked into the Mendocino County jail for evading police and shoplifting. 15-2232

On 8/02/2015 at about 109 PM, Ukiah Police responded to Ukiah Valley Medical Center, regarding 27 year old Ukiah transient Kelisha Alvarez refusing to leave the doctor's office. Officers know Alvarez due to prior Law Enforcement contacts and knew that Alvarez is currently on probation for Contempt of court and that terms of her probation indicated she was to have no contact with UVMC unless for medical needs. Upon officers arrival they learned that Alvarez had been treated for a medical reason but was now refusing to leave the office. Officers contacted Alvarez and requested her to leave and explained to her that if she refused to leave she would be arrested for violating her terms of probation. Alvarez refused and was arrested and booked into the Mendocino County jail for violation of probation. 15-2234

On 8/03/2015 at about 1213 PM, Ukiah Police responded to a residential burglary in progress on Sidnie St. As officers responded they were provided with a description of the suspect, who was later located walking on Sidnie St. This suspect was identified as 26 year old Fort Bragg resident Michael North. Officers detained North and contacted the victim. The victim reported to officers that while seated in her living room with her two children she observed North climb over her fence into her backyard. The victim watched as North walked through her yard towards the rear sliding glass door. As North reached the glass door he cupped his hands against the glass and began looking inside. After doing this North reportedly reached down and started to open the door at which point the victim screamed causing North to stop and leave the yard. Officers conducted a records check of North and learned that he is currently on probation for possession of stolen property and possession of burglary tools. North was arrested and booked into the Mendocino County jail for attempted burglary and violation of probation. 15-2244

On 08/05/2015, at about 147 Am, Ukiah Police responded to Safeway, 653 S. State St, regarding a subject in the attic of the business above the pharmacy. Upon officers arrival store employees reported that they had heard a subject talking and banging in the attic. Officers climbed into the attic and located 44 year old Ukiah transient Corey Heine. Heine had entered
