Statistics

Arrests included: 6 warrant arrests, 3 for shoplifting, 3 for driving under the influence, 2 for Domestic Violence, 2 for assault with a deadly weapon, 2 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 2 for resisting/delaying an officer and one each public intoxication, defrauding a restaurant, threats, battery, vandalism, grand theft, and violation of parole. Probation holds were placed on 3 of these arrests and one was additionally charged with resisting arrest.

Officers investigated and took reports of: 7 found property, 4 traffic collisions, 4 missing persons, 9 thefts, 2 identity thefts, 2 suspected child abuse, 2 burglaries, 2 Domestic disturbance, 6 warrants (citable), and one each for mental health evaluation, possession of marijuana on school property, disturbing the peace, violation of Domestic Violence court order, battery, abandoned vehicle and attempted murder.

Officer investigated 4 traffic collisions.

The Patrol Division's average response time to in-progress calls was about 4 minutes. The average response time to all other calls was about 13 minutes.

Ukiah Police Officers assisted and were assisted by the Mendocino County Sheriff's Office, CHP and the Mendocino Major Crimes Task Force.

Highlights for the Week

On 08/06/2015 at about 740 PM, Ukiah Police responded to Applebee's, 1201 Airport Park Blvd, regarding a "Dine and Dash." Upon arrival officers learned that 41 year old Ukiah transient Michael Mahaffey had ordered food and drinks totaling \$61.00 and after consuming these items left without paying. Officers located Mahaffey in a vehicle parked in the Wal-Mart parking lot. While officers attempted to question Mahaffey regarding the theft he became combative. Officers used pepper spray on Mahaffey to aid in taking him under control. Mahaffey was placed under arrest for defrauding a restaurant and resisting arrest. 15-2277

On 8/09/2015 at about 958 PM, Ukiah Police responded to the 300 block of Leslie St regarding multiple gunshots being heard. Upon arrival officers spoke with several witnesses who reported that a dark colored 4 door sedan with tinted windows had stopped in front of the apartments at 325 Leslie Street. While stopped here the occupants in the car appeared to be in a verbal confrontation with a group of subjects who had been standing on the sidewalk in front of the apartment building. Witnesses reported that it was during this verbal argument that an unknown subject from the group on the sidewalk began shooting at the sedan. Several gunshots were heard with the sedan speeding away going south on Leslie St. and the group on the sidewalk were seen running north on Leslie St. Anyone with information regarding this incident are encouraged to contact the Police Department. 15-2308

On 08/10/2015 at about 333 AM, Ukiah Police responded to the 700 block of S. State St regarding a reported "drunk driver" driving a silver Nissan Titan. The witness reported that the Nissan was observed stopping in the middle of the road as it traveled west on E. Gobbi St and that it repeatedly crossed over into the oncoming lane of traffic. Upon officers arrival the vehicle was located parked in the Chase Bank parking lot. Officers contacted the driver, identified as 26 year old Sanger resident Jose Moreno, who was still seated in the driver's seat. Also in the vehicle at the time were two minor children. As officers spoke with Moreno he displayed symptoms of alcohol intoxication. Moreno was found to be on probation for DUI and was arrested for DUI, violation of probation and child endangerment. 15-2311

On 08/10/2015 at about 846 PM Ukiah Police responded to Marino's Pizza, 142 Talmage Rd. for a physical altercation in which an involved party had been pepper sprayed. Upon officers arrival they learned that 27 year old Andres Herrero had entered the restaurant and was being verbally abusive towards the employees. Herrero was also found to be intoxicated. The victim,

who had been waiting for his order, reportedly told Herrero, “To get his food and shut up.” Upon hearing this Herrero reportedly approached the victim and assaulted him. The victim reported that Herrero grabbed the victim by his shirt collar as Herrero raised his right fist to the victim’s face. In fear of his safety the victim sprayed Herrero once with pepper spray causing Herrero to release his hold and leave the restaurant. Herrero was arrested for battery and public intoxication. 15-2320
