The Patrol Division's average response time to in-progress calls was a little over 3 minutes. The average response time to all other calls was a little over 11 minutes.

### Highlights for the Week

On 10/8/15 at about 5:52 PM, a UPD officer was dispatched to the 600 block of Talmage Road, on a reported intoxicated subject. Upon arrival the officer contacted a subject who he knew as Roger Schoenahl age 43 of Ukiah. While the officer spoke with Schoenahl he noticed the extreme signs of alcohol intoxication. Schoenahl was found to be too intoxicated to care for his safety or that of others and was taken into custody for drunk in public. Schoenahl was booked into county jail on the violation. 15-3965

On 10/8/15 at about 6:35 PM, UPD officers were dispatched to the 100 block of Ford Street, on a report of an intoxicated female who drove her vehicle into a building, causing minor damage. Upon arrival officers contacted the driver of the vehicle Gwendolyn McGrath age 64 of Ukiah. As the officers spoke with McGrath they noticed she appeared intoxicated, so they began a DUI traffic accident investigation. During that investigation McGrath was determined to be too intoxicated to be operating a vehicle and was taken into custody for DUI. A records check on McGrath found that he she was on probation, had a suspended license, and had active warrants for her, one out of Mendocino County for DUI and the other out of Lake County for domestic battery. McGrath was booked into county jail on the DUI, violation of her probation, driving suspended, and the two warrants. 15-2966

On 10/9/15 at about 1:09 AM, a UPD officer was on active patrol when he stopped a subject in the 600 block of South State Street for a traffic violation. The subject was identified as Randall Gensaw age 42 of Ukiah, who is on probation out of this county. The officer noticed that Gensaw appeared to be under the influence of an illegal controlled substance and began an investigation. Gensaw was found to be in possession of drug paraphernalia, under the influence of a controlled substance, and in violation of his probation. Gensaw was taken into custody for the violations and booked into county jail. 15-2969

On 10/9/15 at about 1:41 PM, a UPD officer was on active patrol in the 900 block of North State Street, when he contacted Delbert Alford age 28 and Ronald Pedigo age 56. Both Alford and Pedigo were found to be on active Parole out of this county and per a term of their Parole, were not supposed to be associating with each other. At the residence Katherine Bowes age 25 and William Williams age 22 both of Ukiah were contacted. Bowes was found to have an active probation violation warrant and Williams an active possession of controlled substance warrant. Officers contacted Scott Heidinger age 55 of Ukiah, who was causing a disturbance in the emergency room of the hospital. While speaking with Heidinger officers noticed that he appeared to be extremely intoxicated. Heidinger was found to be too intoxicated to care for his safety or that of others and was placed under arrest for drunk in public. Heidinger was booked into county jail. 15-2990

On 10/11/15 at about 7:51 AM, a UPD officer was dispatched to the 1300 block of South Dora Street, on a reported non-injury traffic collision. Upon arrival the officer located a female subject who was identified as Margaret Hooker age 69 of Ukiah. It was reported to the officer that Hooker was southbound on South Dora Street, when she felt dizzy and attempted to pull over to the side of the road. Hooker veered her vehicle to the right, colliding with the Ukiah Police Department's speed radar trailer, which was parked next to the curb edge on South Dora Street. Hooker continued southbound and collided with a parked car, before her vehicle came to a rest. The radar trailer and Hooker's vehicle sustained severe damage. 15-2993

Upon arrival officers contacted Prudence Davis age 19 of Ukiah, and a male subject in his early 30s. During the investigation, officers determined that Davis and the male were involved in a dating relationship. Davis and the male became involved in a heated argument and Davis physically assaulted the male subject, causing a minor injury. Davis was arrested for domestic assault and booked into county jail. 15-2995

On 10/12/15 at about 3:39 PM, UPD officers were dispatched to McDonalds in the 100 block of North Orchard Avenue, on a reported disturbance. UPD dispatch advised responding offices that two customers were involved in a verbal argument. Upon arrival officers separated and spoke with the two customers. A 34 year old male subject from Palo Alto reported that he was inside the restaurant eating lunch with his family, when a male subject came up to his table and started yelling at him. The male subject was identified as Ruben Herrera age 47. Herrera threatened to assault the male subject. The male subject not wanting to put his family in danger decided to get up and walked outside, as Herrera followed. Outside Herrera spit on Herrera and continued to

On 10/12/15 at about 10:01 PM, Officers were dispatched to Safeway on South State Street, on a report of a male subject yelling profanities at employees and customers. Upon arrival officers contacted Thomas Sanders age 53. As officer spoke with Sanders, they noticed he displayed the extreme signs of alcohol intoxication and was found to be too intoxicated to care for his safety or that of others.
