Statistics

Arrests included: 6 warrant arrests, 1 VOP (violation of probation) / under the influence / possession of drug paraphernalia, 2 VOP / theft, 1 warrant arrest / possession of drug paraphernalia, 6 drunk in public, 1 shoplifting, 1 possession of a controlled substance / possession of drug paraphernalia, 2 DUIs, 1 attempt burglary / vandalism, 2 VOP / possession of a controlled substance / possession of drug paraphernalia, 1 parole violation / trespassing / disturbance in park, 1 VOP / disturbance in park, 1 possession of dirk/dagger, 2 domestic assaults, 1 battery, 2 VOPs, 1 warrant / resist arrest / possession of a controlled substance, 1 burglary / possession of stolen property / possession of dirk/dagger

Officers investigated and took reports of: 1 abandon vehicle tow, 2 parking tows, 3 traffic collisions, 2 burglary reports, 3 cultivation of Marijuana investigations, 9 found property, 5 issued in error, 2 cited for possession of marijuana, 2 cited for having dogs in Alex Thomas Plaza, 1 possession of alcohol in Alex Thomas Plaza, 3 threats, 4 thefts, 1 cited on misdemeanor warrant, 1 cited for illegal camping, 1 marijuana being shipped, 1 urinating in public cite, 1 driving without license, 1 dog bite, 1 burglary, 2 domestic investigations, 1 missing person, 1 hit and run,

The Patrol Division's average response time to in-progress calls was a little under 4 minutes. The average response time to all other calls was a little over 13 minutes.

Highlights for the Week

On 10/15/15 at about 8:02 am, a UPD officer was on active patrol in the 1300 block of South State Street, when he observed a subject he knew named Mark Brandt age 49, walking in the area. The officer was aware that Brandt had an active felony warrant for his arrest out of Placer County and contacted him. Brandt was taken

into custody for the warrant without incident. During his arrest, Brandt was found to be in possession of illegal drug paraphernalia. Brandt was booked into county jail for the violations. 15-3027

On 10/15/15 at about 1:15 pm, a UPD officer on active patrol contacted a subject behind CVS in the 100 block of South Orchard Avenue. The officer recognized the subject as Thomas Sanders age 53 of Ukiah. While speaking to Sanders, the officer noticed that he displayed the extreme signs of alcohol intoxication. Sanders was found to be too intoxicated to care for his safety or that of others and was taken into custody for drunk in public. Sanders was booked into county jail. 15-3036

On 10/15/15 at about 10:34 pm, UPD officers were dispatched to the area of East Perkins Street and North Orchard Avenue, for a reported drunk driver in a Beige 2001 Toyota Corolla. It was reported to dispatch that the vehicle had pulled into the parking lot of JCPenney and two male subjects were seen stumbling around the vehicle and were now involved in an argument. Upon arrival a UPD officer observed the vehicle and occupants attempting to drive away from the JCPenney parking lot and he performed a traffic stop on the vehicle. The officer contacted the driver, who was identified as Wilfred Heidinger age 78 and his passenger Scott Heidinger age 55, both of Hopland. While dealing with Wilfred the officer noticed that he appeared intoxicated and began a DUI investigation. A records check showed that Wilfred's license was suspended. Wilfred was found to be too intoxicated to be operating a vehicle and was taken into custody for DUI and driving on a suspended license. Officers spoke with Scott and found that he was too intoxicated to care for his safety or that of others. Scott was taken into custody for drunk in public. Both Wilfred and Scott were booked into county jail. 15-3041

On 10/15/15 at about 10:34 pm, UPD officers were dispatched to the area of Slam Dunk Pizza on North State Street on a report of a suspicious person in the area. Officers arrived and checked the area, but were unable to locate anyone. At about 10:54 pm, officers were dispatched back to Slam Dunk Pizza on a report of a burglary that had taken place to a vehicle in the parking lot. The victim reported that items had been taken from the vehicle, but there were no suspect leads. On 10/16/15 at about 12:19 am, Officers were dispatched to Slam Dunk Pizza for a reported of an alarm. During the alarm investigation and reviewing video surveillance, officers found that a female subject had been inside the bathroom of the restaurant when the business closed and set the alarm off when she exited the business. The female subject had left personal items of hers inside the bathroom and one of the officers recognized her from the surveillance as Malia Linde age 21 of Willits. In the area officers locate Linde and her boyfriend Theo Corcoran age 29. Both were questioned and released at this time, because officers on scene were unable to establish enough probable cause to show that either intentionally committed a crime at this time. At about 2:43 am, UPD officers were dispatched back to Slam Dunk Pizza for a report of another alarm. It was discovered that an attempted forced entry had been made into the business. During a review of surveillance video, officers discovered that Theo Corcoran was responsible and officers soon found sleeping in bushes in the area. Corcoran was taken into custody for attempted burglary and vandalism to the business. During this investigation officers were able to link Corcoran to the earlier vehicle burglary. Corcoran was booked into county jail on the violations. 15-3044

On 10/17/15 at about 2:25 am, a UPD officer was on active patrol in the 100 block of North Orchard Avenue, when he stopped a red Chrysler 200 for traffic violations. The driver identified himself as Edger Perez-Appleyard age 22 of Ukiah. As the officer spoke with the driver he noticed Perez-Appleyard appeared intoxicated, so the officer initiated a DUI investigation. From that investigation Perez-Appleyard was found to be too intoxicated to operate a motor vehicle and was arrested for DUI. Perez-Appleyard was booked into county jail for the violation. 15-3053

On 10/17/15 at about 3:11 pm, UPD officers were dispatched to the 500 block of North State Street, on a report of a female subject walking in and out of traffic. Upon arrival officers contacted Bonnie Richards age 51 of Ukiah. Richards displayed the extreme signs of alcohol intoxication and was found to be too intoxicated to care for her safety or that of others. Richards was placed under arrest for drunk in public and booked into county jail. 15-3057

On 10/18/15 at about 11:58 am, UPD officers were dispatched to the 300 block of South State Street, on a report of a subject being very disruptive during PumpkinFest. The subject had also been engaged in multiple verbal disputes with different subjects for no apparent reason. When the subject was asked to leave by staff he refused. Officers arrived and identified the subject as Michael Lucas age 42 of Ukiah, who is on Parole. Lucas was placed under citizen's arrest by staff for causing a disturbance in a city park and trespassing. Lucas' Parole Officer was contacted and a parole hold was placed on him. Lucas was booked into county jail on the violations. 15-3066

On 10/18/15 at about 5:54 pm, UPD officers were dispatched to the 100 block of Leslie Street, for a report of a suspicious male subject who had thrown a speaker at a passing vehicle. Upon arrival officers contacted Rafael Maldonado Mata age 21 of Ukiah, who matched the description given. UPD officers contacted the reporting party, who said he was driving on Leslie Street when for an unknown reason Mata threw a speaker at his vehicle, causing minor damage. As officers were dealing with Mata he was found to be in possession of an illegal concealed dirk/dagger and was taken into custody. Mata was booked into county jail on the violation. 15-3070

On 10/19/15 at about 11:47 pm, a UPD officer was dispatched to Walmart of a report that Timothy McCosker age 46 of Willits, was placing merchandise inside his pants. Upon arrival officers contacted McCosker and detained him. Officers learned that just prior to their arrival McCosker had returned the items to the store. A records check on McCosker found that he was on probation with a "No direct / indirect contact with Walmart" clause on his probation. McCosker was taken into custody for violation of probation and booked into county jail. 15-3080

On 10/21/15 at about 1:21 am, UPD officers were dispatched to Rainbow Ag. on East Perkins Street regarding an alarm. While checking the business and area, an officer noticed a subject running southbound across East Perkins Street. The running subject had a backpack on and was carrying some type of clear bag with items inside. Officers contacted and spoke with the subject, concerned that he had just committed a crime. The

During the officers investigation, they discovered that the items Barber had in his possession had just been stolen from a vehicle that was parked in the 200 block of North Main Street. Barber was also found to be in possession of an illegal dirk/dagger. Barber was taken into custody for burglary, possession of stolen property and possession of an illegal dirk/dagger.
