The Patrol Division's average response time to in-progress calls was a little over 4 minutes. The average response time to all other calls was a little over 13 minutes.

Highlights for the Week

On 10/23/15 at about 5:13 am, UPD officers were dispatched to the area of Carrigan Ln. and Donner Ct., regarding two suspicious persons, who were seen in the reporting party's front driveway. Officers contacted Ryan Dickerson age 36 of Covelo and Brittany Davis age 25 of Ukiah, who match the description given by the reporting party. Upon contact of the two Ryan Dickerson provided officers with a false name. When Officers were able to identify Dickerson, he was found to have two misdemeanor and one felony warrant for his arrest. Dickerson was taken into custody for the warrants and was found to be in possession of a controlled substance. Dickerson was booked into county jail for the violation. 15-3116

On 10/23/15 at about 11:14 pm, a UPD officer was dispatched to Kohl's on a report of a shoplifter in custody. Upon arrival the officer contacted the loss prevention officer, who had Wana Matthias age 28 of Ukiah detained for the theft. It was explained to the officer that Matthias entered the store, selected earrings, and a backpack. Matthias then removed the earrings from their packaging and put them on. Matthias selected jeans and a pair of yoga pants. Matthias used a pair of pliers she had brought into the store to remove the security devices from the merchandise. Matthias put the merchandise on and exited the store without paying for the items. Matthias was placed under arrest for shoplifting and possession of burglary tools. 15-3126

On 10/23/15 at about 10:34 pm, a UPD officer was on active patrol in the 600 block of Leslie St., when he contacted a subject who appeared to be illegally camping. The subject was identified as Jason Johnson age 44. Johnson was discovered to be on Parole out of Red Bluff and admitted that he recently left a drug treatment program. The Parole Office in Red Bluff was notified and a Parole hold was placed on Johnson, who was booked into county jail. 15-3127

On 10/24/15 at about 1:53 am, a UPD officer on active patrol performed a traffic stop on a vehicle in the 100 block of Leslie Street for multiple traffic violations. The officer contacted the driver, who identified herself as Maria Valencia-Ortiz age 22 of Ukiah. As the officer spoke with Valencia-Ortiz, he noticed the objective signs of alcohol intoxication and began a DUI investigation. It was determined that Valencia-Ortiz was too intoxicated to be operating a vehicle and she was placed under arrest for DUI. 15-3128

On 10/24/15 at approximately 3:50 am, UPD officers were dispatched to a possible intoxicated driver in the area of Marshall Street, driving a red Chrysler with paper plates. The possible DUI driver and vehicle were located in the 2200 block of South State Street. The driver was identified as Edgar Perez-Appleyard age 24 of Ukiah. As the officer spoke with Perez-Appleyard, he noticed the objective signs of alcohol intoxication and began a DUI investigation. It was determined that Perez-Appleyard was too intoxicated to be operating a motor vehicle and was placed under arrest for DUI. 15-3130

On 10/26/15 at about 11:21 am, a UPD officer contacted Joshua Moore age 27 in Safeway parking lot, who is on Post Release Community Supervision (PRCS) out of Mendocino County; which includes terms of search and seizure, no alcohol and no dangerous weapons. While dealing with Moore the officer discovered that Moore had a large folding knife in his possession, in violation of his probation. The officer went to arrest Moore for the violation and Moore attempted to pull away and flee the officer. Moore was quickly taken into custody. Moore was also found to be in possession of teargas. Moore was booked into county jail for resisting arrest, PRCS revocation, and felon in possession of teargas. 15-3151

On 10/26/15 at about 10:38 pm, UPD officers were dispatched to Ukiah Valley Medical Center ER, on a report of a violent subject assaulting staff. Upon arrival officers were directed to a subject named James Jones age 42, who was being restrained by hospital staff. The officers spoke with Jones in an attempt to calm him down. Jones refused and had to be physically restrained by UPD officers. Hospital staff told the officers that Jones'

behavior escalated over that past hour and he had to be physically restrained after he attempted to punch a security guard. A records check showed that Jones was on probation. Jones was taken into custody for violation of his probation and resisting arrest. Jones was booked into county jail on the violations. 15-3156

On 10/27/15 at about 6:18 pm, UPD officers were dispatched to Social Services on South State Street, in regards to numerous subjects hanging around the front of the business consuming alcohol. Upon arrival one of the subjects that officers contacted was identified as Sean Flinton age 35 from Fort Bragg. Flinton was holding a "Wild Turkey" whiskey bottle and when questioned thought he was in Fort Bragg California. Flinton displayed the extreme signs of alcohol intoxication and was found to be too intoxicated to care for his safety or that of others. Records check showed Flinton to be on probation with a "abstain from alcohol" clause. Also contacted was William Holt age 50 of Ukiah, who was sitting next to an almost empty bottle of liquor. Holt displayed the extreme signs of alcohol intoxication and was also found to be too intoxicated to care for his safety or that of others. Records showed that Holt was also on probation. Holt and Flinton were placed under arrest for violation of their probation and drunk in public. Both were booked into county jail. 15-3167
