On 10/29/15 at about 6:16 pm, UPD officers along with allied agencies were at 213 Tedford Ave., conducting a probation search of the residence. While at the residence officers contacted probationer Luis Barajas age 18 of Ukiah. Barajas was found to be in violation of the "No association with criminal street gang members" term on his probation and was placed under arrest. On 10/29/15 at about 8:10 pm, UPD officers contacted Steven Green age 28 of Ukiah in the 1100 block of Airport Park Blvd. Officers were aware that Steven Green had a misdemeanor warrant for his arrest out of Sonoma County and took him into custody without incident. Green was booked into county jail. 15-3187

On 10/29/15 at about 8:38 pm, UPD officers on active patrol observed three subjects near Grace Hudson School on South State Street, who they suspected might be involved in gang activity. The UPD officers contacted the three, one of which was identified as Javier Ramirez age 24 of Ukiah. Ramirez was found to be in possession of drug paraphernalia and had a large Machete knife with an 18"blade concealed on his person. Ramirez was taken into custody for having a concealed illegal weapon and possession of drug paraphernalia. Ramirez was booked into county jail. 15-3188

On 10/29/15 at about 10:07 pm, UPD officers responded to the railroad tracks on East Gobbi Street, regarding an intoxicated subject causing a disturbance. In the area officers contacted Charles Hensley age 51 of Ukiah. Hensley displayed the extreme signs of alcohol intoxication and was found to be too intoxicated to care for his safety or that of others. Hensley was placed under arrest for drunk in public and booked into county jail. 15-3190

On 10/30/15 at about 4:12 pm, a UPD officer was dispatched to a residence in the 100 block of Leslie Street regarding a theft. The victim reported that a subject he knew as Louie Vigil age 37 of Ukiah had been at his residence earlier and the victim believed that while at his residence Vigil had stolen a cellular phone from him. Records check showed Vigil to be on summary probation out of this county. Officers located Vigil in the 800 block of South State Street. Vigil denied the phone theft, but was found to be in possession of an illegal controlled substance and drug paraphernalia. Vigil was placed under arrest for the violations and violation of his probation. 15-3194

On 10/30/15 at about 6:12 pm, UPD officers were on active patrol when they contacted Jacob Garcia age 27 of Ukiah in the 1400 block of South State Street. Officers were aware that Garcia was on active Parole for a prior offence of assault with a deadly weapon. Garcia is subject to search and seizure per his parole, but refused to allow officers to complete a search of his phone. Garcia was placed under arrest and booked into county jail for violation of his Parole. 15-3196

On 10/30/15 at about 9:32 pm, UPD officers were on active patrol in the 200 block of Observatory Avenue, when then contacted Billy Rickman age 42 of Ukiah. Officers were aware that Rickman is on Post Community Release Supervision (PRCS). A records check showed that Rickman had a felony warrant out of Butte County, for a PRCS violation. Rickman was placed under arrest for the warrant and booked into county jail. 15-3201

On 10/30/15 at about 11:00 pm, UPD officers were dispatched to the Shell Gas Station on East Perkins Street, regarding a disturbance involving three male subjects who were possibly intoxicated. signs of alcohol intoxication and were found to be too intoxicated to care for their safety or that of others. Both were placed under arrest for drunk in public and booked into county jail. 15-3203

On 11/1/15 at about 1:53 am, a UPD officer on active patrol in the 500 block of East Perkins Street conducted an enforcement traffic stop on a white Toyota Corolla. The officer contacted the driver, who identified himself as Fermin Barrales-Gonzalez age 24 of Ukiah. As the officer spoke with Barrales-Gonzalez, he noticed that the driver displayed the objective signs of alcohol intoxication and began a DUI investigation. Barrales-Gonzalez was found to be too intoxicated to be operating a motor vehicle and was placed under arrest for DUI. Barrales-Gonzalez was booked into county jail. 15-3217

On 11/1/15 at about 4:54 pm, UPD officers were dispatched to the 600 block of North State Street on a report of an adult male subject walking in and out of traffic. Upon arrival officers contacted Adrian McWhinney age 60 of Ukiah. McWhinney appeared extremely intoxicated and was found to be too intoxicated to care for his safety or that of others. McWhinney was placed under arrest for drunk in public and booked into county jail. 15-3221

On 11/1/15 at about 10:36 pm, UPD officers were dispatched to FoodMax on Airport Park Blvd., on a report of a subject who was refused a purchase of alcohol due to his level of intoxication. The subject was reported to be sitting in a silver sedan parked in a handicap parking space. Upon arrival officers located the vehicle and contacted Wilfred Hiedinger age 78 sitting in the driver seat and Scott Heidinger age 55 sitting in the passenger seat. Wilfred displayed the objective signs of alcohol intoxication and it was determined that he had drove his car to FoodMax. Officers began a DUI investigation and Wilfred was found to be too intoxicated to be operating a motor vehicle. Wilfred was placed under arrest and charged with DUI. Officers found that Scott was extremely intoxicated and records check showed that Scott was on probation. Scott was arrested for drunk in public and VOP. Both Wilfred and Scott were booked into county jail. 15-3222

On 11/3/15 at about 11:08 pm, UPD officers were dispatched to the ER of Ukiah Valley Medical Center, on a report of Charles Hensley age 51 of Ukiah causing a disturbance. On 11-2-15 at approx. 6:00 PM, UPD officers were dispatched to contact a 17 year old female regarding an attempted kidnapping/sexual assault.

The victim reported she was running/jogging in the 200 block of S. Highland Ave. around 4:45 to 5:00 PM. The victim was grabbed from behind. The victim fought off the suspect and ran away.

No suspect vehicle was seen, nor his direction of travel after the assault. UPD Detectives were notified and have been actively investigating the incident.

On 11-3-15 at approx. 12:20 PM, UPD detectives located Angel Miller in the "pocket park" in the 300 block of E. Perkins St. The victim was brought to the location, where she identified Miller as the suspect. Miller was arrested for 220(a)(2) PC, and 664-207(a) PC. Miller was lodged at the county jail.
