The Patrol Division's average response time to in-progress calls was a little under 4 minutes. The average response time to all other calls was a little over 11 minutes.

### Highlights for the Week

On November 11<sup>th</sup> at about 7:09 pm, UPD units were dispatch to UVMC to investigate a disturbance. It was reported that William Vantreese age 49 was outside and throwing a bag he had been carrying against a set of glass doors of the hospital. Upon arrival officers contacted Vantreese and as they spoke with him realized that he displayed the objective signs of being under the influence of an illegal drug. After a drug evaluation, Vantreese was placed under arrest for being under the influence of a controlled substance and booked into county jail. 15-3327

On November 11<sup>th</sup> at about 11:52 pm, UPD officers were dispatched to an apartment in the 700 block of Waugh Lane, on a report of an unknown male subject knocking on the window of an apartment. Upon arrival officers contacted Gabriel Rojas age 18, who displayed the objective signs of being under the influence of alcohol and Marijuana. Rojas was found to be too intoxicated to care for his safety or that of others and was placed under arrest for being drunk in public. Rojas was booked into county jail. 15-3329

On November 12<sup>th</sup> at about 2:08 am, a UPD officer was on active patrol when he stopped a bicyclist on Scott Street for a traffic violation. The bicyclist identified himself as Cory Brandell age 24. A records check by UPD dispatch showed Brandell to be on probation with a search term. Brandell was found to have methamphetamine in his possession, along with hypodermic needles. Brandell was placed under arrest for possession of a controlled substance, possession of drug paraphernalia, and violation of his probation. Brandell was booked into county jail. 15-3330

On November 12<sup>th</sup> at about 8:30 pm, a UPD officer was on active patrol when he performed a traffic stop on a black Jeep Wrangler that was speeding in the 400 block of North State Street. The driver was identified as Alberto Villalobos age 25 of Ukiah. A records check through UPD dispatch showed that Villalobos was on probation and his license was suspended. Villalobos was placed under arrest for the violations. 15-3341

On November 12<sup>th</sup> at about 9:42 pm, a UPD officer contacted a male subject next to the Train Depot on East Perkins Street. The male subject was identified as Alberto Acosta age 28. A records check showed that Acosta had a felony warrant for his arrest and he was taken into custody without incident. Acosta was booked into county jail. 15-3343

On November 13th at about 1:28 am, a UPD officer was on active patrol, when he stopped a vehicle in the 200 block of W. Mill St. for a traffic violation. The officer contacted the driver, who was identified as Douglas Chadwick age 26. While speaking with Chadwick the officer noticed the objective signs of alcohol intoxication and began a DUI investigation. Chadwick was found to be too intoxicated to be operating a motor vehicle and was placed under arrest for DUI. 15-3344

On November 13<sup>th</sup> at about 6:58 pm, UPD officers were dispatched to Wal\*Mart for a report of an employee chasing a subject suspected of shoplifting. In the 800 block of Waugh Lane, a UPD officer observed a subject running that match the description of the suspect. The officer turned on his overhead emergency lights and the suspect immediately stopped running. The officer contacted the suspect, who identified himself as Nickolas Dunsing age 26. The officer asked Dunsing why he was running and he replied because he had just stolen a Mountain Dew soda from Wal\*Mart. Speaking with Wal\*Mart loss prevention the officer discovered that the theft included many other items and Dunsing was arrested. Dunsing was booked into county jail. 15-3350

On November 14<sup>th</sup> at about 12:48 am, a UPD officer was on active patrol when he stopped a green Kia Sportage on State Street for traffic violations. The driver was identified as Brian George age 31 from Hopland. As the officer spoke with George he noticed the objective signs of alcohol intoxication and began a DUI investigation.

George was found to be too intoxicated to be operating a motor vehicle and was placed under arrest for DUI. George was booked into county jail. 15-3352

On November 14<sup>th</sup> at about 8:58 pm, UPD officers were dispatched to the 100 block of Cherry Street, for a report of a subject with no shirt on walking into traffic. Officers contacted Wayne Campbell age 42, who was found to be on probation out of this county. Campbell displayed the extreme signs of alcohol intoxication and was found to be too intoxicated to care for his safety or that of others. Campbell was placed under arrest for drunk in public and booked into county jail. 15-3357

On November 16<sup>th</sup> at about 2:18 pm, a UPD officer stopped a vehicle on Tedford Avenue for a traffic violation. The driver was identified as Lorenzo Martinez age 32. A records check showed that Martinez had two felony warrants for his arrest and he was taken into custody without incident. Martinez was booked into county jail. 15-3380

### Press Release UPD case 15-3383

On November 16th at about 2357 hours, a UPD Officer was on active patrol at the south end of Airport Park Blvd. and performed a traffic stop on a red 1998 Toyota Corolla for a traffic violation. As the vehicle stopped near Ken Fowler Auto Center, the Officer was advised the Toyota Corolla was stolen out of Pacific Grove California. The Officer performed a felony high risk traffic stop on the vehicle and called for additional UPD units to respond and assist.

The driver of the vehicle later identified as Sharren Flora, age 32 would not comply with officers demands to exit the stolen vehicle. A passenger from the vehicle, identified as Dwayne McKenzie age 43, exited the vehicle and Flora drove off with UPD units in pursuit. McKenzie was taken into custody without incident. McKenzie was on probation and found to be in possession of a controlled substance and drug paraphernalia.

Flora led UPD units on a high speed pursuit that went from the City of Ukiah onto US 101 southbound, where speeds reached in excess of 100 MPH. UPD requested assistance from CHP and Cloverdale PD. Near Cloverdale, CHP deployed a spike strip on the stole vehicle, which flattened all four tires. Flora exited the vehicle but refused to comply with Officer's commands and a Taser was deployed to subdue her. Flora was taken into custody for vehicle theft, reckless evading, possession of stolen property and driving on a suspended license. Both Flora and McKenzie were booked into Mendocino County jail on the above listed charges.

##### **Be Aware of Fraudulent Automated Phone Calls and Emails**

Savings Bank has received numerous reports from people with 707 area code phone numbers who are receiving fraudulent automated phone calls and emails indicating their bank card has been blocked. It appears these calls are not targeting any specific financial institution.

It is important, if you receive one of these calls or emails, do not provide any personal or card information. If you have received an automated phone call or email and have provided personal or card information, please contact Savings Bank or your financial institution right away.

Savings Bank wants our customers to know that the Bank does not make automated phone calls and will not call customers to activate their debit cards or to ask for account or card information. The Bank will call customers if there is unusual activity and it is suspected to be fraud. In this case, the calls are made in person, not automated.

At Savings Bank, account security is a top priority and we remain committed as ever to protect your personal and financial information and privacy.
