On February 4th at about 10 pm, a UPD officer on active patrol stopped a grey Honda in the 1300 block of South State Street for traffic violations. The driver was identified as Jaime Hernandez age 34 from Ukiah. As the officer spoke with Hernandez, he appeared to be under the influence of drugs. The officer then began a DUI investigation. A records check revealed that Hernandez's license was suspended. Hernandez was found to be in possession of an illegal controlled substance and drug paraphernalia. Hernandez was placed under arrest for DUI, possession of an illegal controlled substance, drug paraphernalia and driving suspended. Hernandez was booked into county jail for the violations. 16-0338

On February 5th at about 12:45 am, UPD officers were dispatched to the Kwik Pik Market, 795 East Perkins Street, regarding a burglary alarm. Upon arrival an officer found a glass door smashed, and two large rocks on the floor just inside the door. Officer Snyder deployed his K9 partner "Rex" to conduct a search for any possible suspect(s). No one was located inside the business and it was determined that the suspect(s) fled prior to officers arrival. 16-0339

On February 5th at about 7 am, UPD officers were dispatched to Video Tapa Musica, 249 North Orchard Avenue, regarding a burglary alarm. Upon arrival officers noticed the entrance/exit door was broken. Officers searched the business for any possible suspect, but no one was located. Officers noticed that cash register was opened and an empty cash tray was on the floor. This case is still under investigation. 16-0340

On February 5th at about 10:30 am, UPD SET team along with UPD officers responded to Best Western Inn on South Orchard Ave., on a tip that Idaho fugitive Kim Sanch age 34 was staying at this motel. The information had been provided to UPD from the US Marshall Service. Sanch was located and taken into custody without incident and booked into county jail. 16-0344

On February 5th at about 11:30 am, a UPD officer on active patrol stopped a 2015 Mercedes sedan in the 200 block of East Gobbi Street for traffic violations. The driver was identified as Michel Rico Martino age 24 out of Ukiah. While conducting a route records checks, UPD dispatch advised that the vehicle Martino was drive was reported stolen out of San Jose. Other officers arrived and Martino was taken into custody without incident. Martino was found to be on probation out of this county and was booked into county jail for possession of a stolen vehicle and violation of his probation. 16-0345

On February 6th at about 6:38 am, UPD officers were dispatched to a residence in the 800 block of Mohawk Drive, regarding a home invasion robbery that had just occurred. Officers spoke with the victims, a 77 year old female and an 80 year old male. During the investigation Officers learned that 2 to 3 male subjects entered the residence through a back sliding glass door and tied up the two elderly residents. The male was placed face

down on the kitchen floor and the female on a couch. The suspects disabled all the phones in the residence and after conducting a search of it, one of the suspects indicated that they were at the wrong residence. The suspects untied the victims and left.

The suspects were described as white males, one possibly Hispanic, in their late 20's early 30's. All were wearing hats and clothing that covered the lower portion of their faces. The suspects were associated with a dark colored car that had been parked in front of the residence with its lights on and engine running, during the robbery.

Press Release UPD case #16-0363

On February 7th at about 8:11 am, UPD officers were dispatched to 504 Park Blvd. (Anton Stadium) for a report of an occupied suspicious vehicle. Upon arrival officers found the vehicle and contacted the driver identified as Jeremy Auman age 31 from Laytonville and the passenger, identified as Evangeline Martinez age 27 from Willits. During the investigation officers found that Auman and Martinez were in possession of suspected methamphetamine, Oxycodone and drug paraphernalia. Inside the vehicle was a loaded unregistered 9mm handgun, which was linked to Auman. Auman was placed under arrest for possession of an unlawfully obtained firearm, possession of an illegal controlled substance and possession of drug paraphernalia. Martinez was placed under arrest for possession of a controlled substance and drug paraphernalia. Both were booked into the county jail.

While en-route, dispatched informed responding officers that the victim was following the suspect and both were now located in the 1000 block of South Dora Street. As the officer was speaking with Gonzalez-Alvarez he noticed that the driver appeared to be intoxicated, so he began a DUI investigation. Brandell was found to be in possession of suspected methamphetamine and drug paraphernalia. Brandell was placed under arrest for being under the influence of a controlled substance, possession of a controlled substance, possession of drug paraphernalia and violation of his probation. On February 8th at about 8:30 am, UPD was notified of vandalism. It was reported that sometime between February 6th at 4pm and February 7th at noon, an unknown subject(s) spray painted gang graffiti on a residence in the 800 block of Maple Avenue. 16-0372

On February 9th at about 3 am, UPD officers were dispatched to the 400 block of McPeak Street, for a reported vehicle collision. On scene officers found two vehicles in the roadway and contacted both drivers. One of the drivers was identified as Jody Angel age 22. While speaking with Angel regarding the collision, the officer suspected she was intoxicated and began a DUI investigation. Angel was placed under arrest for DUI and booked in county jail. 16-0384

On February 9th at about 8:40 am, a UPD officer was contacted by a social worker with Mendocino Youth Project. The officer was informed that a female juvenile was possibly followed by an adult yesterday morning. The UPD officer began an investigation and contacted the juvenile, who reported that on February 8th at about 7 am, she was walking through the Shell gas station on South Orchard Avenue, when she noticed a man in a pickup truck following her. The victim first ignored the subject and walked towards East Perkins Street. For the next 30 minutes, the victim walked to different locations on East Perkins Street in an attempt to avoid the subject. During this time the subject got close enough to the juvenile victim, to make inappropriate commits and gestures toward her. The victim last saw the pickup on East Perkins at Main Street.

The suspect was described as a chubby Hispanic male in his 30's, with a mustache, wearing a grey hat and a blue hoodie type sweatshirt. The vehicle was a faded red, two door Chevrolet pickup truck, with the word "Chevrolet" written on the tailgate, over a silver stripe.

While we continue to investigate this incident and the previous incidents involving school children traveling to and from school, it is important to note that we are not sure these incidents are connected. Parents should spend time talking with their children about these safety tips:

1. Do not talk to strangers.
2. Be aware of your surroundings (example: Don't focus your attention on your cell phone while walking home from school. Walk with your head up, looking at your surroundings).
3. Stick together. There is safety in numbers.
4. Practice basic self – defense. A swift kick to the shins or private parts along with a loud scream will help get the attention of people in the area.
5. If you're at home alone – lock your doors.
6. If something happens to you report it immediately!

Press Release **UPD case #16-0397**

On January 10th at about 5:45 am, UPD officers were dispatched to a residence in the 1300 block of Rose Avenue, on a report that a resident had a male subject held at gunpoint. Officers responded and detained Oscar Alvarez Carrillo age 27 of Ukiah. During the investigation officers discovered that Carrillo had climbed over a fence and opened the victim's backdoor. The alert owner contacted the intruder, gave him verbal commands and held him at gun point until officers arrived. Carrillo was found to be under the influence of a controlled substance and had two outstanding misdemeanor warrants for his arrest. Carrillo was placed under arrest for prowling, being under the influence of illegal drugs and for the outstanding warrants. Carrillo had somehow cut his hand prior to police contact and was medically cleared, before he was booked into county jail.
