The Patrol Division's average response time to in-progress calls were a little under 4 minutes. The average response time to all other calls was a little under 10 minutes.

Highlights for the Week

On February 10th at about 3:15 pm, a UPD officer was dispatched to Burger King on East Perkins Street, for a welfare check on a male subject asleep in the parking lot. Upon arrival the officer contacted David Kroll age 39, known to local law enforcement. As the officer spoke with Kroll he appeared extremely intoxicated and an alcohol breath test showed .30% BAC, which is extremely high. A records check revealed that Kroll had an

active misdemeanor warrant for his arrest. Kroll was arrested for being drunk in public and for his warrant. Kroll was booked into county jail. 16-0407

On February 10th at about 8:35 pm, a UPD officer on active patrol stopped a bicyclist in the 700 block of South State Street for a traffic violation. The bicyclist was identified as Joshua Guevara age 22. A records check of Guevara revealed that he was on probation. Guevara was found to be in possession of an illegal knife and was placed under arrest for violation of his probation and possession of a concealed dirk / dagger. Guevara was booked into county jail. 16-0411

On February 11th at about 1 am, a UPD officer was dispatched to Safeway on South State Street, to investigation a suspicious person. Upon arrival the officer contacted Mathew Gardiner age 27. Gardiner appeared to be under the influence of drugs and a records check reviewed that he was on probation. Gardiner was found to be in possession of suspected methamphetamine. Gardiner was placed under arrest for being under the influence of a controlled substance, possession of a controlled substance and violation of his probation. Gardiner was booked into county jail. 16-0413

On February 11th at about 4 am, a UPD officer was dispatched to the Hampton Inn on Airport Park Blvd., on a report of an intoxicated male subject causing a disturbance. Upon arrival the officer contacted Shannon River age 37 of Willits and spoke with him about his behavior. River was found to be intoxicated and placed under arrest for being drunk in public. River was booked into county jail. 16-0414

Press Release Traffic Collision North Oak Street UPD case #16-0415

On February 11th at about 9:30 am, UPD Officers responded code 3 to North Oak Street at Gibson Street, for a report of a rollover traffic accident with a subject trapped inside. Upon arrival officers found a 2009 Ford Sedan resting on its top, blocking both north and southbound lanes of traffic. Alert Ukiah citizens were on scene and directing traffic away from the accident. Ukiah Fire Department personnel and an ambulance service arrived to deal with the driver, who was still inside of the vehicle. The driver was able to self-extricate herself from the overturned vehicle and was transported to Ukiah Valley Medical Center for her injuries. During the investigations officers determined that Guadalupe Magdaleno-Rankel age 39 of Ukiah was traveling southbound on North Oak Street. Guadalupe told officers she felt faint and went to pull over when the collision occurred. Evidence showed that Guadalupe had turned her vehicle and collided with a legally parked unoccupied City of Ukiah vehicle. The impact of the collision pushed the City of Ukiah vehicle approximately 15' forward. Both vehicles sustained major to total damage and had to be towed from the scene. A records check revealed that Guadalupe was driving without a valid drivers' license and she was cited for the violation.

On February 11th at about 2:00 pm, UPD officers were out looking for warrant suspect Beau Benjamin, who had a Felony warrant for his arrest. Officers were at the Sunrise Inn on South State Street, when an alert UPD officer saw Benjamin jumping a fence from the motel, to the parking lot of Rite Aid. Officers gave chase and Benjamin was caught in the 700 block of South Oak Street. Benjamin was taken into custody. 16-0419

On February 11th at about 9:30 pm, a UPD officer on active patrol stopped a U Haul truck in the 500 block of East Perkins Street for a traffic violation. The driver was identified as Garrett Travis age 36. As the officer spoke with Travis he appeared intoxicated, so the officer began a DUI investigation. Garrett was placed under arrest for DUI and booked into county jail. 16-0422

On February 12th at about 12 pm, a UPD officer was dispatched to a residence in the 600 block of Myron Street, to check on the welfare of a juvenile. During this call for service UPD officers contacted Lorenzo Martinez age 32, who was known to have a parole warrant. Martinez was taken into custody without incident and booked into county jail. 16-0429

On February 12th at about 4 pm, a UPD officer on active patrol in the 800 block of South Oak Street, observed a subject he recognized as Dwayne Mckenzie age 43 from Ukiah. The officer was aware that Mckenzie had an active warrant for his arrest and contacted him. Mckenzie was on probation and was found to be in possession of suspected methamphetamine and drug paraphernalia. Mckenzie was booked, cited and released for his warrant, violation of his probation and additional drug offences. 16-0430

On February 12th at about 9:30 pm, a UPD officer on active patrol stopped a red Toyota Tacoma pickup in the 100 block of Warren Drive for a traffic violation. As the officer spoke with the driver who was identified as Christopher Land age 42 from Ukiah, he suspected that Land was intoxicated so he began a DUI investigation. Land was placed under arrest for DUI and later booked, cited and released on a citation to appear. 16-0432

On February 13th at about 2:30 am, a UPD officer on active patrol in the 400 block of East Perkins Street, noticed a male subject walking in the center of the roadway. The officer contacted the subject and asked him if everything was ok. The male subject identified himself as Timothy Fisher age 49 from Fort Bragg and began to tell the officer how he "Praises Hitler". A records check revealed that Fisher had three misdemeanor warrants from Sonoma County. Fisher was placed under arrest for the warrants and booked into county jail. 16-0437

On February 14th at about 3:45 am, a UPD officer was dispatched to a residence in the 300 block of Leslie Street, for a report of a male subject causing a disturbance. The officer contacted Christopher Adam Lopez age 26, who is known to law enforcement. Lopez was found to be extremely intoxicated and placed under arrest for being drunk in public. Lopez was booked into county jail. 16-0443

On February 14th at about 3:30 pm, UPD officers were dispatched to Vinewood Park in the 1200 block of Elm Street, for a report of an intoxicated male subject. Officers contacted Jesus Herrera age 33 from Ukiah, who was lying on the ground halfway under a park picnic table. Herrera was found to be extremely intoxicated and placed under arrest for being drunk in public, then booked into county jail. 16-0448

On February 14th at about 9:15 pm, a UPD patrol officer attempted to contact probationer Robert Berg in the 500 block of North State Street, as he was suspected of being under the influence of a controlled substance. Berg fled from the officer on foot and the officer pursued him. Berg was caught in the 600 block of North State Street and was placed under arrest for being under the influence of a controlled substance, resisting an officer, and violation of his probation. Berg was booked into county jail. 16-0449

On February 15th at about 10:20 am, a UPD officer on active patrol in the 600 block of South State Street, observed a male subject who he recognized from prior law enforcement contacts as Mark Brandt, age 49. The officer was aware that Brant had a felony warrant for his arrest out of Placer County, where the bail was set at \$120,000. Brandt was contacted and placed under arrest, then booked into county jail. 16-0451

Press Release Wal-Mart Embezzlement UPD case #16-0452

On February 15th at about 12:45 pm, UPD Officers were dispatched to Wal-Mart regarding an employee who was suspected of embezzlement. Officers learned Wal-Mart's Asset Protection Team had conducted an internal investigation and had evidence that showed employee Donna Arriaga age 58 from Ukiah, had embezzled in excess of \$6,000, since late January 2016. Officers placed Arriaga under arrest for felony embezzlement and grand theft. Arriaga had in excess of \$4000 cash in her possession at the time of her arrest. UPD Detectives were called out and assisted with the subsequent investigation. Detectives obtained information that Arriaga had purchased numerous items with the money she stole from Wal-Mart, which led to a local motel room in the 600 block of South Orchard Ave., where she had been staying. Some items that were purchased with the stolen funds were located in this motel room and recovered. While at the motel room Officers and Detectives contacted Raymond Snyder Jr. age 48 from Lake County. A records check revealed that Snyder had two local warrants and a Lake County warrant for his arrest. Snyder was arrested for the warrants and was additionally found to be in possession of a controlled substance. Snyder was booked into county jail and Arriaga was booked and released.

The officer contacted the driver and passenger of the vehicle. The passenger was identified as Douglas Kenyon age 49.
