### **Highlights for the Week**

On March 16<sup>th</sup> at about 9:30 am, a UPD officer on patrol observed a subject he recognized as Juan Carols Lopez age 27, in the 300 block of Empire Drive. The officer was aware that Lopez had an active Felony warrant for his arrest. The officer observed Lopez enter a residence in the 300 block of Empire Drive and once another UPD officer arrived, they made contact with the residents. On March 16<sup>th</sup> at about 4:30 pm, a UPD officer was dispatched to Perkowski's on North State Street, regarding a male subject causing a disturbance. The described subject was located and contacted by the officer. The subject was identified as Danny Ray age 51 from Ukiah, and was holding an open 24oz container of beer. Ray was found to be intoxicated and was placed under arrest for being drunk in public. Ray was booked into county jail. 16-0765

On March 17<sup>th</sup> at about 1 pm, UPD officers were dispatched to Wal-Mart, regarding a combative shoplifter. UPD dispatch advised that the detained suspect was threatening to assault employees. Officers contacted a subject they knew as Abel Aguado age 31, being detained by Wal-Mart loss prevention. A records check revealed that Aguado was on probation out of this county for prior thefts. During the investigation officers learned that Aguado concealed numerous store items inside of his backpack, then exited the store without paying for the items. Aguado was contacted outside by Wal-Mart loss prevention employees. Aguado had to be physically restrained and made threatening statements toward employees. Aguado was placed under arrest for shoplifting and violation of his probation. Aguado was booked into county jail. 16-0771

On March 17<sup>th</sup> at about 4:20 pm, a UPD officer was dispatched to Kohl's on North Orchard Avenue, for a report of a shoplifter in custody. Upon arrival the officer contacted Yaneth Sandoval Reyes age 23 from Ukiah, who was being detained by Loss Prevention. During the investigation the officer learned that Reyes was inside the store and was observed selecting two pairs of shorts. Reyes concealed the shorts in her purse then exited the store without paying for them. Reyes was then detained by Loss Prevention. A records check revealed that Reyes was on summary probation out of this county. Reyes was cited and provided a court appearance dated for shoplifting and violation of her probation. 16-0775

On March 17<sup>th</sup> at about 4:30 pm, UPD officers were dispatched to a residence on Cherry Court, regarding a domestic dispute. Officers contacted an adult female standing outside of the residence upset and crying. The adult female subject reported that she and her live in boyfriend Adrian Ramirez age 48 from Ukiah, were involved in a verbal argument. During the argument Ramirez pushed her, causing minor visible injuries to the victim. Ramirez was located, interviewed and arrested for the domestic assault. Ramirez was booked into county jail. 16-0776

On March 17<sup>th</sup> at about 9:15 pm, a UPD officer was dispatched to the 200 block of Mason Street, for a report of a man down on the shoulder of the roadway. Upon arrival the officer contacted Steven Vondohlen age 27, who was identified with his US passport. Vondohlen was found to be very intoxicated and placed under arrest for being drunk in public. Vondohlen was booked into county jail. 16-0778

On March 18<sup>th</sup> at about 2:10 am, a UPD officer on patrol stopped a blue Ford Escort in the 100 block of Evans Street for a traffic violation. The driver was identified as Robert Fackrell age 29 from Ukiah. A records check revealed that Fackrell had 4 misdemeanor warrants for his arrest and he was taken into custody. Fackrell was booked into county jail. 16-0780

On March 18<sup>th</sup> at about 9:35 am, a UPD officer was dispatched to Walgreens for a reported physical fight between two males. As the officer was responding, UPD dispatch advised both parties had separated and one of the suspects was walking northbound near the railroad tracks, with his shirt off. Upon arrival the officer contacted Adam Pearson age 34 from Ukiah. Pearson was carrying an open 24oz. can of Mango-Rita alcohol. A records check revealed that Pearson was on probation with a "No alcohol" clause. Pearson was placed under arrest for violation of his probation and booked into county jail. 16-0782

On March 18<sup>th</sup> at about 1:15 pm, a UPD officer was dispatched to Supercuts on North Orchard Avenue, for a report of a male subject sleeping on the south side of the business and refusing to leave. Upon arrival the officer contacted Michael Donahue age 61, who was known to law enforcement from many prior contacts. A records check revealed that Donahue was on probation and had a warrant for his arrest. Donahue was found to be extremely intoxicated and was placed under arrest for being drunk in public, violation of his probation and a warrant. Donahue was booked into county jail. 16-0784

On March 18<sup>th</sup> at about 5:45 pm, UPD officers were dispatched to Quest Mart on North State Street, for a report of a male subject causing a disturbance. Upon arrival officers contacted Danny Ray age 51. Ray was yelling gibberish, threw his bicycle on the ground and started kicking it. Ray appeared intoxicated and the officer noticed a 24oz bottle of "Hurricane" alcohol on the ground, near where Ray had been standing. Ray was extremely agitated and was detained by officers. A records check revealed that Ray was on probation. Ray was placed under arrest for violation of probation and public intoxication. Ray was booked into county jail. 16-0787

On March 18<sup>th</sup> at about 6:45 pm, a UPD officer was dispatched to a residence in the 300 block of Cooper Lane, regarding a vehicle theft. Upon arrival the officer spoke with the victim, who reported that on March 17<sup>th</sup> at about 11 am, he left town. At this time his tan 1991 Honda Accord sedan Cal license 3VVJ998 was parked in the driveway of his residence. On March 18<sup>th</sup> at about 6 pm, the victim returned home and found that his vehicle was gone. The victim was unable to provide any suspect information. 16-0788

On March 18<sup>th</sup> at about 7:35 pm, a UPD officer was dispatched to UPS on Cherry Street, regarding a package containing marijuana. While en-route the officers were advised that the involved subjects had fled the area on foot. Upon arrival officers observed a subject running westbound through the parking lot of the Regal 6 Cinemas and jump over a fence into the parking lot of the Sunrise Inn. Officers contacted the subject, who was identified as Francisco Gonzalez age 26 from Rohnert Park. A records check revealed that Gonzalez had an active felony warrant and he was arrested. On March 19<sup>th</sup> at about 8 am, a UPD officer was dispatched to Shady Grove Mobile Home Park on South State Street, for a possible vandalism. The park manager reported that a subject named David Chavez, dug out a metal bumper pole from the asphalt road on the property, causing damage. The park manager then followed Chavez back to his residence in the mobile home park. Chavez was contacted and a statement was obtained. A records check revealed that Chavez was on probation. Chavez was placed under arrest for vandalism and violation of his probation. 16-0798

On March 20<sup>th</sup> at about 12:30 am, a UPD officer was dispatched to the Perkins Street Bar, regarding a subject being detained. Upon arrival officers were advised by the bars manager that the detained subject had removed a fire

The officer identified the subject as Jonathan James Tims age 22, who would not explain to the officer why he had discharged a fire extinguisher inside the bar. Tims was found to be intoxicated and was placed under arrest for public intoxication. Tims was booked into county jail. 16-0805

On March 20<sup>th</sup> at about 10:08 pm, a UPD officer was dispatched to a residence in the 600 block of North Orchard Avenue, regarding a vehicle theft. The victim reported that on March 19<sup>th</sup> at about 2 pm, she parked her silver 2015 Toyota Camry California License 7MXX585 in the parking lot of her apartment complex. On March 20<sup>th</sup> at about 6 pm, she discovered that her vehicle was missing. The victim was unable to provide any suspect information. 16-0810

On March 20<sup>th</sup> at about 11:20 pm, a UPD officer performed a traffic stop on a black Dodge Ram pickup on Garrett Drive, for traffic violations. The driver was identified as Anne Hash age 43 from Ukiah, who told the officer she did not have a valid driver's license. A records check revealed that Hash's license was suspended.
