Highlights for the Week

On March 23 at about 2:48 pm, a UPD officer was dispatched to the 100 block of Ford Street, regarding a male subject causing a disturbance. Upon arrival the officer contacted Rodney Belvins age 54. Belvins was found to be extremely intoxicated and placed under arrest for being drunk in public. Belvins was booked into county jail. 16-0840

On March 23 at about 10:54 pm, a UPD officer was on patrol in the 200 block of South State Street, security checking local businesses in the area, when he observed Charlene Martinez age 35 and Delbert Alford age 28. The officer was aware that Alford was on Parole and Martinez had a warrant for his arrest. Martinez was placed under arrest for her warrant and during that arrest was found to have suspected methamphetamine in her possession and drug paraphernalia. Martinez was booked into county jail on the violations. 16-0843

On March 24th at about 10:06 am, a UPD officer on patrol in the 400 block of Talmage Road, observed a subject he recognized as Austin Waters age 19. The officer was aware that Waters had an active misdemeanor warrant for his arrest and contacted him. Waters was placed under arrest and booked into county jail. 16-0847

On March 24th at about 6:35 pm, a UPD officer was dispatched to the Ukiah Skate Park on Low Gap Road, regarding a male subject harassing and threatening children. Upon arrival the officer was directed to the male subject, who was identified as Danny Lee Ray age 51. Ray was extremely intoxicated and a records check revealed that he was on probation. Ray was placed under arrest for being drunk in public and violation of his probation. Ray was booked into county jail. 16-0852

On March 25th at about 12:12 am, a UPD officer on patrol observed a MCSO Deputy conducting a traffic stop in the 700 block of South State Street and assisted him. The driver of the vehicle was identified as Timothy Navarro age 33 from Lake County. Navarro was suspected of being intoxicated and the officer began a DUI investigation. Navarro was placed under arrest for DUI and during a search was found to have a switch blade type knife on his person. Navarro was booked into county jail for DUI and possession of a switch blade knife. 16-0853

On March 25th at about 1:30 pm, a UPD doubled patrol unit was on patrol, when it stopped a silver Chevrolet Malibu in the 400 block of North State Street for traffic violations. The driver was identified as Mayra Zamorano age 27 from Ukiah. As the officers spoke with Zamorano she appeared intoxicated, so they began a DUI investigation. Zamorano was placed under arrest for DUI and booked into county jail. 16-0854

On March 25th at about 4:14 pm, UPD officers were dispatched to the 400 block of North State for a possible burglary. While en-route officers were told that a witness was following the suspect. Officers located the suspect in the parking lot of Black Oak Coffee Shop and detained him. The suspect was identified as Mark Burleigh age 31. During the investigation officers learned that the witness resides on Clara Avenue and his residence backs up to a residence on Norton Street. The witness reported seeing Burleigh in the backyard of the Norton Street residence. The witness knows the owner of the residence and was aware the owner was not home. The witness observed Burleigh attempting to gain entry into this residence, so he called police. Burleigh was placed under arrest for prowling and booked into county jail. 16-0858

On March 25th at about 9:32 pm, a UPD officer on patrol stopped a bicyclist on Leslie Street for a traffic violation. The rider identified himself as Danny Oresco age 50 of Ukiah. Oresco was found to be in possession of suspected methamphetamine and drug paraphernalia. Oresco was placed under arrest for the violations and later booked, cited and released with a court appearance date. 16-0860

On March 26th at about 4:08 am, a UPD officer on patrol stopped a vehicle in the 400 block of South State Street for traffic violations. The driver was identified as Randy Pike age 25 and a records check revealed that Pike's license was suspended and he was on felony probation, for a prior assault with a deadly weapon charge. A search of Pike's vehicle revealed that he had ammunition, drug paraphernalia, and over 5 lbs. of marijuana. Pike was placed under arrest for violation of his probation, felon in possession of ammunition, possession of drug paraphernalia, driving on a suspended license and possession of more than an oz. of Marijuana. Pike was booked into county jail on the charges. 16-0861

On March 26th at about 2:03 am, a doubled UPD patrol unit stopped at red Hyundai Elantra in the 1200 block of Vichy Springs Road, for traffic violations. The driver was identified as Dennis McMahan age 32. As the officer spoke with McMahan the officer noticed McMahan appeared intoxicated and began a DUI investigation. McMahan was placed under arrest for DUI and later booked, cited and released with a court appearance date. 16-0864

On March 26th at about 4:52 am, a UPD officer was dispatched to a residence in the 700 block of Cindee Drive, regarding a burglary report. The victim reported to the officer that she and her family went to bed on March 25th at around 10:30 pm. On March 26th at about 4:30 am the victim woke up and noticed her rear sliding glass door was left ajar. The victim checked her residence and found that her purse, a Samsung Galaxy Note smartphone, a Google Chrome-book, and other miscellaneous items were missing. The victim had no idea who committed the burglary. 16-0865

On March 26th at about 10:38 am, a UPD officer was dispatched to Wal-Mart, regarding a shoplifting that had occurred. The officer contacted Asset Prevention employees, who had Joshua Guevara age 22 detained for shoplifting. It was reported that Guevara selected items from the store, put them in a Wal-Mart shopping bag and exited, making no attempt to pay for them. A records check revealed that Guevara was on probation. Guevara was placed under arrest for shoplifting and violation of his probation. Guevara was booked into county jail on the violations. 16-0867

On March 26th at about 3:54 pm, a UPD officer was dispatched to Ukiah Skate Park regarding subjects consuming alcohol in public. Upon arrival an officer observed a subject identified as Kati Sistonen age 34 from San Francisco, drinking a 12oz. Corona beer. Sistonen was found to be extremely intoxicated and was placed under arrest for being drunk in public. Sistonen was booked into county jail. 16-0869

On March 26th at about 3:45 pm, a UPD officer was dispatched to the MTA bus stop, located in the JC Penny parking lot, for a report of a subject out and a female drinking from an open alcohol container. Upon arrival the officer contacted William Vantreesse age 45 and Rebecca Stiles age 59, both known to the officer from prior contacts. Vantreesse appeared to be passed out and a records check revealed he was on probation. Both subjects were found to be extremely intoxicated. Vantreesse was placed under arrest for being drunk in public and violation of his probation, and Stiles for being drunk in public. Both subjects were booked into county jail. 16-0870

Press Release / Motorcycle Pursuit UPD case #16-0877

On March 27th at about 1:30 pm, a UPD officer observed a yellow motorcycle traveling northbound in the 700 block of South State Street at approximately 65 MPH. When the officer attempted to initiate an enforcement stop on the speeding motorcyclist, the rider refused to stop. The rider instead sped up and led the officer on a high speed pursuit throughout the City of Ukiah. During the pursuit the motorcyclist failed to stop for posted stop signs, ran a red light and at times drove into oncoming traffic, attempting to evade the officer. The pursuit ended as the rider attempted to turn into a dirt lot near Talmage Road and Babcock Lane. During this turn the rider lost control of the motorcycle, fell to the ground and was taken into custody by UPD officers. The rider was identified as Manuel Luis Ayala-Rodriguez age 19 of Ukiah. A records check revealed that Ayala-Rodriguez was on felony probation and did not have a license. Ayala-Rodriguez was taken into custody for felony evading a police officer, violation of his probation and driving without a license. Ayala-Rodriguez received some abrasions from wrecking the motorcycle, so he was transported to UVMC and treated for his injuries. Ayala-Rodriguez was then booked into county jail on the above listed charges.

On March 27th at about 5:52 pm, a UPD officer on patrol in the 300 block of E. Gobbi Street, observed a subject he knew as Ashley Svendsen age 30. The officer was aware that Svendsen had an active misdemeanor warrant for her arrest for violation of her probation. The officer contacted Svendsen and placed her under arrest without incident. Svendsen was booked into county jail. 16-0881

On March 27th at about 7:36 pm, a UPD officer was dispatched to Mary Lane, regarding a vehicle driving reckless in the area and was stuck in a ditch. Upon arrival the officer contacted the driver who was identified as Homero Carmen age 23 from Ukiah. Carmen's vehicle was found partially off the roadway and in a small ditch. As the officer spoke with Carmen about the incident, he suspected Carmen was intoxicated and began a DUI investigation. Carmen was placed under arrest for DUI and booked into county jail. 16-0883

On March 28th at about 3:37 pm, a UPD officer was dispatched to Wal-Mart regarding a male subject requesting to turn himself in. The male subject was identified as Ronald Abad age 30 from Santa Rosa and UPD dispatch advised that he was wanted on felony theft charges out of Sonoma County. Upon arrival Abad was taken into custody without incident and later met with a Sonoma County Deputy, who took custody of him. 16-0900
