### Highlights for the Week

On March 31<sup>st</sup> at about 10:46 pm, a UPD officer on patrol stopped a green Toyota Avalon in the 600 block of South State Street, for traffic violations. The officer contacted the driver, who was identified as Joseph Hoaglen age 33. The officer recognized a passenger inside the vehicle as Eric Lincoln age 54. A records check revealed that Hoaglen's license was suspended and Lincoln had a misdemeanor warrant for his arrest. Hoaglen was cited for driving on a suspended license and Lincoln was placed under arrest for the warrant and booked into county jail. 16-0937

On March 31<sup>st</sup> at about 11:19 pm, a UPD officer was dispatched to a residence in the 200 block of Brush Street, for a report of Michael Wiles being unwanted at the location. Upon arrival a witness advised the officer that Wiles was highly intoxicated and was last seen walking westbound on Brush Street. The officer located Wiles who was found to be intoxicated. A records check revealed that Wiles was on parole and was prohibited from consuming alcohol. Wiles was placed under arrest for being drunk in public and violation of his parole. Wiles was booked into county jail for the violations. 16-0938

On April 1<sup>st</sup> at about 1:39 pm, a UPD officer was dispatched to Wal-Mart for a report of an intoxicated female subject. It was reported that the intoxicated female was belligerent and trying to fight citizens in the parking lot. The officer contacted a subject named Erin Blackwell age 45, who was recognized from prior contacts. Blackwell appeared extremely intoxicated, was placed under arrest for being drunk in public and booked into county jail. 16-0944

On April 1<sup>st</sup> at about 3:31 pm, a UPD officer was dispatched to the Quality Inn on South State Street, regarding a subject possibly under the influence of drugs. Dispatch advised that the suspect was a truck driver delivery man and was in the process of delivering a load to the Motel. Upon arrival a witness flagged down the officer and told him that "The driver is twacked out of his mind". "Twack" is a slang term which can refer to being under the influence of an illegal controlled substance. The officer contacted David Patin age 46 and evaluated him for being under the influence of illegal drugs. Patin was placed under arrest for being under the influence of a controlled substances and booked into county jail. 16-0945

On April 1<sup>st</sup> at about 10:47 pm, UPD officers were dispatched to the parking lot of MCSO regarding a report of a subject brandishing a knife. A subject known as Armando Llamas age 21, was located holding a large fixed blade knife in his right hand. Officers held Llamas at gunpoint, giving him verbal orders to drop the knife, which he eventually did. Llamas was detained in handcuffs. During the investigation Llamas was found to be extremely intoxicated. A records check revealed that he was on probation with an abstention from alcohol clause and he had an active misdemeanor warrant for his arrest. Llamas was taken into custody for being drunk in public, for violating his probation and for his warrant. Llamas was booked into county jail. 16-0949

On April 2<sup>nd</sup> at about 1:52 am, a UPD officer on patrol stopped a red Mercury sedan in the 200 block of East Standley Street for traffic violations. As the officer approached the vehicle, the driver began yelling obscenities out of the window, accusing the officer of ruining his life. After a second officer arrived to assist, the yelling driver exited the vehicle. The driver was identified as Miguel Guevara age 35. A records check revealed that Guevara is on probation and his driver's license was suspended. Guevara was placed under arrest and booked into jail on the charges. 16-0950

On April 2<sup>nd</sup> at about 3:26 am, a UPD officer on patrol was dispatched to a suspicious male subject in front of Big Lots on South Orchard Ave. Upon arrival the officer contacted Pablo Mora age 56, who is known to law enforcement from many prior contacts. Mora was intoxicated and placed under arrest for being drunk in public. Mora was booked into county jail. 16-0951

On April 3<sup>rd</sup> at about 1:52 am, a UPD officer on patrol performed an enforcement stop on a white Toyota sedan on Pomeroy Avenue. The driver was identified as Katie Moss age 20 from Willits. As the officer spoke with Moss, he suspected that she was intoxicated and began a DUI investigation. Moss was placed under arrest for DUI and later booked, cited and released with a court appearance date. 16-0958

On April 3<sup>rd</sup> at about 2:12 pm, a UPD officer on patrol observed a female subject in the 400 block of Talmage Road, near a closed business. The officer contacted the subject, who was identified as Maria Marfil age 34, from Willits. As the officer spoke with Marfil, he suspected that she was under the influence of an illegal stimulant. Marfil was found to be in possession of suspected methamphetamine and placed under arrest. Marfil was booked, cited and released with a court appearance date. 16-0959

On April 3<sup>rd</sup> at about 4:12 pm, a UPD officer in the 400 block Talmage Road, observed a subject he knows as Marcelino Zurita-Paz age 44. The officer was aware that Zurita-Paz was on probation with a "no alcohol" clause and contacted him. Zurita-Paz was found to be intoxicated and was placed under arrest for violation of his probation. Zurita-Paz was later booked, cited and released with a court appearance date. 16-0960

On April 4<sup>th</sup> at about 10:10 pm, a UPD officer was dispatched to Motel 6 on South State Street, to investigate a disturbance. The manager directed the officer to a subject identified as Michael Sandoval age 25. As the officer spoke with Sandoval, he was found to be intoxicated and was placed under arrest for public intoxication. Sandoval was booked into county jail. 16-0962

On April 4<sup>th</sup> at about 7:30 am, a UPD officer on patrol contacted a subject named Tammy Jimenez age 37, in the 1200 block of South State Street. A records check revealed that Jimenez had active misdemeanor warrants for her arrest. Jimenez was placed under arrest for the warrants and booked into county jail. 16-0965

On April 4<sup>th</sup> at about 7:41 am, a UPD officer on patrol observed a subject named Scott Mather age 29, driving a vehicle in the 400 block of East Gobbi Street. A records check revealed that Mather's license was suspended, and the officer conducted an enforcement stop on the vehicle. Mather was found to be in possession of methamphetamine and drug paraphernalia. Mather was placed under arrest for the violations and booked into county jail. 16-0966

On April 4<sup>th</sup> at about 10:19 am, a UPD officer on patrol in the 700 block of South State Street stopped a white Lexus sedan for traffic violations. The driver was identified as Yecenia Buenrostro, age 25. A records check revealed that Buenrostro had two active misdemeanor warrants for her arrest. On April 4<sup>th</sup> at about 10:22 am, a UPD officer contacted an 85 year old female subject, who resides in the 600 block of Leslie Street regarding a theft. The elderly female subject reported that on March 24<sup>th</sup>, she received a phone call from a subject who identified himself as "Michael Crow". Michael told the victim that he was an attorney for her grandson "Nathan" who was currently in a Las Vegas jail pending local charges. Michael told the victim that he needed \$5,800.00 so "Nathan" could be bailed out of jail. Concerned about her grandson, the victim decided to send the money. Michael instructed the victim to use \$100.00 bills, place them inside a magazine and use a 9x12 envelope to send both the magazine and cash payment. The victim was instructed what to write on the outside of the envelope and address where it would be sent. A courier from Bay Area Express came by and collected the envelope from the victim. The courier service dropped the envelope off at FedEx and it was shipped to an address in Whittaker Michigan. The victim does have a grandson named "Nathan", but after she sent the money discovered that he was not in custody in Las Vegas and she had been the victim of a scam. Neither the courier nor shipping company appears to be involved in this scam. The case is under investigation at the Ukiah Police Department.

As a reminder in regards to con games, fraud schemes and scams:

*Be skeptical of any individual that calls you on the phone, or contacts you via email or texts and requests you to send money.*

*Never be pressured or threatened into sending money.*

*If you're not sure, just hang up on the person.*

*If it seems too good to be true it probably is.*

*Call the police if you are suspicious.*

On April 5<sup>th</sup> at about 8:48 am, a UPD Detective received information that Eric Roberts age 28, was eating in the breakfast area at the Days Inn on North State Street. The detective was aware that Roberts had a felony warrant for his arrest. UPD detectives and officers responded to the area of the Days Inn, and upon arrival observed him running down a stairwell of the motel. UPD detectives and officers were able to give Roberts verbal orders and take him into custody. Roberts was booked into county jail. 16-0984

On April 5<sup>th</sup> at about 7:18 pm, a UPD officer was dispatched to the intersection of S. Dora St. and W. Mill St. regarding a report of a possible DUI Traffic Collision. Upon arrival, the officer spoke with Ukiah Fire Department Chief Kevin Jennings. Chief Jennings reported that he saw the driver hunched over the steering wheel of the U-Haul. Chief Jennings pulled over to check on the driver of the U-Haul to make sure he was not in need of medical attention. As Chief Jennings woke the driver up, the U-Haul truck proceeded forward colliding with the rear end of Chief Jennings Truck. The officer spoke with the male driver who was identified by his CA DL as Kyle Gillespie age 32. Gillespie showed the objective signs and symptoms of being under the influence of a controlled substance. During the investigation the officer located a handgun, two hypodermic needles, a white ABA body armor vest, two tire knockers, as well as ammunition. Gillespie had a prescription pill bottle with six pills inside as well as a hypodermic needle on his person. Gillespie was placed under arrest for DUI drugs, possession of drug paraphernalia, possession of a controlled substance and carrying a concealed firearm. Gillespie was booked into county jail.
