Statistics

Arrests included: 6 warrants, 1 shoplifting, 1 possession of a firearm, 1 possession of a controlled substance for sale, 2 possession of a controlled substance / possession of drug paraphernalia, 1 DUI, 1 arrested for domestic assault, 7 drunk in public, 1 under the influence of a controlled substance, 1 VOP / drunk in public, 1 possession of a controlled substance for sale, 1 drunk in public / VOP, 2 assault with a deadly weapons, 1 grand theft, 1 assault with a deadly weapon / VOP, 1 vandalism, 2 VOPs, 2 PRCS warrants, 1 shoplifting / false ID / VOP.

Officers investigated and took reports of: 6 found property, 1 abandon vehicle tow, 5 CPS cross reports, 1 theft, 2 APS referrals, 1 UCC violation report, 2 registration tows, 1 child endangerment / contributing to the delinquency report, 1 dog bite, 1 mental health commitment, 1 use of force, 1 annoying phone calls, 1 supplemental, 1 suspicious circumstance, 2 cited illegal camping, 1 adult MP, 2 batteries, 1 burglary, 1 stolen vehicle, 1 health and safety investigation, 1 fraud investigation.

The Patrol Division's average response time to in-progress calls were a little over 4 minutes. The average response time to all other calls was just under 11 minutes.

Highlights for the Week

On April 6th at about 7:52 am, a UPD officer on patrol in the 700 block of East Gobbi Street, noticed a subject he knew as Gordan Hanover age 44 from Ukiah. The officer was aware that Hanover had three misdemeanor warrants for his arrest. A records check revealed that Hanover was also on probation and with terms of search and seizure. The officer contacted Hanover, who was found to be in possession of methamphetamine for sale. Hanover was placed under arrest for the warrants and possession of a controlled substance for sale. 16-0997

On April 6th at about 2:48 pm, a UPD officer was dispatched to Kohl's on North Orchard Avenue, for a report of a shoplifter leaving the scene. Upon arrival the officer contacted Loss Prevention officer who was outside the store pointing at a white Mazda driving away from the scene, stating "That's her". The UPD officer performed a traffic stop on this vehicle in the 200 block of Clara and detained the driver, who was identified as Christine Cook, age 29. There was a passenger inside the vehicle who was identified as Timothy Simons, age 37. During the investigation the officer learned that Cook had selected clothing, sandals, sunglasses, fragrances and jewelry. Cook had entered a dressing room and then exited without any items. Cook then exited the store making no attempt to pay for the items. Cook was placed under citizen's arrest for shoplifting. The stolen property was located under the passenger seat of Cook's vehicle. A records check revealed that Simmons had a felony warrant issued for him out of Placer County for ID theft. Simmons was taken into custody for the warrant. Both Cook and Simmons were booked into county jail. 16-1005

On April 6th at about 8:30 pm, a UPD officer on patrol heard a car alarm sounding from a grey Dodge Avenger in the Rite Aid parking lot on South State Street. The officer approached the vehicle and noticed that there was a dog locked inside of it. In plain view inside the vehicle was drug paraphernalia. The officer went looking for the owner of the vehicle and found him as he was exiting Rite Aid. The officer knew the subject, from prior law enforcement contact, as Ron Keys age 49. Keys was found to have suspected Methamphetamine on his person. Keys was placed under arrest for possession of a controlled substance and possession of drug paraphernalia. Keys was booked into county jail. 16-1006

On April 6th at about 10:52 pm, a UPD officer stopped a black Ford Explorer in the 500 block of South Dora Street, for traffic violations. The driver was identified as Javier Leon-Mulgado age 44, from Ukiah. A records check revealed that Mulgado did not have a drivers' license. As the officer spoke with Mulgado, he suspected that Mulgado was intoxicated and began a DUI investigation. Mulgado was placed under arrest for DUI and booked into county jail. 16-1007

On April 7th at about 10:10 am, a UPD officer was dispatched to 508 East Perkins Street, for a report of panhandlers in front of the business. Upon arrival the officer contacted a female adult, who he knew from prior law enforcement contacts as Jennifer Degroot, age 44. A records check revealed that Degroot had a misdemeanor warrant for violation of her probation and she was taken into custody. Degroot was booked into county jail. 16-1012

On April 7th at about 5:43 pm, UPD officers were dispatched to the 300 block of North Orchard Avenue, for a domestic disturbance between a male and female. A witness reported that the female subject was striking the male multiple times. UPD officers arrived and separated the two, who were involved in a dating relationship and have two children in common. During the investigation it was learned that Ashley Espinosa age 30, had been involved in an altercation with her adult boyfriend, during which time she punched him in the face. Espinosa's boyfriend received visible injuries from the assault and she was arrested for domestic assault. Espinosa was booked into county jail. 16-1018

On April 7th at about 11:49 pm, a UPD officer was dispatched to the Shell gas station in the 500 block of East Perkins Street, for a report of a male subject causing a disturbance. Upon arrival a clerk told the officer that she was leaving work when a male subject approached her, began screaming at her for no reason. At one point the male charged toward her as if he was going to attack her. The clerk reported being terrified because of the male's aggressive behavior toward her. The officer located the subject across the street at Chevron gas station. The male subject was identified as Christopher Bagley age 55. As the officer spoke with Bagley he noticed that Bagley appeared to be under the influence of drugs and evaluated him for this. Bagley was placed under arrest for being under the influence of a controlled substance and booked into county jail. 16-1021

On April 8th at about 1:04 am, a UPD officer on patrol contacted Craig Leitz age 65 in the 1100 block of Airport Park Blvd. A records check revealed that Leitz had a misdemeanor warrant for his arrest and he was taken into custody. Leitz was booked into county jail. 16-1023

On April 8th at about 12:19 pm, a UPD officer patrolling in the 200 block of North Orchard Avenue, observed an adult female who he recognized from prior law enforcement contacts as Erin Blackwell, age 45. Blackwell was drinking from an open 24oz Budweiser beer and was contacted by the officer. Blackwell was found to be extremely intoxicated and placed under arrest for being drunk in public. Blackwell was booked into county jail. 16-1024

On April 8th at about 10:28 pm, a UPD officer was dispatched to Walmart on Airport Park Blvd., for a report of an intoxicated male causing a disturbance inside the store. Upon arrival the officer contacted the subject, who was identified as Kevin Litzen, age 44. Litzen was found to be extremely intoxicated and placed under arrest for public intoxication. Litzen was booked into county jail. 16-1028

On April 9th at about 1:44 am, a UPD officer on patrol noticed two pedestrians walking down the center of the roadway in the 100 block of Ford Street. The officer contacted the two, who were identified as Maric Arriaga age 23, and Falynn Ricci age 31. Arriaga was found to be on probation, had suspected methamphetamine on his person for sale and was placed under arrest for the violations. A records check revealed that Ricci had an active misdemeanor warrant for her arrest out of Marin County and she was also taken into custody. Both subjects were booked into county jail. 16-1030

On April 9th at about 10:32 am, UPD officers were dispatched to the 300 block of Seminary Avenue., for a report of a male transient causing a disturbance. The subject was identified as David Caron age 58. Caron was yelling, belligerent and intoxicated. Caron was placed under arrest for being drunk in public and booked into county jail. 16-1031

On April 9th at about 8:54 pm, a UPD officer was dispatched to an apartment complex in the 100 block of Observatory Avenue, for a report of two subjects in the communal laundry room, who were not tenants of the complex. The two subjects were located and identified as Rick Horton age 47 and Mary Schafer age 31. A record check revealed that Horton had two local misdemeanor warrants and one misdemeanor warrant out of Placer County. Horton was placed under arrest for his active warrants and Schafer was asked to leave, which she did so upon request. Horton was booked into county jail. 16-1036

On April 11th at about 6:30 am, UPD officers were dispatched to the 800 block of North State Street, Redwood Tree Car Wash, for a report of an assault victim waiting to speak to an officer. Upon arrival, officers contacted a 57 year old male victim. The victim had visible injuries on his hands, arms, face and head. The victim reported that the prior evening he was camping near the railroad tracks about 200 yards north of Brush Street, with a subject he knew as Cynthia Philliber age 24. Philliber and the victim were talking, when she became upset with the victim and starting yelling him. Philliber then used a wooden stick, a metal bar and rocks to assault the victim causing bruising, swelling and bleeding to his arms, hands, face and head. The victim said that during the night of the assault he attempted to escape and call law

enforcement, but was stopped by Philliber who brought him back to the camp. The victim was transported to UVMC via ambulance to be treated for his injuries. A UPD officer located Philliber near the described the camp and a records check revealed that Philliber was on probation. Philliber was placed under arrest for assault with a deadly weapon, kidnapping, and violation of her probation. Philliber was booked into county jail.

On April 11th at about 12:24 pm, a UPD officer was dispatched to a residence in the 800 block of East Gobbi Street, regarding a residential burglary. Upon arrival the victim reported that today while she was gone, between 8am and 12:10 pm, someone forced entry into her residence stole two laptop computers, jewelry and personal clothing. The officer discovered that entry was made through a window and the victim had no suspect information regarding the theft. 16-1046

On April 11th at about 1:16 pm, a UPD officer on patrol in the 300 block of East Gobbi Street, observed a subject he knew as Nicholas Halvorsen age 43. The officer was also aware that Halvorsen is on probation with an "abstain" from alcohol clause and has a history of alcohol abuse. The officer contacted Halvorsen, who was found to be intoxicated in violation of his probation. Halvorsen was placed under arrest for the violation and booked into county jail. 16-1047

On April 11th at about 3:20 pm, a UPD officer observed a subject he knew as Gregory Cuadra age 39, in the 300 block of North Main Street. A records check revealed that Cuadra had a felony and misdemeanor warrant for his arrest. The officer contacted Cuadra and placed him under arrest for the warrants. Cuadra was also found to be in possession of drug paraphernalia. Cuadra was booked into county jail for the violations. 16-1050

On April 11th at about 3:01 pm, a UPD officer was dispatched to Walmart, regarding a shoplifter in custody. Upon arrival the UPD officer contacted a Loss Prevention Officer, who had a male subject detained. The Loss Prevention Officer reported that the subject did not have an identification card. When asked, the subject verbally identified himself as "James Joseph Mullen, 3/23/94". The subject was later identified as Joseph Eduardo Mallon age 23. The Loss Prevention Officer reported that Mallon had removed a hat from the shelf, removed the tag from the hat and then walked out of the store failing to pay for the property. A records check revealed that Mallon was on felony probation. Mallon was placed under arrest for shoplifting, falsely ID himself to a police officer, and violation of his probation. Mallon was booked into county jail. 16-1051

On April 12th at about 12:40 am, a UPD officer was dispatched to UVMC on Hospital Dr., for a report of a female subject refusing to leave the ER after being discharged. Upon arrival the officer contacted Kelly Kennedy age 52. Kennedy appeared intoxicated and a records check revealed that she was on probation with a "consume no alcohol" clause. A security guard reported that he was walking behind Kennedy attempting to get her to leave the property. Kennedy was yelling at him and at one point turned around swinging her purse at him, hitting the security guard on the left side of the face. Kennedy was placed under arrest for being drunk in public and violation of her probation. Kennedy was booked into county jail on the violations. 16-1053

On April 12th at about 1:15 am, a UPD officer on patrol observed a woman standing in the middle of the intersection of South State Street and Gobbi Street. The officer contacted the female subject, who raised her arms up as if to challenge the officer. The female subject was holding a 24oz. can of beer. The female subject was identified as Cecelia Reeves age

25. Reeves was found to be intoxicated and was placed under arrest for being drunk in public. Reeves was booked into county jail. 16-1054

On April 12th, UPD officers on patrol were aware that Charles Maxfield, age 42 had a Probation Order of Arrest for violation of his mandatory supervision. At about 10:46 am, UPD officers located Maxfield in the 300 block of North Main Street and took him into custody without incident. Maxfield was booked into county jail. 16-1056

On April 12th at about 9:36 pm, UPD officers were dispatched to Walmart regarding a report of a shoplifting. Dispatch advised the suspect was fleeing from Loss Prevention Officers and was seen running Northbound toward Quick Stop and Jack in the Box. Upon arrival, officers were directed to and contacted a subject identified as Dustin Wood age 26. Upon initial contact Wood argued with officers and would no listen to their verbal directions. A large knife was removed from Wood's person and he was detained in handcuffs. Loss Prevention reported to the officers that Wood had stolen a 24 pack of colored pencils, a coloring book and a portable charger. All the property was recovered from Wood and he was also found to be in possession of drug paraphernalia. Wood was placed under arrest for the violations and booked into county jail. 16-1060
