The Patrol Division's average response time to in-progress calls were a litter under 6 minutes. The average response time to all other calls was just over 14 minutes.

Highlights for the Week

On April 13th at about 8:50 am, a UPD officer on patrol in the 100 block of South State Street, observed a subject he knew from prior law enforcement contacts as Sean Day age 28. A records check revealed that Day was on probation with terms of search and seizure. The officer contacted Day in the 200 block of East Perkins Street. Day was found to be in possession of cocaine and placed under arrest for the violation and for violating his probation. Day was booked into county jail. 16-1061

On April 13th at about 10:19 am, UPD officers were dispatched to Honey Fluff in the 1200 block of North State Street, for a report of a female adult who was lying on the sidewalk in front of the location. Upon arrival the officer contacted a subject who is known from prior police contacts as Erin Blackwell age 45. On April 13th at about 11:16 pm, a UPD officer on patrol contacted two subjects sitting inside a vehicle parked in the Walmart parking lot. One of the subjects was identified as Daniel Cauley age 26. A records check revealed that Cauley had a felony and misdemeanor warrant out of Oklahoma. Cauley was placed under arrest for the warrants and booked into county jail. 16-1065

On April 14th at about 8:14 am, a UPD officer was dispatched to All in One Auto on North State Street, regarding a stolen vehicle. The officer spoke with an employee who reported that sometime between April 7th at 8 am and April 13th at 1 pm, someone stole a 1996 Red Mazda pickup with a white camper shell from their business. The employee was unable to provide any suspect information. On April 14th at about 5:04 pm, a UPD Detective located the vehicle unoccupied in the 200 block of Norton Street. The vehicle was recovered and returned to All In One Auto. No suspect(s) were identified. 16-1066

On April 14th at about 11:05 am, a UPD officer was dispatched to Starbucks on East Perkins Street, for a report of a suspicious male running and screaming at a female employee, as she was leaving work. A description was provided and the officer located the subject standing near the entrance to Starbucks. The subject was identified as Christopher Bagley age 55. Bagley was drenched in sweat, appeared disoriented, and has some abrasions on his head and arms. A witness reported that Bagley was screaming in the parking lot of Burger King and then stumbled into the middle of East Perkins Street. Bagley was found to be extremely intoxicated and placed under arrest for public intoxication. Bagley was booked into county jail. 16-1073

On April 14th at about 11:47 am, a UPD officer on patrol stopped at gray Ford pick-up in the 700 block of Waugh Lane for a traffic violation. The driver identified herself as Jessica Diaz age 23. A records check revealed that Diaz had two misdemeanor warrants for her arrest and she was placed under arrest. Diaz was booked into county jail. 16-1074

On April 15th around 1:30 am, UPD officers were dispatched to an apartment at 741 Waugh Lane, for a reported prowler. Dispatch advised that a Hispanic male subject wearing a red shirt was looking into the bedroom window of a female. Upon arrival UPD officers searched and located a subject matching the description in the parking lot of the apartment complex. The subject was identified as Daniel Saucedo (Saucedo-Gaona) age 30, with an address listed out of Lake County. The adult female victim reported that prior to calling the police she was inside her bedroom exercising. The victim reported hearing a male voice talking in Spanish saying, "Hey girl, I like the way you dance". The victim then saw a Hispanic male, who was staring into her open bedroom window with his hands against the window screen. The victim immediately called the police. During the investigation the victim was able to identify Saucedo as the suspect peering into her bedroom window. A records check revealed that Saucedo was on probation and had an active warrant for his arrest. Saucedo was placed under arrest for prowling, violation of probation and his outstanding warrant. Saucedo was booked into county jail.

- *Never ignore a knock on the door.*

The lawn had multiple ruts left from the vehicle and it appears the vehicle gained access to the lawn between two trees, on the North Pine Street side of the park. 16-1076



On April 15th at about 10:13 am, a UPD officer on patrol in the 600 block of Grove Avenue, observed an adult female who he recognized as Jondie Sperry age 27. The officer was aware that Sperry had two active misdemeanor warrants for her arrest. The officer contacted Sperry and took her into custody without incident. Sperry was booked into county jail. 16-1077

On April 15th at about 3:36 pm, UPD officers were dispatched to Freedom Skate Shop in the 400 block of North State Street, for a report of a theft that had just occurred. Dispatch advised that a male subject in a gray trench coat had stolen a pair of shoes and fled. The suspect was last seen entering Black Oak Coffee, which is across the street. An employee reported to an officer that the suspect had entered the store, tried on some shoes and left the store wearing the shoes without paying for them. The employee provided a more in depth description of the suspect, while two other UPD officers located the suspect inside Black Oak Coffee. The suspect was identified as Zachary Simons age 29 out of Ukiah. A records check revealed that Simons was on summary probation out of Mendocino County as well as Felony Formal Probation out of Santa Cruz County. Simons was placed under arrest for violation of his probation, shoplifting, and possession of stolen property. Simons was booked into county jail. 16-1081

On April 15th at about 4:48 pm, UPD officers were dispatched to the 300 block of East Gobbi Street, regarding a domestic dispute involved Ashley Espinosa and her adult boyfriend. Upon arrival an officer observed Espinosa yelling hysterically at her boyfriend. The officer made contact, and as the officer attempted to determine what had occurred, Espinosa continued yelling, calling her boyfriend names and acting irrational. Once other officers arrived to assist, they began investigating the incident. In reviewing surveillance video in the area, an officer was able to determine that Espinosa had physically assaulted her boyfriend. A records check revealed that Espinosa was on probation. As the officer placed Espinosa under arrest, she became resistive and had to be restrained. Espinosa was uncooperative, cussing and calling the officers racial slurs. After Espinosa was placed in the backseat of a police car and she began to bang her forehead against the Plexiglas partition and window bars inside the car. Officers had to remove Espinosa from the car and an ambulance was summoned. Espinosa was transported to UVMC and once medically cleared, was booked into county jail for violation of her probation and domestic assault. 16-1085

On April 15th at about 6:06 pm, a UPD officer was dispatched to a report of an intoxicated male walking northbound in the roadway of Talmage Road. Upon arrival the officer located the subject, who was now in the middle of South State Street. The subject was known from many prior police contacts as Roger Zane Schoenahl age 44. Schoenahl was waving his arms in the air and screaming at cars as they passed him. Schoenahl staggered out of the roadway into the parking lot of Motel 6. The officer contacted Schoenahl and a records check revealed that he was on probation. Schoenahl was found to be extremely intoxicated and was placed under arrest and booked into the county jail for public intoxication and violation of his probation. 16-1086

On April 15th at about 7:29 pm, UPD officers were dispatched to the 1000 block of North State Street regarding a traffic collision. Upon arrival an officer observed a red colored BMW in the road way with extensive front end damage. A black colored Scion had rear end damage and had been moved from the roadway. The driver of the BMW was identified as Madrone Roben Maltas age 35 from Ukiah. As the officer spoke with Maltas about the traffic collision, he suspected Maltas was intoxicated and began a DUI investigation. Maltas was placed under arrest for DUI. Maltas was medically cleared at UVMC and then booked into the county jail. 16-1087

On April 16th at about 1:24 am, a UPD officer on patrol stopped a black VW in the 600 block of East Perkins Street for traffic violations. The driver was identified as Kerry Madigan age 45 from Redwood Valley. As the officer spoke with Madigan, he suspected that Madigan was intoxicated and began a DUI investigation. Madigan was placed under arrest for DUI and later booked, cited and released with a court appearance date. 16-1089

On April 16th at about 9:01 am, UPD officers were dispatched to an apartment in the 700 block of South Oak Street, for a report of an un-served restraining order violation. Dispatch advised that the suspect was identified as Mauricio Diaz age 19, and that there was an active misdemeanor warrant for his arrest. While en-route to the call, a UPD officer located Diaz in the 600 block of South Oak Street and placed him under arrest for the warrant. 16-1091

On April 16th at about 6:46 pm, a UPD officer was dispatched to Lucky Supermarket in the 500 block of East Perkins Street, for a report of a theft that just occurred. Dispatch advised that the suspect had fled on foot and the reporting party was now following the suspect. A description was provided and the officer located the suspect in the area of Ford Street and Myron Place. The suspect was identified as Christina McGrew age 31. An employee reported to the officer that McGrew selected items inside the store and placed them in a blue shopping bag. McGrew then exited the store without paying for the items. A records check revealed that McGrew was on probation. The property was recovered and McGrew

was placed under arrest for shoplifting and violation of her probation. McGrew was later booked, cited and released with a court appearance date. 16-1095

On April 16th at about 11:41 pm, a UPD officer was dispatched to the 200 block of East Perkins Street, regarding an intoxicated female subject throwing rocks at vehicles. Upon arrival the officer located a subject, who was identified as Heidi White age 24 from Ukiah. White was found to be extremely intoxicated and placed under arrest public intoxication. White was booked into county jail. 16-1097

On April 17th at about 3:52 am, a UPD officer on patrol conducted an enforcement stop on a red Toyota on Garrett Drive for traffic violations. The driver was identified as Cesar Lugo age 18 from Ukiah. As the officer spoke with Lugo, he noticed that Lugo appeared intoxicated and began a DUI investigation. Lugo was placed under arrest for DUI and was later booked, cited and released on a citation with a court appearance date. 16-1098

On April 17th at about 7:37 am, a UPD officer on patrol conducted an enforcement stop on a gray 1995 Volvo, in the 100 block of South Orchard Avenue, for a traffic violation. The driver was identified as Luis Villalobos age 23. A records check revealed that Villalobos was on probation and had three active misdemeanor warrants for his arrest. Villalobos was placed under arrest for the warrants and found to be in possession of suspected heroin and methamphetamine. Villalobos was booked into county jail on the warrants and the additional listed violations. 16-1101

On April 17th at about 9:33 am, a UPD officer was dispatched to Lucky Supermarket in the 500 block of East Perkins Street, for a report of a suspicious person inside the store. Dispatched further advised that the subject was at the checkout register with a full shopping car of items. The subject ran a credit card and the machine sent a hold message to the cashier, indicating that the credit card was likely stolen. The subject left just before the officer arrived. He was located behind the supermarket, hiding behind a dumpster. The subject was identified as Christopher Peters age 27 and he was detained. During the investigation Peters was found to be in possession of a credit cards and "Coach" wallet that did not belong to him. Peters was also found to be in possession of burglary tools, suspected methamphetamine and hydrocodone without a prescription. Peters was placed under arrest for ID theft, burglary, possession of burglary tools, and possession of a controlled substance. Peters was booked into county jail. 16-1103

On April 17th at about 10:31 am a UPD officer was dispatched to the Sunrise Inn on South State Street, in regards to a female refusing to leave. The officer contacted the subject, who was identified as Andrea Gonzalez age 46. A records check revealed that Gonzalez had an active misdemeanor warrant out of Sonoma County for her arrest. Gonzalez was taken into custody without incident and booked into county jail. 16-1104

On April 17th at about 9:12 am, a UPD officer received information that the occupant of a residence in the 400 block of Cypress Avenue was wanted by Parole. The subject was identified as Sobin Nhuy age 32. A records check revealed that Nhuy had an active parole warrant. Officers responded to the location and took Nhuy into custody without incident. Nhuy was booked into county jail. 16-1105

On April 17th at about 4:31 pm, a UPD officer was dispatched to the 400 block of South Oak Street, on a report of an intoxicated male subject in the company of an approximately four year old little girl. It was reported that the male subject was yelling and cursing. The officer arrived and contacted the subject, who was identified as Derrick Ridenour. The little girl was identified as Ridenour's daughter, who was confirmed to be 4 years old. Ridenour was found to be extremely intoxicated and unable to care for the child. Ridenour was placed under arrest for being drunk in public and child

endangerment. Child Protective Services was notified and took custody of the girl. Ridenour was booked into county jail. 16-1106

On April 18th at about 10:09 am, a UPD officer on patrol in the 300 block of North Main Street contacted a female subject who he knows as Brandi Adkins age 43, and a male subject, who was identified as Fredrick Fitch age 21. A records check revealed that Fitch had three misdemeanor warrants for his arrest and he was on probation. Fitch was also found to be in possession of methamphetamine and was placed under arrest for the warrants, probation and drug violations. Fitch was booked into county jail. 16-1115

On April 18th at about 10:40 am, a UPD officer was dispatched to the lobby of the police department, regarding a subject stating that he felt someone was following him around town and his brain was broken. The officer contacted the subject, who he recognized from many past police contacts as Michael Beers age 37. A records check revealed that Beers was on probation. As the officer spoke with Beers he suspected that Beers was under the influence of a controlled substance and evaluated him for this. Beers admitted to using methamphetamine an hour ago and was placed under arrest for being under the influence of a controlled substance and violation of his probation. Beers was booked into county jail. 16-1116

On April 18th at about 12:14 pm, a UPD officer was dispatched to All in One Auto on North State Street, regarding a stolen vehicle report. Upon arrival the officer spoke with the owner of the business, who told him that sometime between April 15th at 6 pm, and April 18th at 12 pm, someone stole a tan 1999 Mazda 626 sedan, for the parking lot of the business. The owner had no idea who committed the theft. 16-1121
