The Patrol Division's average response time to in-progress calls was a little under 5 minutes. The average response time to all other calls was a little over 9 minutes.

Highlights for the Week

On May 4th at about 7:46 am, UPD officers were dispatched to a residence in the 100 block of Evans Street, on a report of a domestic assault. An adult female victim reported that her boyfriend Jared Carlsen age 25, had consumed alcohol and was intoxicated the prior evening. At about 3:45 am the victim attempted to wake Carlsen for work, but was unable to due to Carlsen being intoxicated. Upon awaking at 7am Carlson became angry that his girlfriend had not woke him up. Carlsen began yelling and screaming at the victim. Carlsen picked up food and dumped it on the living room floor and threw belongings around the house. Carlsen also dumped a glass of ice tea on the victim. Carlsen was placed under arrest for domestic assault and booked into county jail. 16-1272

On May 4th at about 11:14 am, a UPD officer was dispatched to the 700 block of East Perkins Street, on a report of Chris Lawson age 50, walking in the area and possibly wanted on a warrant. Lawson was located in the 600 block and contacted. A records check revealed that Lawson did in fact have a misdemeanor warrant out of San Manteo County and he was taken into custody without incident. On May 4th at about 12:42 pm, a UPD officer was dispatched to a report of a civil issue in the 600 block of S. Orchard Avenue. Upon arrival the reporting party told the officer that his ex-girlfriend, Hannah Nelson age 25 would not return his vehicle. The officer knew Nelson from past contacts and was aware she had a misdemeanor warrant for her arrest. The vehicle and Nelson were located and she was taken into custody for her warrant. Nelson was booked into county jail. 16-1277

On May 5th at about 6:46 pm, UPD officers were dispatched to the 400 block of South State Street, to investigate a report of an intoxicated subject in the roadway. Upon arrival officers contacted Joel Kimball age 45. Kimball was found to be drunk and placed under arrest for public intoxication. Kimball was booked into county jail. 16-1294

On May 5th at about 6:51 pm, a UPD officer was dispatched to Wal-Mart for a report of a shoplifter in custody. Loss Prevention at the store had Danny Ray age 51 detained. A Loss Prevention employee told the officer that Ray had entered the store, selected items and then exited without paying for the items. A records check revealed that Ray was on probation. Ray was placed under arrest for shoplifting and violation of his probation. Ray was booked into county. 16-1295

On May 5th at about 10:01 pm, a UPD officer on patrol performed an enforcement stop on Oldsmobile Bravado in the 100 block of North School Street, for traffic violations. The driver was identified as Sebastian Rabano age 36 of Ukiah. The officer observed there were two open cans of alcoholic beverages inside the vehicle. The driver appeared intoxicated and admitted to smoking marijuana a couple of hours prior. After a DUI investigation, Rabano was placed under arrest for driving intoxicated. Rabano was later booked, cited and released with a court appearance date. 16-1296

On May 6th at about 2:02 am, a UPD officer performed an enforcement stop on a grey Ford Fusion with Michigan license plates, in the 100 block of Freitas Street for traffic violations. The driver was identified as Archez Marks age 25, out of Detroit Michigan. As the officer spoke with Marks, he could smell the odor of Marijuana coming from the vehicle. Suspecting the driving was under the influence of Marijuana and driving, the officer began a DUI investigation. Marks was placed under arrest for driving under the influence of drugs and later booked, cited and released with a court appearance date. 16-1298

On May 6th at about 2:53 pm, a UPD officer was dispatched to 410 Cypress Avenue, for a welfare check. During that welfare check the officer spoke with a subject identified as Sobin Nhuy age 32 from Bakersfield. A records check revealed that Nhuy was on Parole and had a CDCR warrant for his arrest. Nhuy was placed under arrest and booked into county jail. 16-1303

On May 6th at about 9:21 pm, UPD officers were dispatched to the 1900 block of Elm Street, regarding an intoxicated subject attempting to gain entry into various residences. Upon arrival officers contacted a subject named Brandon Harrison age 37, who they knew from past contacts. Harrison was drunk and placed under arrest for public intoxication. Harrison was booked into county jail. 16-1305

On May 7th at about 10:58 am, a UPD officer was flagged down by three females, who reported that they had just seen a male urinate on a building in the 200 block of N. State Street. The officer located the subject, who was identified as Adrian McWhinney age 61 from Ukiah. A records check revealed that McWhinney was on probation with an "Abstain

from alcohol” clause. McWhinney was drunk and placed under arrest for violation of his probation and public intoxication. McWhinney was booked into county jail for the violations. 16-1306

On May 7th at about 9:58 pm, a UPD officer performed an enforcement stop on a vehicle in the 1100 block of South State Street for traffic violations. The driver was identified as Jose Lopez age 19 out of Ukiah. As the officer spoke with Lopez, he could smell the strong odor of marijuana coming from the vehicle, so the officer began a DUI investigation. A records check revealed that Lopez’ license was suspended and he was found to be in possession of concentrated cannabis. Lopez was placed under arrest for driving under the influence of drugs, driving on a suspended license, and possession of concentrated cannabis. Lopez was later booked, cited, and released for the violations with a court appearance date. 16-1310

On May 8th at about 1:21 am, UPD officers were dispatched to the 1100 block of West Perkins Street, for a report of an intoxicated male subject. Upon arrival the officer located the male subject lying on the ground. The subject was identified as Giovanni Villavicencio age 22, from Cloverdale. Villavicencio was placed under arrest for public intoxication and booked into county jail. 16-1313

On May 8th at about 5:33 am, a UPD officer was dispatched to a residence in the 1600 block of Lockwood Drive, to investigate a vehicle theft. The victim reported that he left his vehicle running and unlocked as he was loading items from his residence. While walking to his car, the victim reported seeing a male subject get into his vehicle and drive off, northbound on Lockwood toward Empire Drive. Officers contacted a witness who reported seeing the victim’s vehicle sideswipe a parked car on Lockwood as it drove off. Officers checked the area and located the vehicle damaged in the hit and run, but not the stolen vehicle. At about 7 am UPD received a call from the victim, who reported seeing the male suspect walk by his residence. UPD officers responded and based on a description provided by the victim contacted a male subject in the 1700 block of Lockwood Drive. The male subject was identified as Daniel Castillo, age 28. A records check revealed that Castillo was on Post-Release Community Supervision (PCRS) out of Napa County. Evidence was located that linked Castillo to the vehicle theft and some suspected methamphetamine that had been discarded nearby. Castillo was placed under arrest for vehicle theft, possession of methamphetamine and for the PCRS violation. During an area search, the victim’s vehicle was located in the 900 block of North Oak Street. The victim’s personal belongings were missing from the vehicle. A UPD officer searched the area around where the vehicle was located and most items were recovered. One of the only item’s that was not recovered was the victim’s wallet. Castillo was booked into county jail on the above listed charges.

I’d like to take this time to provide some vehicle safety tips:

- Never leave the keys in your vehicle or leave it running unattended. It only takes a few seconds for a criminal to get in your car and drive off.
- Always lock the doors, even when you are away from the vehicle for a short time.
- Always roll up your windows when you leave your vehicle, even when it’s parked in a driveway or garage.

On May 8th at about 5:37 pm, a UPD officer was dispatched to Friedman Brothers on Airport Park Blvd., for a report of an ex-employee named Benjamin Harpe consuming alcohol and causing a disturbance in front of the business. Upon arrival a UPD officer located Harpe and contacted him. Harpe was found to be intoxicated and placed under arrest. Harpe was booked into county jail on the violation. 16-1317

On May 8th at about 7:35 pm, a UPD officer was inside the Police Department, when he heard several loud "thud" noises coming from the area near the night lobby. As the officer started to look into the matter, he heard a sound of a window shatter. Officers went outside to investigate and found a male subject that was breathing heavily and had a thick cable style bicycle lock near his feet. The subject stated, "I told you guys to take me to jail". The

male subject was identified as John Varney age 51, was then detained. During an inspection of the exterior of the building and reviewing video surveillance, officers discovered that Varney had used his bicycle lock to break a window out of the police department. A records check revealed that Varney was on probation for a prior assault with a deadly weapons case. Varney was placed under arrest for vandalism and violation of his probation and booked into county jail. 16-1318

On May 9th at about 11:21 am, a UPD officer received information that Jonathan Koegler age 33, was staying at a residence in the 300 block of North Main Street and had an active Felony warrant for his arrest. UPD officers confirmed that warrant and contacted Koegler at the reported residence. Koegler was taken into custody without incident and booked into county jail. 16-1322

The victim locked his vehicle and did not return until about 10 pm. When he returned to his vehicle he found the vehicles rear

sliding window was open and property stolen from the interior. The victim was unable to provide any suspect information. 16-1332

A City Parks employee reported that sometime between May 9th at 1 pm and May 10th at 7:15 am, an unknown person(s) broke the drinking fountain in the park (shown left). It is unknown who damaged the drinking fountain. 16-1333

On May 10th at about 8:07 am, UPD officers were dispatched to a report of a domestic disturbance at the Comfort Inn, 1200 block of Airport Park Blvd. Upon arrival officers contacted a pregnant adult female, who was crying and distraught. The female reported that her boyfriend Theodore Strong age 30 had been drinking heavily and was intoxicated. The victim reported that inside the motel room Strong was pestering her and started an argument. The victim tried to get away from the situation by walking out into the parking lot, but her boyfriend followed her outside. The victim then returned to the motel room and Strong struck her in the arm. Strong was located by officers and placed under arrest for domestic assault. Strong was booked into county jail for the violation. 16-1334

On May 10th at about 3:45 pm, a UPD officer was dispatched to 625 North State Street #10, to investigate an altercation. While conducting the investigation, the officer contacted a female subject who was identified as Elizabeth Holm age 25 from Ukiah. A records check revealed that Holm had an active warrant for her arrest and she was taken into custody without incident. Holm was booked into county jail on the warrant. 16-1343

On May 10th at about 5:31 pm, a UPD officer was dispatched to Wal-Mart on Airport Park Blvd., regarding a report of embezzlement. Upon arrival the officer spoke with the Asset Protection Supervisor, who had employee Raul Munoz age 57 from Ukiah detained for embezzlement from the store. The Supervisor reported that he had identified 12 transactions, where Munoz has embezzled items from the store. The embezzlement was recorded on surveillance video, which was
