### **Highlights for the Week**

On May 11<sup>th</sup> at about 10:34 pm, a UPD officer responded to an apartment complex in the 200 block of Main Circle to investigate a vehicle theft. Upon arrival the officer spoke with the victim, who reported that the prior evening at about 10 pm, his 2004 Acura TSX was parked in a parking space at the complex and all doors were locked. The following day, on May 11<sup>th</sup>, at about 10:30 pm he noticed that his car had been stolen. On May 12<sup>th</sup> at about 6:32 am, UPD officers responded to the 1100 block of Low Gap Road, regarding a vehicle that had collided with a fire hydrant. Upon arrival the officers found a blue dodge coupe, on the sidewalk of Low Gap next to a fire hydrant. Airbags of the vehicle had been deployed and the driver was located near his vehicle. The driver of the vehicle was identified as Ronald Keys age 49. Keys reported that he was traveling at about 20-25 MPH, when he fell asleep and collided with the fire hydrant. Keys reported no injuries from the collision and City of Ukiah public works responded, inspected the fire hydrant and found no damage. 16-1361

On May 12<sup>th</sup> at about 10:11 am, UPD officers were dispatched to CVS on South Orchard Avenue, regarding two male subjects dragging another male subject for an unknown reason. Upon arrival officers contacted two subjects, who they immediately recognized as Scotty Willis and John Bolton. A third subject was lying under a piece of cardboard, who was identified as Thomas Sanders age 53. Next to Sanders was a  $\frac{3}{4}$  consumed bottle of alcohol. A records check revealed that Sanders was on probation with an "Abstain from alcohol clause". Sanders woke up and as officers spoke with him they realized he was intoxicated. Officers placed Sanders under arrest for public intoxication and for violation of his probation. Sanders was booked into county jail. 16-1362

On May 12<sup>th</sup> at about 12:25 pm, a UPD officer was dispatched to the 700 block of East Gobbi Street, Chevalier Vineyard, for a report of a theft. Upon arrival the officer spoke with the business owner and reporting party. The victim reported that sometime between May 11<sup>th</sup> at 6 pm and May 12<sup>th</sup> at about 5 am, an unknown person(s) broke a gate on the perimeter fence of the property and stole a trailer and two four wheelers. The victim described the trailer as a red in color with the license plate of 4FJ9039 on it. 16-1364

On May 12<sup>th</sup> at about 6:45 pm, a UPD officer was dispatched to the intersection of N. Bush Street and Walnut Avenue, to investigate a report of an intoxicated female. Upon arrival the officer contacted Vickie Mejia age 54. A records check revealed that Mejia was on probation. As the officer spoke with Mejia she appeared to be intoxicated and started to walk away from the investigation officer. The officer gave Mejia verbal instructions, which she ignored. When the officer went to physically restrain Mejia, she punched the officer in the chest. Mejia was placed under arrest for assault on a peace officer, resisted / delay a police officer and violation of her probation. Mejia was booked into county jail. 16-1370

On May 12<sup>th</sup> at about 10:23 pm, UPD officers were dispatched to a local dentist office on South Dora Street, in regards to a possible prowler outside of the business. Upon arrival the area was checked, but the prowler was not located. Upon inspecting the business, the officer found two pry marks to one of the business' doors. The suspect was described as an Asian or Hispanic male adult with dark short hair, approximately 5'8" tall, possibly barefoot or wearing sandals, wearing shorts and a tank top. 16-1372

On May 13<sup>th</sup> at about 2:26 am, a UPD officer was dispatched to Cherry Court, for a report of a suspicious person loitering outside of a residence. Upon arrival the officer contacted Daniel Delossantos age 49 from Ukiah. As the officer spoke with Delossantos, he suspected that Delossantos was under the influence of a controlled substance and evaluated him for this. A records check revealed that Delossantos was on probation, for a prior drug related offence. Delossantos was

placed under arrest for being under the influence of a controlled substance and violation of his probation. Delossantos was booked into county jail for the violations. 16-1374

On May 14<sup>th</sup> at about 1:58 am, a UPD officer performed an enforcement stop on a grey Pontiac G6, in the 300 block of South State Street, for a traffic violation. The driver was identified as John Clark age 54, from Wolf Creek Oregon. As the officer spoke with Clark, he suspected Clark was intoxicated and began a DUI investigation. Clark was placed under arrest for DUI. Clark was later booked, cited and released with a court appearance date. 16-1380

On May 14<sup>th</sup> at about 2:45 am, a UPD officer performed an enforcement stop on a white pickup, in the 1000 block of North State Street, for traffic violations. The driver was identified as Carlos Ogawa age 29, from Fort Bragg. As the officer spoke with Ogawa he could smell the strong order of marijuana coming from the vehicle and suspected that the driver was under the influence of drugs. After a DUI drug investigation, Ogawa was placed under arrest for DUI drugs. Additionally, Ogawa was found to be in possession of drug paraphernalia. Ogawa was booked into county jail for the violation. 16-1381

On May 15<sup>th</sup> at about 11:03 am, a UPD officer was dispatched to Alex Thomas Plaza, regarding a woman in the plaza yelling. Upon arrival the officer contacted a subject he knew as Cruz Rea. Rea's pants were pulled down and she was exposing herself to people in the park. As the officer spoke with Rea it was clear that she was intoxicated and a field breath test revealed that her blood alcohol level was .26 %. Rea was placed under arrest for public intoxication and booked into county jail. 16-1395

On May 17<sup>th</sup> at about 8:09 pm, a UPD officer on patrol in the 300 block of North Main Street when he saw a subject he recognized as Christopher Keyser age 32 and contacted him. A records check revealed that Keyser had a warrant for his arrest and he was on probation. Keyser was placed under arrest for the warrant and was found to be in possession of suspected methamphetamine and drug paraphernalia. Keyser was booked into county jail for the warrant and a report was submitted to the DA's office for the drug offences and probation violation. 16-1409

On May 17<sup>th</sup> at about 5:52 pm, a UPD officer was dispatched to Alex Thomas Plaza, for a reported possible assault. Upon arrival the officer spoke with multiple subjects, one of which who was identified as Cruz Rea age 55. Rea was found to be intoxicated and a records check revealed that she was on probation. Rea was placed under arrest for being drunk in public and for violation of her probation. Rea was booked into county jail. 16-1420

On May 17<sup>th</sup> at about 10:04 pm, a UPD officer performed an enforcement stop on a silver Honda Accord in the 300 block of North Main Street for traffic violations. The officer contacted the driver, who was identified as Guadalupe Garcia age 21. As the officer spoke with Garcia he suspected Garcia was intoxicated and began a DUI investigation. Garcia was placed under arrest for DUI. Garcia was later booked, cited and released with a court appearance date. 16-1421

On May 18<sup>th</sup> at about 12:22 am, a UPD officer performed a traffic stop on a silver VW Bug in the 600 block of South State Street for an observed traffic violation. The driver was identified as Sylvestre Ruiz age 31. The passenger in the front seat verbally identified herself as "Casandra Guerra". During the traffic stop the officer suspected that the passenger was not being truthful and she was eventually identified as Adriana Guerra age 27, from Ukiah. A records check revealed that Adriana Guerra had an active felony warrant for her arrest and was on probation. Adriana Guerra was placed under arrest for the felony warrant, false ID to a police officer and violation of her probation. After Adriana Guerra's arrest she was found to be in possession of drug paraphernalia. She was booked into county jail for all the above charges. 16-1423
