### **Highlights for the Week**

On May 18<sup>th</sup> at about 8:48 am, a UPD officer was dispatched to an apartment complex in the 700 block of Waugh Lane, for a report of a violation of a court order. The suspect was identified as "Gabriel" and was reportedly wearing all red. Upon arrival in the area, the officer observed a subject he knew as Gabriel Campos age 42 and contacted him. The adult female victim was contacted and interviewed. She reported that Campos had contacted her in front of her residence in violation of a domestic violence restraining order. A records check revealed that there was an active domestic violence restraining order prohibiting Campos from contacting the victim. Campos was placed under arrest for violating the restraining order and booked into county jail. 16-1431

On May 18<sup>th</sup> at about 6:37 pm, a UPD officer was dispatched to 398 South Orchard Avenue, for a possible court order violation. Upon arrival the officer contacted one of the involved parties, who was standing outside of the residence on the sidewalk. The officer recognized the subject as Nicole Pacheco age 39. While speaking with Pacheco regarding the possible court order violation, the officer noticed Pacheco was intoxicated. Pacheco was placed under arrest for public intoxication and booked into county jail. 16-1438

On May 18<sup>th</sup> at approximately 7:44 pm, a UPD officer responded to 245 East Perkins Street, for a report of an unresponsive male at the location. Upon arrival on scene the officer noticed a male subject staggering from the area and contacted him. The subject was identified as Jesse Bugher age 45. As the officer spoke with Bugher to determine if he had some type of medical issue, Bugher was found to be intoxicated. Bugher was placed under arrest for being drunk in public and booked into county jail. 16-1439

On May 18<sup>th</sup> at about 7:35 pm, UPD officers were dispatched to the Regency Inn on South State Street, regarding a report of an unwanted subject behind the hotel. Upon arrival an officer contacted four subjects, who he knew from prior law enforcement contacts as Fernando Fabian age 42, Sherri Neeley age 45, Paul Rivera age 26, and Angelina Cantaroni age 44. As the officer walked up to the group, Fabian looked at the officer and tossed something from with his left hand. The officer discovered it was a "Beats" zipper case that contained a used glass pipe, commonly used for smoking methamphetamine. There were also multiple empty small plastic methamphetamine baggies and a large zip lock bag that contained suspected crystal methamphetamine. A records check revealed that both Fabian and Neeley were on probation. Through an investigation officers determined that both Fabian and Neeley were in possession of a controlled substance to sell, possession of drug paraphernalia and in violation of their probation. Both were placed under arrest for the violations and were later booked, cited and released with a court appearance date. 16-1440

On May 18<sup>th</sup> at about 9:35 pm, a UPD officer performed a traffic stop on a white Dodge Ram pickup in the 1100 block of Airport Park Blvd., for a traffic violation. The officer contacted the driver who was identified as Erik Velasco-Murillo age 34. As the officer spoke with Velasco-Murillo he suspected that he was intoxicated, so the officer began a DUI investigation. Velasco-Murillo was placed under arrest for DUI and booked into county jail. 16-1441

On May 18<sup>th</sup> at about 10:17 pm, a UPD officer was dispatched to the apartment complex in the 600 block of Marshall Street, for a report of a male subject standing outside of an apartment screaming. Upon arrival the subject was contacted and identified as Anthony Stra age 23. As the officer spoke with Stra he was found to be intoxicated and placed under arrest for public intoxication. On May 18<sup>th</sup> at about 9:48 pm, a UPD officer was dispatched to Safeway on South State Street regarding a report of an aggressive panhandler. UPD dispatch provided a description of the panhandler and he was contacted near the front of the store. The officer recognized the subject as James Miles age 38 and was aware that Miles had a probation warrant issued for his arrest. Miles was placed under arrest for the probation warrant and was booked into county jail. 16-1443

On May 19<sup>th</sup> at about 1:09 pm, UPD officers were dispatched to the MTA bus stop in the 200 block of North Orchard Avenue, regarding a physical altercation. Upon arrival UPD officers separated the involved parties, during which officers spoke with a subject identified as Thomas Sanders age 54. A records check revealed that Sanders was on probation with an "Abstention from Alcohol" clause. Sanders was found to be intoxicated and was placed under arrest for public intoxication and for violation of probation. Sanders was booked into county jail. 16-1450

Upon arrival officers spoke with a subject identified as Sean Lykes age 38, who told officers he had been in an argument with a friend and was leaving. A records check revealed that Lykes was on probation with a no alcohol clause. Lykes was found to be intoxicated and placed under arrest for violating his probation. Lykes was booked into county jail. 16-1456

The officer contacted the driver who identified herself as Rayann Lorenz age 23. As the officer spoke with Lorenz he suspected that Lorenz was intoxicated and began a DUI investigation. Lorenz was placed under arrest for DUI and later booked, cited and released with a court appearance date. 16-1462

On May 21<sup>st</sup> at about 3:11 am, UPD officers were dispatched to a residence in the 200 block of Ford Street, for a report of a vehicle break in. UPD dispatch advised that two male juveniles had broken a window of a vehicle in the area and fled toward Hamilton Drive. Upon arrival an officer located the victim vehicle, which was a white UMC panel van and spoke with a witness to the vandalism. An officer located a suspect to the vandalism in the area, who was identified as Ian Roberts age 18. Roberts had cuts on his hands and arms that were consistent with breaking the window. He was treated by ambulance personnel for his injuries. Roberts was found to be intoxicated and was linked to the vandalism. He was placed under arrest for public intoxication and vandalism. Roberts was booked into county jail. 16-1463

On May 21<sup>st</sup> at about 11:01 pm, a UPD patrol officer observed a subject he knows a Steven Green age 28. The officer was aware that Green had a misdemeanor warrant out of Sonoma County. Green was contacted, placed under arrest for the warrant and booked into county jail. 16-1466

On May 21<sup>st</sup> at about 11:52 pm, a UPD officer conducted an enforcement stop on a Dodge flatbed truck in the 100 block of East Stephenson Street for a traffic violation. The driver was identified as Travis Criss age 42, from Upper Lake. As the officer spoke with Criss he suspected that he was intoxicated and began a DUI investigation. Gonzalez was placed under arrest for the warrant and booked into county jail. 16-1468

The rider was identified as Brandy Schleper age 38. Schleper was found to be in possession of suspected methamphetamine and drug paraphernalia and was placed under arrest for the violations. Schleper was booked into county jail. 16-1473

On May 22<sup>nd</sup> at about 9:38 pm, a UPD officer was dispatched to the 400 block of East Gobbi Street for a report of several subjects causing a disturbance. Upon arrival the officer found two adult females at the location, one of them identified as Stephanie Milberger age 24. A records check revealed that Milberger had an active misdemeanor warrant for her arrest and she was taken into custody without incident. Milberger was booked into county jail. 16-1474

On May 23<sup>rd</sup> at about 11:20 am, a UPD officer performed a traffic stop on a blue SUV in the 500 block of South State Street. The driver was identified as Israel Sanchez Contreras age 30 and the passenger as Fernando Aguilar age 25. A records check revealed that Contreras was on probation and Aguilar had a misdemeanor warrant for his arrest. Aguilar was placed under arrest for his warrant and found to be in possession of drug paraphernalia. Aguilar was booked into county for the violations. Contreras was cited for a traffic violation and given a court appearance date. 16-1481

Guevara attempted to walk away and became extremely confrontational with the officer. The officer grabbed hold of Guevara who had become combative. Backup officers were requested. Guevara was taken into custody for the warrant and for resisting arrest. After his arrest Guevara was found to be in possession of multiple packages of methamphetamine and drug paraphernalia. A records check revealed that Guevara was on probation. Guevara was booked into county jail for possession of drug paraphernalia for sale, drug paraphernalia, resist arrest, violation of probation and the initial warrant. 16-1483

On May 23<sup>rd</sup> at about 7:16 pm, UPD officers were dispatched to the area of Ford and Sidnie Street, for a report of a female causing a disturbance and possibly under the influence of drugs. Upon arrival an officer attempted to contact a subject he knew as Edna Williams, age 39, who tried to walk away from him. Williams displayed the signs of being under the influence of a controlled substance and would not follow commands from the officer. Once another officer arrived, Williams had to be physically restrained. After being handcuffed, Williams tried to kick officers and her legs had to be restrained. A records check revealed that Williams was on probation. Williams was placed under arrest for being under the influence of a controlled substance, resisting arrest and violation of her probation. Williams was transported to Ukiah Valley Medical Center and after receiving a medical clearance was booked into county jail. 16-1484

On May 23<sup>rd</sup> at about 10:05 pm, a UPD officer was dispatched to Safeway on South State Street, regarding an intoxicated male subject outside of the store. Upon arrival the officer contacted a subject he knew as Scott Heidinger age 56. A records check revealed that Heidinger had two active warrants for his arrest.
