Highlights for the Week

On May 25th at about 7:10 am, a UPD officer performed an enforcement stop on a vehicle in the 1100 block of Airport Park Blvd., for a traffic violation. The driver was identified as Skyler Nunes age 20. A records check revealed that Nunes had a felony warrant out of Madera County and was driving without a license. Nunes was placed under arrest for the violations and was booked into county jail. 16-1505

On May 25th at about 9:08 pm, a UPD officer was in the 600 block of South State Street, when he observed a subject he knew as Danny Ray age 51, drinking from a silver can that he suspected was alcohol. The officer was also aware that Ray was on probation and the officer attempted to contact him. During the contact, Ray walked out into the middle of the street as the officer gave him verbal commands to stop. The officer had to physically restrain Ray, who was yelling and screaming at the officer. Once backup officers arrived Ray was taken into custody for being intoxicated in public, resisting an officer and violation of his probation. On May 26th at about 10:25 pm, UPD officers were dispatched to Ukiah Valley Medical Center, regarding a combative patient in the emergency room. Upon arrival officers were directed to a female, who was identified as Brenda Harden age 54. Harden was continuously screaming, being belligerent, and found to be intoxicated. Harden was placed under arrest for public intoxication and booked into county jail. 16-1523

On May 27th at about 12:55 am, a UPD officer on patrol in the 200 block of South Orchard Avenue contacted a subject behind a closed business. The subject was identified as Michael Hoisington age 32. Hoisington displayed the objective signs of being under the influence of drugs and the officer evaluated him for this. Hoisington was found to be in possession of hydrocodone without a prescription. Hoisington was placed under arrest for being under the influence of a controlled substance and for illegal possession of the hydrocodone pills. Hoisington was booked into county jail for the violations. 16-1524

On May 27th at about 2:30 pm, a UPD officer was dispatched to the 600 block of South Orchard Avenue, to investigate a disturbance involving two male subjects who were consuming alcohol and being loud. Upon arrival the officer contacted the two, who were identified as Nicholas Cruz age 23 and Joshua Smith age 29. Both were found to be extremely intoxicated, were placed under arrest for public intoxication and booked into county jail. 16-1526

On May 27th at about 5:06 pm, UPD officers were dispatched to Chevron in the 600 block of East Perkins Street regarding a battery that had just occurred. Upon arrival the officer contacted a subject he knew as Scotty Willis. Willis reported that he and Kevin Litzin age 44 had been involved in a physical altercation. Willis informed the officer that Litzin could be found behind CVS Pharmacy on South Orchard Avenue. Officers responded to the location and saw Litzin and another male subject named Charles Hensley age 52. Hensley was lying face down on the ground. A records check revealed that Litzin was on probation. Hensley and Litzin were found to be extremely intoxicated. Both were placed under arrest for public intoxication and Litzin additionally was charged with violation of his probation. Both were booked into county jail for the violations. 16-1530

On May 27th at about 11:00 pm, a UPD officer was dispatched to Wal-Mart parking lot for a report of a male subject causing a disturbance. It was reported that the male adult was hitting vehicles in the parking lot and had taken off his shirt. Upon arrival the officer located an adult male, with no shirt, lying on the pavement in the parking lot. The subject was identified as Johnny Green age 38. Green was bleeding from his right hand and smearing blood over his bare chest. Green was breathing heavily and appeared disoriented and confused. Once a backup officer arrived and ambulance personnel had treated Green for his injuries, the officer began an investigation into Green being under the influence of illegal drugs. Green was placed under arrest for being under the influence of a controlled substance and booked into county jail. 15-1535

On May 28th at about 2:35 am, a UPD officer performed an enforcement stop on a vehicle in the 600 block of South State Street for a traffic violation. The officer contacted the driver and immediately saw an open 32 oz. bottle of Bud Ice beer, behind the driver's seat on the floorboard. The driver was identified as Cody Carlsen age 24 and a records check revealed that Carlsen was unlicensed. The officer had Carlsen exit the vehicle and conducted a DUI enforcement investigation. Carlsen was placed under arrest for DUI and later booked, cited and released with a court appearance date. 15-1536

Press Release: Vehicle burglaries UPD Case # 16-1537, 16-1538, 16-1539

On May 28th in the morning hours, UPD Officers responded to three separate reported vehicle burglaries, which occurred near residences in the 100 block of Washo Drive, 800 block of Pomo Drive, and at the City of Ukiah softball fields in the 900 block of River Street. All three victims reported that they had secured their vehicles the day prior on May 27th in the late afternoon to early evening hours. The next morning on May 28th the victims found that forced entry had been made into their vehicles and property had been stolen. The property included construction tools, a black Easton softball backpack, men's Nike softball cleats, a black and grey softball glove and grey Easton softball bat. I'd like to take this time to provide some methods to reduce vehicle break-in:

- Always lock the doors of your vehicle, even when you leave your vehicle for a short time period.
- Never leave valuables inside your vehicle such as: Cell phones, GPS unit, purse or wallet, shopping bags, clothing, laptop, tablets, or sporting equipment or tools.
- Always roll up your windows when you leave your vehicle, even when it's parked in a driveway or garage.
- Never leave any documents, credit cards or checkbook in your vehicle.
- Park in well-lit locations and avoid isolated areas.
- Install an alarm.

Press Release: Grounds equipment and tool theft UPD case # 16-1550

On May 29th at about 11:34 am, a UPD officer was dispatched to the Ukiah Unified School District bus storage area in the 700 block of Maple Avenue, for a report of a burglary. Upon arrival the officer spoke with the Transportation Manager, who reported that before calling the police he arrived at the location and noticed the front gate lock had been removed. The manager was suspicious and began reviewing video surveillance. The manager noted on today's date at about 5:23 am, a subject ran across the parking lot towards the grounds equipment vehicles. A black GMC SUV is seen entering through the gate and several subjects are seen loading tools and equipment into the SUV. Reported stolen were 3 Stihl gas blowers model BR430m, a Craftsman combo wrench set, a 58 piece Craftsman wrench set, 3 gas cans, a Craftsman tool box, and misc. mechanic hand tools, with a reported total loss of around \$3,000.00. The case has been sent to the Ukiah Police Department Detective Division and is under investigation. On May 29th at about 4:26 pm, UPD officers were dispatched to the 800 block of Waugh Lane, on a report of a disturbance. It was reported that Ashley Lynne Espinosa age 30 had struck Melissa Louise Gott age 44 in the head. Gott was requesting medical attention due to an injury from the assault. During the investigation officers learned that Espinosa and Gott were engaged in an argument, that turned physical when Espinosa struck Gott in the head with a purse. Gott received a laceration to her forehead from the assault and Espinosa was placed under arrest and booked into jail for the assault. 16-1553

On May 29th at about 5:13 pm, a UPD officer was dispatched to a residence in the 100 block of Gibson Street, for a report of a male trying to open a garage door to a residence, where he didn't reside. Upon arrival the officer spoke with the witness, who reported that the suspect had left prior to UPD arriving. The suspect was last seen on North Oak Street and was wearing a black shirt and grey pants. The officer began searching the area for the suspect and located a subject matching the description at the intersection of North Bush Street and Low Gap Road. The subject was identified as Eric Garcia age 26, from Redwood Valley. A records check revealed that Garcia was on probation for a prior vehicle theft. A witness identified Garcia as the subject who had tried to gain entry into the garage and he was placed under arrest for prowling and for violation of his probation. Garcia was booked into county jail. 16-1555

On May 29th at about 6:10 pm, a UPD officer was dispatched to Safeway on South State Street, on a report of an assault. Upon arrival the officer spoke to an adult male victim, who was complaining of pain in his ribs and had bleeding from his left ear. The victim reported that he was consuming alcohol by the railroad tracks approximately 50 yards south of E. Gobbi Street. The victim stated that out of nowhere an unknown white male subject struck him in the head with a rock and began to physically assault him. The suspect punched and kicked the victim repeatedly. The victim was intoxicated and transported to UVMC via ambulance to be treated for his injuries. A description of the suspect was provided by the victim and officers responded to the scene in an attempt to locate the suspect. Upon arrival officers contacted a subject

known as Johnny Green age 39, which matched the description given. The officers were aware that Green was on CDC Parole and that he had an extremely violent history. Green was found to be intoxicated and during the investigation was placed under arrest for assault with a deadly weapon, violation of his parole, and for being intoxicated in public. Green was booked into county jail. 16-1556

On May 29th at about 11:33 pm, UPD officers responded to Alex Thomas Plaza for a report of a subject starting a small fire near the north side of the plaza. Upon arrival the officer contacted and spoke with a witness, who reported that prior to police being called he had been sitting on a bench in the plaza. The witness observed a bright light coming from the bathroom area, which caught his attention. The victim noticed a fire with flames 2 feet tall near the bathrooms, and observed a subject walk away. The witness provided a description to the officer and advised the fire extinguished itself. The suspect was located nearby and was identified as Craig Jones age 49. Evidence linked Jones to the fire and he was placed under arrest for Arson. Jones was booked into county jail. 16-1559

On May 30th at about 10:43 pm, a UPD officer was dispatched to a business in the 500 block of South State Street, for a report of an adult female block the entrance to the front of the store. Upon arrival the officer contacted Cruz Rea age 55. As the officer spoke with Rea she was found to be extremely intoxicated and a records check revealed that she was on probation. Rea was placed under arrest for public intoxication and for violation of her probation. Rea was booked into county jail. 16-1560

Press Release: Theft of an America Flag UPD case # 16-1561

A witness reported seeing a white female adult with blonde hair ride by his house on a bicycle with an American Flag and pole. The female suspect was seen entering a residence on Cherry Court that the alert citizen was able to identify. During the investigation the officer located the suspect inside the residence and identified her as Odessa O'Neil age 41 from Ukiah. The stolen Memorial Day America Flag was recovered and O'Neil was placed under arrest for possession of stolen property. O'Neil was booked into county jail for the violation and the Flag and Pole were returned to the Veteran's Memorial Building.
