The Patrol Division's average response time to in-progress calls was a little under 4 minutes. The average response time to all other calls was a little under 10 minutes.

### Highlights for the Week

On June 9<sup>th</sup> at about 10:21 am, a UPD officer was dispatched to Safeway, to assist MedStar Paramedics with an aggressive transient. Upon arrival the officer contacted Justin Peacock age 30. A records check revealed that Peacock was on probation, with a term to "Abstain" from alcohol. As the officer spoke with Peacock, he was found to be extremely intoxicated. Peacock was placed under arrest for public intoxication and for violating his probation. Peacock was booked into county jail. 16-1673

On June 9<sup>th</sup> at about 11:51 am, a UPD officer was dispatched to the area of East Perkins and Main Street, regarding a male subject walking into traffic. While en-route, dispatch advised the officer that the male subject was now headed to Alex Thomas Plaza, on South State Street. On June 9<sup>th</sup> at about 4:45 pm, a UPD officer was dispatched to a Lingerie Boutique in the 100 block of West Church Street, on a report of a male subject exposing himself. Upon arrival the officer contacted and spoke with the owner of the business. The owner reported that about at 4:30 pm, a male subject entered the business and began asking questions about women's lingerie he was looking to purchase for a party. The subject continued shopping and at a point entered the changing booth. A short time later the male subject exited the changing booth wearing a black lingerie top, but was completely naked from the waist down, exposing his private parts. The male subject approached and talked with the owner, before going back into the changing booth. The male subject exited the changing booth and left the store clothed. The male suspect was described as a white male adult, approximately 30-40 years old. He was approximately 6'2" tall, thin build, with a scruffy beard. The suspect had short and curly dirty blonde hair, wearing tan pants with a dark shirt. Additionally, the suspect smelled of marijuana. 16-1678

On June 9<sup>th</sup> at about 7:43 pm, a UPD officer on patrol in the 500 block of South State Street, observed a subject he knew as Scotty Willis age 33. The officer was aware that Willis had an active misdemeanor warrant for his arrest and contacted him. Willis was placed under arrest for the warrant and booked into county jail. 16-1679

On June 9<sup>th</sup> at about 9:22 pm, a UPD officer on patrol in the 500 block of East Perkins Street, observed a subject he knew as Aleshia Tuttle age 43. The officer was aware that Tuttle had an active misdemeanor warrant for her arrest and contacted her. Tuttle was placed under arrest for the warrant and booked into county jail. 16-1680

On June 10<sup>th</sup> at about 1:10 am, a UPD officer performed an enforcement stop on a bicyclist in the 500 block of Stella Drive. The rider was identified as Juan Rodriguez age 43. A records check revealed that Rodriguez was on probation, with search and seizure terms. Rodriguez was found to be in possession of methamphetamine. A records check revealed that Ray was on probation with a "No alcohol" clause, from a prior DUI and theft. The officer attempted to obtain an in the field alcohol breath test from Ray, but he became belligerent. Ray was placed under arrest for violation of his probation and booked into county jail. 16-1689

On June 10<sup>th</sup> at about 6:07 pm, a UPD officer was dispatched to Kohl's in regards to a shoplifter who had just fled the location. Upon arrival a loss prevention employee directed the officer to the suspect, who was now near Ross Dress for Less. The officer contacted the suspect, who was identified as Kristopher Sparkman age 33. A records check revealed that Sparkman was on probation and had 3 active misdemeanor warrants for his arrest. The officer learned from loss prevention that Sparkman stole 4 pairs of shorts from the store before he fled. The shorts were recovered from Sparkman

and he was placed under arrest for shoplifting, violation of his probation, and the outstanding warrants. Sparkman was booked into county jail. 16-1692

On June 10<sup>th</sup> at about 10:03 pm, a UPD officer performed an enforcement stop on a vehicle in at the entrance to Hwy 101, at Talmage. The driver of the vehicle was identified as Niko Steffen age 35. As the officer spoke with Steffen he suspected that Steffen was intoxicated and began a DUI investigation. Steffen was placed under arrest for DUI and booked into county jail. 16-1693

On June 10<sup>th</sup> at about 11:07 pm, a UPD officer was dispatched to an apartment in the 600 block of North Orchard Avenue for a report of a fight in progress involving two males. During the investigation the officer learned that Rafael Maldonado age 22 had threatened to stab members of his family with a screwdriver. A records check revealed that Maldonado was on probation. Maldonado was located and found to be in possession of drug paraphernalia. Maldonado was placed under arrest for criminal threats, possession of drug paraphernalia, and violation of his probation. Maldonado was booked into county jail. 16-1695

On June 11<sup>th</sup> at about 1:16 am, a UPD officer was dispatched to Rite Aid, to investigate a report of a suspicious vehicle. UPD dispatch advised that the vehicle was parked for about four hours and the lights had gone on and off several times. Upon arrival officers found two subjects sleeping inside of the vehicle, one of which was identified as Carol Curtiss age 32. A records check revealed that Curtiss was on probation, with search and seizure terms. Curtis was found to be in possession of drug paraphernalia and Heroin. As the officer spoke with Ray regarding his behavior, he noticed that Ray appeared intoxicated. Ray was placed under arrest for violation of his probation. 16-1703

On June 12<sup>th</sup> at about 6:37 am, a UPD officer was dispatched to Observatory Avenue, on a report of two suspicious male subjects carrying a television walking westbound. A description was provided and the officer located the two in the area. One of the subjects was identified as Scott Franks age 29. Franks and the subject he was with told the officer that they had found the television in a dumpster. A records check revealed that Franks was on felony probation with a "No dangerous weapons clause, including knives and no gang clothing". Franks was found to be in possession of a knife and wearing gang type clothing in violation of his probation and was placed under arrest. Franks was booked into county jail. 16-1708

On June 12<sup>th</sup> at about 10:12 am, a UPD officer was dispatched to a parking lot in the 1200 block of Airport Park Blvd., for a report of three subjects associated with a white sedan, who left garbage outside of the vehicle. The officer spoke with the owner of the vehicle, who was identified as Shawn Wilson age 35. A records check revealed that Wilson was on probation, for a prior stolen vehicle case. Upon arrival officers spoke with both involved parties, one of which was identified as Neviah Sidham age 47. While taking with Sidham regarding the dispute, she was found to be extremely intoxicated. Sidham was placed under arrest for public intoxication and booked into county jail. 16-1714

On June 12<sup>th</sup> at about 10:39 pm, UPD officers were dispatched to the parking lot of Motel 6 on South State Street, regarding a hit and run traffic collision, wherein the driver of the suspect vehicle was possibly intoxicated. Upon arrival officers located one of the involved vehicles. The driver of the car that had caused the collision was located hiding in nearby bushes. The driver was identified as Noe Espitia age 32. A records check revealed that Espitia was on probation with terms of "Shall not refuse BAC test" and "Shall not drive a vehicle with alcohol in blood". During the investigation the officer determined that Espitia was intoxicated driving his vehicle in the parking lot and his 2 year old son was a passenger. During a backing maneuver, Espitia collided with a parked car. Espitia then left the scene making no attempt to contact the owner of the parked vehicle. Espitia was placed under for DUI, hit and run, violation of his probation, and child endangerment. Espitia was booked into county jail. 16-1715

On June 13<sup>th</sup> at about 1:44 am, a UPD officer was dispatched to a residence in the 600 block of Willow Avenue, for a report of a vandalism that had just occurred. Upon arrival the officer spoke to the resident and victim. The victim reported that she and her family were inside their residence, when she heard the sound of something hitting the side of her residence, and then heard her front window break. The victim went to investigated and found a rock had been thrown through the window. 16-1716

On June 13<sup>th</sup> at about 10:06 am, a UPD officer was dispatched to the 700 block of South State Street, for a report of a female subject causing a disturbance. Upon arrival the officer contacted the subject, who he recognized as Janie Kaaihue age 47. Kaaihue was extremely agitated and was screaming obscenities. Kaaihue was found to be intoxicated and placed under arrest for public intoxication. Kaaihue was booked into county jail. 16-1720

The adult female victim reported that she and her boyfriend were arguing because Carrillo wanted to take their baby and she did not want him to. The argument turned physical when Carrillo grabbed their baby while the victim was holding him and tried to pull the baby away. Through the struggle the victim was able to hold onto the baby and both the victim and Carrillo received minor injuries from the altercation. A records check revealed that Carrillo was on parole. Carrillo was placed under arrest for child endangerment and for violation of his Parole. Carrillo was booked into county jail. 16-1725

Press Release: Adult female steals medical equipment arrested

On June 14<sup>th</sup> at about 8:45 in the morning, UPD officers were dispatched to a residence in the 1000 block of North Pine Street, for a report of a female subject who stole a package from their front porch. The dispatcher was able to obtain a very good description of the suspect from the victim and provided that information to responding units. Officers checked the area and located the suspect in the 1200 block of North Pine Street and detained her. The suspect was identified as Wana Matthias age 29 and a records check revealed that she was on probation for a prior theft. During the investigation officers learned that prior to police being called, the victim was inside her residence when she heard her dog barking. The victim looked out her front window and noticed Matthias walking her bicycle down the handicap ramp attached to her front porch. The victim noticed that Matthias had stolen a package from her porch. The package contained an Intralite feeding tube pump for the victim's disabled son valued at \$1,100.00. As Matthias left the victim was able to photograph her and provided the photo to officers. The stolen property was recovered and Matthias was placed under arrest for grand theft and violation of her probation. Matthias was booked into county jail.

I would like to take this opportunity to provide some tips to protect you from a home delivery theft:

- *If you are not going to be home, think about sending the package to the residence of a trusted friend or relative, who you know will be home.*
- *Ask the package delivery company to hold the package if you will not be home.*
- *Request that your package is marked "signature required".*
- *Sometimes you can leave special instructions on where to deliver the package, so that it is out of sight.*
- *Use a company that provides a tracking service and check online to see when your package is scheduled to arrive.*
- *If you have an understanding boss, have your package delivered to your work.*
- *If something is suspicious notify your local police.*
