Arrests included: 7 warrants, 5 drunk in public, 1 possession of a controlled substance / parole violation, 4 DV arrests, 1 possession of a controlled substance / possession of drug paraphernalia, 2 VOPs, 1 DUI / hit and run, 1 possession of a controlled substance, 1 drunk in public / VOP, 1 false identification / warrant, 1 DUI / drive on expired license, 2 VOP / false identification, 1 battery, 1 under the influence of a controlled substance, 1 possession of a controlled substance / possession of drug paraphernalia / VOP, 1 possession of a controlled substance / VOP, 1 VOP / unlawful camping

Officers investigated and took reports of: 4 found property, 3 search warrants, 3 abandon auto tows, 1 court order violation, 3 CPS cross reports, 3 vandalisms, 1 APS cross report, 1 attempted burglary, 1 unlawful marijuana grow, 1 cited for assault with pepper spray, 1 agency assist report, 4 cited for unlawful camping, 2 traffic collisions, 1 dog bite, 4 warrants cited in the field, 2 thefts, 2 burglaries, 1 battery / hate crime investigation, 1 documentation report, 1 issued in error.

The Patrol Division's average response time to in-progress calls was a little over 5 minutes. The average response time to all other calls was a little under 10 minutes.

Highlights for the Week

On June 15th at about 10:00 am, a UPD officer on patrol performed an enforcement stop on a bicyclist in the 1400 block of North State Street. The rider was identified as Vincent Hernandez age 51. A records check revealed that Hernandez was on CDC parole. Hernandez was found to be in possession of methamphetamine and placed under arrest. Hernandez was booked into jail for possession of a controlled substance and for violation of parole. 16-1740

On June 15th at about 10:14 am, a UPD officer on patrol was driving through the parking lot of Ukiah Natural Foods in the 700 block of South State Street, when he saw a subject he knew as Sean Lykes age 38. The officer was aware that Lykes had an active warrant for his arrest. Lykes was contacted and placed under arrest without incident. Lykes was booked into county jail. 16-1741

On June 15th at about 3:16 pm, UPD officers were dispatched to a residence in the 100 block of Evans Street to investigate a domestic assault. Upon arrival an officer contacted a 27 year old female subject, who was crying hysterically and covered in grey paint. The adult female reported that during a verbal argument her boyfriend Jacob Parker age 35, poured

grey paint on her head. Officers located and arrested Parker for the domestic assault. During that arrest, Parker was found to be in possession of drug paraphernalia and methamphetamine. Parker was booked into jail for the violations. 16-1747

On June 15th at about 8:42 pm, a UPD officer on patrol in the 300 block of Cooper Lane contacted a female, who was identified as Wilma McCraken age 45. McCraken was found to be in possession of methamphetamine and drug paraphernalia. McCraken was cited in the field with a court appearance date for the violation. 16-1748

On June 16th at about 9:22 am, a UPD officer was dispatched to South State Street and Clay, regarding a female subject walking in the road causing a hazard. Upon arrival the officer contacted the female, who he recognized as Joy Davidson age 39. A records check revealed that Davidson was on probation with an "Abstain from alcohol" clause. As the officer spoke with Davidson, he suspected that she was intoxicated. Davidson completed an in the field alcohol screening test, results being .14% BAC. Davidson was placed under arrest for violation of her probation and booked into county jail. 16-1751

Press Release: Hit and Run / DUI drug arrest UPD case # 16-1752

On June 16th at about 10:26 am, UPD officers were dispatched to the area of School Street and Perkins, regarding a hit and run traffic collision call. Officers were advised that the reporting party was following the suspect's vehicle, which was located in the 400 block of South Oak Street. A UPD officer performed a traffic stop on the suspect's vehicle and contacted the driver, who was identified as Michael Eldridge age 25. As the officer spoke with Eldridge about driving away from the traffic collision, the officer suspected that Eldridge was under the influence of some type of intoxicant and began a DUI investigation. During this investigation it was determined that Eldridge was impaired by being under the influence of nitrous oxide when he caused the collision and drove off. Additionally, over 1,000 used small canisters of nitrous oxide were located inside his vehicle. Eldridge was placed under arrest for the hit and run traffic collision and DUI drugs. The case will also be reviewed for the additional charge of driving a motor vehicle while being addicted to drugs. Eldridge was booked into county jail. 16-1752

I would like to take this opportunity to provide some tips in reporting a suspected DUI driver:

- *Use a hands free type device to call 911 and tell the dispatcher you suspect a driver maybe impaired. (If you don't have a hands free device, safely pull over, park and then make the call).*
- *Be aware that you will be asked questions such as your location, the suspect vehicle location, direction of travel, vehicle description, license plate number, manner in which the vehicle is being driven, etc...Be patient with the dispatcher as they are often talking with you and dispatching officers to respond at the same time.*
- *Don't follow too close to the suspected impaired driver or attempt to stop the suspect vehicle yourself.*

On June 16th at about 10:59 pm, a UPD officer was dispatched to a report of a male subject, who had entered a residence in the 800 block of Cindee Drive. The subject appeared intoxicated, sat down on a couch and was not known to the resident. When confronted by the resident the suspect fled and was located by police in the area. The subject was identified as Pedro Reynaga age 33, who was found to be extremely intoxicated. Reynaga was placed under arrest for public intoxication and booked into county jail. 16-1762

On June 16th at about 11:23 pm, a UPD officer contacted a subject in the 500 block of Peach Street. The officer identified the subject as Johnny Casteneda age 27. Casteneda was found to be in possession of methamphetamine and placed under arrest. Casteneda was booked into county jail for possession of a controlled substance. 16-1764

On June 17th at about 11:45 am, a UPD officer was dispatched to the south side of Home Deport on North Orchard Avenue, regarding a subject acting suspicious. The officer contacted a subject he knew as Charles Hensley age 52. A records check revealed that Hensley was on probation. Hensley was found to be intoxicated and placed under arrest for violation of his probation and public intoxication. 16-1768

On June 17th at about 3:57 pm, a UPD officer was dispatched to the Dialysis Clinic on South Orchard Avenue, on a report of loud music near the building causing a disturbance. The officer located and spoke with Kate Kummer age 29. Upon contact of Kummer she provided the officer with a false name. When she was identified the officer learned that Kummer had an active misdemeanor warrant for her arrest for past drug offences. Kummer was placed under arrest for providing a false name to an officer and for the warrant. Kummer was booked into county jail. 16-1770

On June 17th at about 8:34 pm, a UPD officer on patrol in the 200 block of Talmage Road, observed a subject he knew as John Zerangue age 45. The officer knew that Zerangue was on probation out of Placer County as well as Mendocino County. The officer contacted Zerangue and a records check revealed that he had an active felony warrant out of Placer Co. for a drug violation. Zerangue was placed under arrest for the drug violation and booked into county jail. 16-1772

On June 17th at about 10:00 pm, a UPD officer on patrol performed an enforcement stop on a red Camaro in the 100 block of Washington Avenue, for traffic violations. The driver was identified as Sylvester Estrada age 37. A records check revealed that Estrada's license was expired. As the officer spoke with Estrada he suspected that Estrada was intoxicated and began a DUI investigation. Estrada was placed under arrest for DUI and driving on an expired license. Estrada was booked into county jail for the violations. 16-1773

On June 18th at about 3:05 am, a UPD officer was dispatched to the 500 block of South State Street on a report of a male subject yelling in the area. Upon arrival the officer located the subject he recognized as Michael Beers age 37, who was now in Alex Thomas Plaza. Beers was not wearing any shoes, was wet from the rain and shivering. Beers admitted to recently taking Lorzaepam, Hydrocodone and drinking alcohol. Beers was found to be too intoxicated to be in public and was placed under arrest for public intoxication. Beers was booked into county jail. 16-1774

On June 18th at about 9:30 pm, UPD officers were dispatched to a residence on Lorraine Street, regarding a physical fight. After interviewing all parties involved, it was determined that a male adult identified as Jacob Malugani age 27 had struck his girlfriend's sister in an altercation. The sister signed a citizen's arrest form and Malugani was placed under arrest for battery. Malugani's friend, Jesse Holberg age 25, was at the location and found to be extremely intoxicated. Holberg was placed under arrest for public intoxication and both were booked into county jail. 16-1779

On June 20th at about 3:50 pm, UPD officers were dispatched to a residence on Lorraine Street, for a report of an unknown male subject standing on the front porch of the residence vomiting. Upon arrival officers contacted the subject the subject, who was sweating and not wearing a shirt. The subject was identified as Kristopher Sparkman age 33, who was found to be on probation for prior drug offences. Sparkman did not live at the residence, was very confused, and displayed mood swings. It was determined that Sparkman was under the influence of a controlled substance and was placed under arrest for the violation. Sparkman was booked into county jail for the violations. 16-1795

On June 21st at about 3:24 am, a UPD officer on patrol in the 1100 block of South Dora Street, observed a green Honda Accord parked along the east curb of the street. The officer observed that there was a subject inside the vehicle and contacted her. The subject was identified as Carley Schlapkohl age 30 and a records check revealed that Schlapkohl had an active misdemeanor warrant for her arrest. Schlapkohl was placed under arrest for the warrant and booked into county jail. 16-1797

On June 21st at about 4:37 pm, a UPD officer was dispatched to Pacific Outfitters on North State Street, in regards to a female subject harassing customers. Upon arrival the officer contacted a subject he knew as Joy Davidson age 40. A records check revealed that Davidson was on probation and she was found to be in possession of methamphetamine. Davidson was placed under arrest for possession of a controlled substance and for violation of her probation. Davidson was booked into county jail. 16-1805

On June 22nd at about 1:49 am, a UPD officer on patrol was checking a filed on the north side of Lewis Lane when he contacted a male subject. The subject was identified as Thomas Cook age 53, and a records check revealed that Cook was on probation with an "Abstain from alcohol" clause. Cook was found to be intoxicated, placed under arrest for violation of his probation and booked into county jail. 16-1807
