Arrests included: 9 warrants, 4 public intoxication / VOP, 1 under the influence of a controlled substance, 1 court order violation / warrant, 2 public intoxication, 1 under the influence of a controlled substance / possession of a controlled substance, 3 domestic assaults, 1 possession of drug paraphernalia / under the influence of a controlled substance, 1 public intoxication / court order violation, 2 DUIs, 1 drug paraphernalia / VOP, 1 vandalism

Officers investigated and took reports of: 9 found property, 9 CPS cross reports, 1 issued in error, 1 assault with a deadly weapon, 1 abandon vehicle tow, 2 APS cross reports, 2 mental health commitments, 3 for unlawful camping, 2 issued in error, 2 dog bites, 2 vehicle tows, 1 use of force, 1 credit card fraud report, 4 non-injury traffic collisions, 1 burglary report, 2 cited for marijuana on school grounds, 1 vehicle tampering, 2 warrants cited in field, 1 missing person, 1 vandalism, 1 domestic investigation,

The Patrol Division's average response time to in-progress calls was a little under 4 minutes. The average response time to all other calls was a little under 11 minutes.

Highlights for the Week

On June 22nd at about 10:10 am, a UPD officer, along with probation officers, went to a room at the Sunrise Inn, to conduct a probation search. During the search an officer contacted a subject who was identified as Lorenzo Martinez age 33. A records check revealed that Martinez had 2 Felony and 1 misdemeanor warrant for his arrest. One of the felony warrants was for a Parole violation out of Sacramento. Martinez was placed under arrest and booked into county jail. 16-1812

On June 22nd at about 1:16 pm, a UPD officer was dispatched to the south parking lot of the Regal 6 Cinemas on South State Street, regarding multiple transients in the bushes near the business. Upon arrival the officer contacted John Bolton age 40, Michael Donahe age 61, and Emery Ellingwood age 60. All three subjects were found to be extremely intoxicated and a records check revealed that Bolton and Donahe were on probation. All three subjects were placed under arrest for public intoxication and booked into county jail. Bolton and Donahe were additionally charged with violating their probation. 16-1815

On June 22nd at about 2:11 pm, two UPD Detectives were following up on a case and responded to a residence on Sanford Ranch Road. At the residence they contacted Jordan Shaw age 19. The Detectives were aware that Shaw had a felony warrant for his arrest. Shaw was taken into custody without incident and booked into county jail. 16-1818

On June 22nd at about 9:03 pm, a UPD officer was dispatched to an apartment in the 800 block of Waugh Lane, regarding an unwanted male subject harassing the reporting party. The subject was located in the courtyard of the complex and identified as Jonathan Larsen age 19. As the officer spoke with Larsen he suspected that Larsen was under the influence of drugs and evaluated him for this. Larsen was placed under arrest for being under the influence of a controlled substance and booked into county jail. 16-1821

On June 23rd at about 11:55 am, UPD officers were dispatched to a residence in the 1300 block of Berkley Way, regarding an unwanted subject refusing to leave the property. Upon arrival officers contacted two male subjects that were sitting in a red truck. One subject was recognized by an officer as Beau Benjamin age 26. A records check revealed that Benjamin had 5 warrants out of this county for his arrest and 1 out of Humboldt County. Benjamin was taken into custody for the warrants. The other male subject was identified as Peter Cole age 53. A records check revealed that Cole had two warrants for his arrest out of Sonoma County and he was taken into custody. While dealing with the two warrant suspects, a female exited the residence. Officers on the scene recognized the female as Lauretta Long age 43. Officers were aware that Long had a warrant for her arrest and she was taken into custody. All subjects were booked into county jail. 16-1827

On June 23rd at about 6:55 pm, a UPD officer was dispatched to the 100 block of Cherry Street, to investigate a disturbance. Dispatch advised the officer that the male subject was not wearing a shirt and challenging people to fight. Upon arrival the officer contacted the subject, who was identified as James Brown age 50. The male subject was belligerent, resistive and was extremely intoxicated. The male subject was placed under arrest for public intoxication and booked into county jail. 16-1830

On June 23rd at about 11:37 pm, a UPD officer on patrol in the 1300 block of North State Street, noticed a male subject walking on the east sidewalk. The officer recognized the subject as Alan Pollick age 36. Pollick was screaming and yelling and was staggering back and forth as he walked. The officer contacted Pollick and a records check revealed that Pollick was on probation for a prior sex crimes conviction, with a term of consume no alcohol. Pollick was placed under arrest for public intoxication and violation of his probation. Pollick was booked into county jail. 16-1832

On June 24th at about 7:52 am, UPD officers were dispatched to Denny's on Pomeroy, for a report of a suspicious male subject. Upon arrival officers were directed to a male subject who was identified as Robert Berg age 38. As officers spoke with Berg he displayed erratic behavior and paranoia, so he had to be detained in handcuffs. Berg was found to be under the influence of a controlled substance and in possession of methamphetamine. Berg was placed under arrest and booked into county jail for the violations. 16-1834

On June 24th at about 9:42 am, UPD officers were dispatched to Umpqua Bank in the 600 block of South State Street, for a report of two subjects involved in a physical altercation. Officers spoke with an adult female subject, who reported that she and her boyfriend Michael McGee age 28, had been involved in a verbal argument. The argument turned physical when McGee began hitting her in the right shoulder and right eye. The victim was able to get away from McGee and go into the bank for assistance. The victim sustained minor injuries to her face and shoulder. McGee was placed under arrest for the domestic assault and booked into county jail. 16-1838

On June 24th at about 4:42 pm, a UPD officer contacted a male subject in the 300 block of South State Street, because he appeared intoxicated. The subject was identified as Justin Peacock age 30. A records check revealed that Peacock was on probation with an "Abstain from alcohol" clause. Peacock was placed under arrest for public intoxication and booked into county jail. 16-1839

On June 24th at about 6:18 pm, a UPD officer was dispatched to the 500 block of South Main Street, on a report that an ambulance crew had observed a male subject using illegal narcotics. The subject was contacted and identified as Jason Kull age 37. Kull was found to be under the influence of a controlled substance and in possession of drug paraphernalia. Kull was placed under arrest and booked into county jail. 16-1840

On June 25th at about 8 am, a UPD officer observed two subjects lying in the parking lot of Wal-Mart sleeping. The subjects were in sleeping bags and surrounded by personal property. The officer woke the two, who were identified as Christopher Filbert age 39 and Debbie Mcosker age 30. A records check revealed that Filbert had an active misdemeanor warrant out of Lake County. Filbert was placed under arrest and booked into county jail for the warrant. Mcosker was cited for unlawful camping. 16-1845

On June 25th at about 9:11 pm, a UPD officer on patrol in the 200 block of Observatory Avenue, observed a subject he knows as Noe Perez age 27. The officer was aware that Perez had an active warrant for his arrest. The officer contacted Perez and placed him under arrest without incident. Perez was booked into county jail. 16-1649

On June 26th at about 2:11 am, a UPD officer performed an enforcement stop on a white Chevy Blazer, in the 500 block of North State Street for traffic violations. The driver was identified as Ventura Garcia-Escamilla age 26 and a records check revealed that he did not have a license. As the officer spoke with Garcia-Escamilla, he suspected that Garcia-Escamilla was possibly intoxicated, so the officer began a DUI investigation. Garcia-Escamilla was placed under arrest for DUI and booked into county jail. 16-1853

On June 26th at about 2:08 am, a UPD officer performed an enforcement stop on a vehicle in the 800 block of North State Street, for traffic violations. The driver was identified as Sebastian Novoa age 18. As the officer spoke with Novoa, he suspected that Novoa was possibly intoxicated so the officer began a DUI investigation. Novoa was placed under arrest for DUI and booked into county jail. 16-1854

On June 26th at about 7:48 pm, UPD officers were dispatched to a residence in the 300 block of Clara Avenue, regarding a physical domestic. Upon arrival officers contacted the involved parties and a witness. Officers learned that an adult female and her boyfriend Oscar Bernal age 27, were involved in a verbal argument. The argument turned physical when Bernal wanted his girlfriend to leave with him and she refused. Bernal reportedly grabbed hold of the victim's arms and began to forcefully pull her away from the residence. A witness intervened and separated the two. The victim received minor injuries from the assault. Bernal was placed under arrest for the domestic assault and booked into county jail. 16-1859

On June 27th at about 11:34 am, UPD officers were dispatched to the 100 block of North Orchard Avenue for a report of a domestic assault. UPD dispatch advised responding officers that a female subject tried to hit a male subject with a bottle. Officers located the two involved parties and began an investigation. Officers learned that an adult male victim was at the intersection of East Perkins and North Orchard Avenue, waiting on a walk signal to proceed across the intersection. The

victim noticed his ex-girlfriend Cherri Roberts age 39, running toward him yelling and screaming. As she got closer, the victim noticed that Roberts had a bottle in her right hand, which she swung and hit the victim with on the right side of his face. The Jack Daniels bottle left the victims grasp, hit the sidewalk and broke. The victim received a minor injury from the assault and refused medical treatment. Roberts was placed under arrest for the domestic assault and booked into county jail. 16-1863

On June 27th at about 3:36 pm, a UPD officer was dispatched to Kohls on North Orchard Avenue, for a report of a suspicious female. Upon arrival the officer spoke with loss prevention, who reported that a subject known as Teresa Smith age 34 was inside a dressing room. The employee reported that Smith had been caught shoplifting at Kohls on multiple occasions and he was concerned about what she may be doing. A records check revealed that Smith had 4 misdemeanor warrants for her arrest, from prior theft and drug offences. Smith was contacted, placed under arrest for the warrants and booked into county jail. 16-1865

On June 27th at about 6:14 pm, a UPD officer was dispatched to the lobby of the Ukiah Police Department, regarding a subject who had a warrant wishing to turn herself in. Upon arrival the officer contacted and spoke with Haley Casey age 21. A records check revealed that Casey had a misdemeanor warrant for her arrest and she was taken into custody without incident. Casey was booked into county jail. 16-1866

On June 28th at about 1:40 pm, a UPD officer was dispatched to a verbal argument near Star's Restaurant on South Orchard Avenue. Upon arrival the officer contacted a subject he recognized as Jake Gouber age 48 and an adult male victim. The officer learned that the victim was traveling eastbound on East Perkins Street when Gouber walked out in traffic. A vehicle traveling westbound had to slam on her brakes, to keep from hitting Gouber. Gouber became angry at the driver and started yelling. The victim had stopped his vehicle and Gouber threw a bottle at his vehicle, damaging the driver's door. The victim's vehicle was new and did not even have license plates yet. A records check revealed that Gouber was on probation with a term of "Obey all laws". Gouber was placed under arrest for vandalism and for violating his probation. Gouber was booked into county jail. 16-1877
