The Patrol Division's average response time to in-progress calls was a little under 4 minutes. The average response time to all other calls was a little under 11 minutes.

Highlights for the Week

On June 29th at about 7:22 am, UPD officers were dispatched to Vinewood Park on Elm Street, for a report of a female causing a disturbance, yelling and screaming while slamming her shopping cart against the public bathrooms. Upon arrival officers located a subject recognized as Deborah Lawrence age 50. A records check revealed that Lawrence was on probation, with terms of "Submit to search and seizure". Lawrence was and displaying erratic behavior, and was suspected of being under the influence of the stimulant methamphetamine. Lawrence was also found to be in possession of methamphetamine. Lawrence was placed under arrest for public drug intoxication, possession of a controlled substance and violation of her probation. Lawrence was booked into county jail. 16-1881

On June 29th at about 9:07 am, a UPD officer was dispatched to a residence in the 100 block of Clara Street, regarding a stolen vehicle report. The victim reported that on June 28th at about 5:30 pm, her blue Honda Civic was left unlocked in front of her residence. The following morning at about 9 am, she noticed that her vehicle was missing. At about 11:41 pm UPD officers were dispatched to the 100 block of Zinfandel Drive, on a report that MCSO deputies had located the stolen vehicle and had the driver detained. A UPD officer contacted the driver, who was identified as Antoine Moore age

37. Moore was placed under arrest for possession of the stolen vehicle and booked into county jail. The victim responded to the scene and her vehicle was released to her. 16-1884

On June 29th at about 3:19 pm, UPD officers were dispatched to an apartment in the 600 block of North State Street, for a report of a possible domestic disturbance. During the investigation, officers located and identified a subject by the name of Jesse James Rodriguez age 39. Upon first contact, Rodriguez attempted to conceal his identity by providing a false name, but an officer recognized him from prior contacts. A records check revealed that Rodriguez had 3 Felony warrants for his arrest, one out of Mendocino County, one out of Sonoma County and one out of Eureka. Rodriguez was placed under arrest for the warrants and booked into county jail. 16-1894

On June 30th at about 9:16 am, UPD officers were dispatched to the Court House on North State Street, regarding a late report of a domestic assault. Both parties had been separated and were located in the District Attorney's office. A male adult victim reported that he was with his girlfriend Angela Furia age 41, staying at the Sunrise Inn on South State Street. At about 3am in morning, they became involved in a verbal argument that then turned physical when Furia assaulted the victim causing minor injuries. Furia was placed under arrest and booked into county jail. 16-1904

On June 30th at about 4 pm, a UPD officer on patrol in the 700 block of South State Street performed an enforcement stop on a vehicle for traffic violations. The driver was identified as Jennifer Gilbert age 42. A records check revealed that Gilbert had a Felony warrant out of Butte County for violation of her probation. Gilbert was placed under arrest and booked into county jail. 16-1908

On June 30th at about 9:46 pm, UPD officers were dispatched to the AM/PM on Talmage Road, for a report of a verbal argument between two subjects. Upon arrival the officer contacted the subjects, one of whom was identified as Danny Ray age 51. A records check revealed that Ray was on probation with an abstention from alcohol term. Ray was found to be intoxicated and placed under arrest for violation of his probation. Ray was booked into county jail. 16-1911

On July 1st at about 12:54 am, a UPD officer on patrol noticed a subject in the breezeway of a closed hospital office located in the 400 block of Hospital Dr. The officer contacted the subject and spoke with him about what he was doing near the closed business. The subject was identified as Christopher Bagley age 55. Bagley was found to be in possession of methamphetamine and drug paraphernalia. Bagley was placed under arrest for the violations and later booked, cited and released with court appearance date. 16-1913

On July 1st at about 1:56 am, a UPD officer observed a motorcycle rider in the 100 block of East Gobbi Street fall over and appeared to be having trouble righting the motorcycle. The officer saw the rider get the motorcycle back on its wheels, then ride it into the parking lot of Safeway, where he fell over again. The officer contacted the rider, who was identified as Stanley Klings age 33. As the officer spoke with Klings he suspected that Klings was intoxicated and began a DUI investigation. Klings was placed under arrest for DUI and later booked, cited and released with a court appearance date. 16-1914

On July 1st about 12:25 pm, a UPD officer was dispatched to the Post Office on South Orchard for a report of a domestic assault. Upon arrival the officer contacted the male victim, who he knew from prior law enforcement contacts. The victim reported that prior to contacting the police he was on the sidewalk in front of the Post Office with his girlfriend, Angela Furia age 41. Furia became agitated at the victim and demanded money. The victim did not have money to give Furia. She then physically assaulted the victim ripping his shirt and hitting him. The victim sustained minor injuries.

Furia had left the scene prior to police arriving, but at about 2:40 she was located at Redwood Child Services on South Dora Avenue. Furia was placed under arrest for the domestic assault. It was discovered that she had been released on bail, from a prior UPD domestic assault case 16-1904. Furia was booked into county jail for the domestic assault and for committing a crime while out on bail. 16-1918

On July 1st at about 1:44 pm, a UPD officer was dispatched to the 200 block of North Orchard Avenue, regarding a welfare check on a male subject sleeping at the MTA bus stop. Upon arrival the officer contacted and spoke with Charles Hensley age 52, who was found to be intoxicated. A record check revealed that Hensley was on probation. Hensley was placed under arrest for public intoxication and for violation of his probation. Hensley was booked into county jail for the violations. 16-1920

On July 1st at about 3:43 pm, a UPD officer was dispatched to Big O Tires on North State Street, for a report of a stolen vehicle. A store employee reported that a customer's 1978 Toyota Pickup California license 1L14089 had been parked in the outside lot on June 24th, waiting to be repaired. An employee noticed that the vehicle was missing and after checking surveillance they observed the vehicle was stolen around 2:15am. The quality of the recording of the theft was poor and the only thing that could be identified was the suspect was possibly male. The owner was contacted, responded to the shop and spoke with the officer. The victim was unable to provide any suspect information. 16-1921

On July 1st at about 6:16 pm, a UPD officer was dispatched to the 500 block of South Orchard Avenue, for a report of a female adult screaming. Upon arrival the officer contacted the subject, who was identified as Joy Davidson age 39. Davidson was found to be intoxicated. A records check revealed that Davidson was on probation with a term of "Alcohol abstention". Davidson was placed under arrest for violation of her probation and booked into county jail. 16-1922

On July 1st at about 9:49 pm, a UPD officer was monitoring traffic in the 300 block of South State Street. The officer was watching a cross walk in the area, due to a special event occurring in the Alex Thomas Plaza. During this time the officer observed a white Ford pickup speeding in a north bound lane. The officer performed a traffic stop on the vehicle. The driver was identified as Vincent Young age 24. As the officer spoke with Young, he suspected that Young was intoxicated and began a DUI investigation. Young was placed under arrest for DUI and booked into county jail. 16-1924

On July 1st at about 9:38 pm, a UPD officer on patrol performed an enforcement stop on a Gold 2001 Ford F150 in the 200 block of North Orchard Avenue, for traffic violations. The driver was identified as Angelio Bettega age 21. As the officer spoke with Bettega he suspected that Bettega was intoxicated and began a DUI investigation. Bettega was placed under arrest for DUI. A 15 year old male passenger was contacted and found to be intoxicated. He was placed under arrest for public intoxication. Bettega was later booked, cited and released for DUI with a court appearance date. The 15 year old male was booked into Juvenile Hall for public intoxication. 16-1925

On July 1st at about 10:37 pm, a UPD officer on patrol performed a traffic stop on a vehicle in the 100 block of South Main Street, for traffic violations. The driver was identified as Joel Thompson age 36. The officer suspected that Thompson was under the influence of marijuana and began a DUI investigation. Thompson was placed under arrest for DUI and later booked, cited and released with a court appearance date. 16-1926

On July 1st at about 10:10 pm, a UPD officer was dispatched to Alex Thomas Plaza for a report of a suspicious person behaving strangely. Upon arrival the officer contacted the subject who was identified as Kelly Hunt age 50 and found to be extremely intoxicated. The driver was identified as Robert Ponce age 35. As the officer spoke with Ponce he suspected that Ponce was intoxicated and began a DUI investigation. Ponce was placed under arrest for DUI and later booked, cited and released with a court appearance date. 16-1928

On July 2nd at about 3:03 am, a UPD officer was dispatched to a residence on Main Circle, for a report of an unknown subject pounding on the front door of the residence. Upon arrival the officer contacted the subject, who was identified as Daniel George age 36. As the officer spoke with George he was found to be confused and extremely intoxicated. George was placed under arrest for public intoxication and booked into county jail. 16-1929

On July 2nd at about 8:15 pm, a UPD officer was dispatched to Baskin Robbins on East Perkins Street, regarding a possible medical aid. Upon arrival the officer contacted the subject, who he recognized as Charles Hensley slumped over a concrete bench. In assessing Hensley for possible medical needs, the officer released that Hensley was extremely intoxicated and a records check revealed that he was on probation. Hensley was placed under arrest for public intoxication and for violation of his probation. Hensley was booked into county jail. 16-1934

On July 2nd at about 8:13 pm, a UPD officer was dispatched to the Oak Manor area for a report of a male subject seen staggering in the roadway and foaming at the mouth. Upon arrival the officer located a subject he recognized as Roger Schoenahl age 44. Schoenahl was found to be extremely intoxicated and placed under arrest for public intoxication. Schoenahl was booked into county jail for the violation. 16-1935

On July 2nd at about 9:21 pm, a UPD officer was dealing with an unrelated call for service at the Laundry Mat in the 200 block of North Orchard Avenue, when he heard a male subject screaming and cursing at passing motorists. The Officer recognized the subject as Michael Donahue age 61, and made contact. Donahue was found to be extremely intoxicated. A records check revealed that Donahue was on probation with a term of "No direct or indirect contact with Pear Tree Shopping Center". Donahue was placed under arrest for public intoxication and for violation of his probation. Donahue was booked into county jail. 16-1936

Press Release: Dog fight / puppies taken to shelter UPD case # 16-1939

On July 3rd at about 12:26 pm, UPD officers were dispatched to a residence in the 1300 block of Berkley Way, for a report of a dog fight in progress involving multiple pit bulls. Upon arrival officers found that the dog fight was ongoing in the backyard of the residence. The dogs were eventually separated. During the investigation officers learned that there were 3 adult males, 3 adult females and 6 pit bull puppies living at the residence. Prior to the police being called, two of the adult male dogs reportedly stared at each other and a vicious fight broke out. The third male dog was tied up, but broke out of a harness to join the fight. While attempting to break-up the three fighting dogs both owners were bit and injured. Officers took custody of the three male dogs, two of which were severely injured in the fight. Officers transported the injured dogs to a local vet. The third adult male was uninjured and transported to the animal shelter to be quarantined. The owners admitted they were unable to care for the dogs and relinquished ownership. As a result of this, remaining animals were transported to the Animal Shelter.

Safety tips when meeting an unfamiliar dog:

- Ask first before petting a dog. When meeting an unfamiliar dog, don't reach out to pet her. First, ask her pet parent, "May I pet your dog?" A strange hand in a dog's face may scare her, leading to a bite.
- After you receive permission to pet a dog, let her sniff your closed hand. Then you may proceed to pet her shoulders or chest. Avoid petting the top of the dog's head.
- Don't touch a dog who is sleeping, eating or chewing a toy. Respect her space, as startled dogs are more likely to bite.
- Avoid dogs who are barking or growling. It is also best to steer clear of dogs who are loose, behind a fence or tied up, or actively involved in a dog fight.
- If an unknown dog approaches you, stay quiet and still. Do not run or scream.

The officer suspected the Berg was under the influence of the stimulant methamphetamine. Berg was placed under arrest for public drug intoxication and was found to be in possession of methamphetamine. Berg was booked into jail on both charges. 16-1942

On July 4th at about 3:58 am, UPD officers were dispatched to a residence in the 400 block of Peach Street for a reported prowler attempting to get inside the residence. Upon arrival an officer noticed an adult male standing in the front yard of the residence. An officer recognized the subject as Sono Carrigg age 51. During the investigation officers learned that Carrigg does not live at the residence, cut a window screen, and attempted to gain entry through a window. Carrigg was placed under arrest for prowling and vandalism. Carrigg was booked into county jail. 16-1943

A records check of Wood revealed that he had an active misdemeanor warrant for his arrest out of Los Angeles County.
