Patrol Division Weekly Activity Report 07/07/16 to 07/13/16

Statistics

Arrests included: 7 for warrants, 5 for public intoxication, 2 for DUI, 6, for Domestic Violence, 4 for being under the influence and/or possession of drug paraphernalia, and 1 each for violation of probation, possession of a controlled substance for sale, violation of a Domestic Violence restraining order, battery, possession of an illegal weapon, vehicle theft, felon in possession of ammunition, assault with a deadly weapon.

Officers investigated and took reports of: 9 found property, 4 abandoned vehicles, 10 City of Ukiah code violations, 2 suspected child abuse, 8 thefts, 2 vehicle thefts, 3 burglaries, 3 warrants, and 1 each of missing person, traffic collision, drug registration, 72 hour mental health evaluation, identity theft, embezzlement, elder abuse, sex registrant, animal bite, and violation of a court order.

The Patrol Division's average response time to in-progress calls was 4 ½ minutes. The average response time to all other calls was approximately 15 minutes.

Highlights for the Week

On 07/07/2016, Officers responded to 787 Sidnie Ct., to conduct a probation search of Stephen Thomas. During this search ammunition consisting of 12 gauge shotgun and .380 pistol ammunition was found in the residence. Thomas was arrested for being a felon in possession of ammunition and booked into the county jail. 16-1977

On 07/07/2016, Officers contacted Christopher Turner in the 300 block of Luce Ave while investigating a report of a person acting under the influence in the area. Officers noticed that Turner was displaying signs of recent stimulant use and conducted a pat down, which led to the discovery of a methamphetamine pipe. Officers conducted an evaluation of Turner and believed Turner was under the influence of a CNS stimulant. Turner was placed under arrest for possession of drug paraphernalia and for being under the influence of a controlled substance. Turner was booked into the county jail. 16-1980

On 07/07/2016, Officers contacted Randall Gensaw, in the area 1165 S. Dora St. Gensaw was known to be on summary probation with search and testing terms. During the contact with Gensaw, Officers noticed he was displaying signs of recent drug use. Officers conducted an evaluation of Gensaw and determined he was under the influence of methamphetamine. Gensaw was found to be in possession of a hypodermic syringe. Gensaw was placed under arrest for

possession of drug paraphernalia and for being under the influence of a controlled substance. Gensaw was booked into the county jail. 16-1990

On 7/8/2016, Officers contacted Jorge Martinez-Valencia in the parking lot of Friedman's, 1255 Airport Park Blvd, after it was reported that he had been following another vehicle. Valencia was located in the driver's seat of his vehicle and was showing signs and symptoms of being under the influence of a controlled substance. Officers attempted to remove Valencia from his vehicle to conduct sobriety tests. Valencia became resistive and was physically restrained. During the altercation an Officer sustained minor injuries to his hand. During a search of Valencia, Officers located approximately 16.4 grams suspected methamphetamine and a large sum of money on his person. Valencia was also found to be on summary probation. Valencia was arrested and booked into the county jail for possession of a controlled substance for sale, being under the influence of a controlled substance, assault on a peace officer and violation of probation. 16-2003

On 07/09/2016, an Officer was traveling northbound in the 300 block of S. State St. when Christopher Bagley ran out into the street screaming. Bagley began running directly towards the Officer's patrol vehicle while screaming. The Officer stopped his patrol vehicle and contacted Bagley and noticed he was extremely paranoid, repeatedly stated he felt like people were trying to kill him and displayed symptoms of recent drug use. Bagley was arrested and booked into the county jail for public intoxication. 16-2011

On 7/9/2016, Officers responded to the 700 block of S. Oak St. for a report of a female walking down the street yelling at people and exposing herself. Upon arrival, Officers contacted Joy Davidson after observing her sitting in front of 741 S. Oak St. While contacting Davidson, Officers noticed she was displaying symptoms of alcohol intoxication and learned that Davidson was currently on summary probation with a term of abstaining from alcohol. Officers asked Davidson if she had been drinking recently and Davidson admitted to drinking half a bottle of vodka. Davidson was arrested and booked into the county jail for violation of probation. 16-2013

On 7/9/2016, Officers responded to UVMC for a report of a subject with a stab wound. Upon arrival, Officers contacted the victim who was being treated by medical personnel. The victim told Officers that he had been in a fight with approximately 3 male subjects and had been stabbed during the fight. After speaking with the victim officers searched the area in which the victim claimed this assault took place. During this time Officers located the area in which the altercation took place along with video surveillance. In checking the surrounding area Officers contacted three male juveniles all of which matched the description provided by the victim. While contacting the three juveniles one was found to be on summary probation and subject to search. A search of this juvenile resulted in a knife being found. All three juveniles were placed under arrest and booked into the county juvenile hall. 16-2019

On 07/10/2016, an Officer contacted Thomas Dean at 317 N. Main St. after observing him prowling in the yard. Upon contact with Dean the Officer noticed that Dean displayed symptoms of recent drug use. The Officer conducted an evaluation of Dean and believed Dean was under the influence of a CNS stimulant. Dean was placed under arrest for being under the influence of a controlled substance. Upon arresting Dean, he divulged to the Officer that he had lied about his true name and that he is on parole. Dean was booked into the county jail for being under the influence of a controlled substance, providing a false name and violation of his parole. 16-2026

On 7/10/2016, Officers responded to 614 Myron St. due to a report of domestic violence on the sidewalk at that location. Upon arrival Officers contacted Oscar Bernal and the victim. Both Bernal and the victim reported to Officers that they had been in a verbal argument but were not involved in any type of physical altercation. Upon further investigation

Officers learned that Bernal was the restrained party in a served domestic violence protection order and listed the victim as the protected party. The order stated Bernal could not contact the victim in any way. Bernal was placed under arrest for violation of the protection order and booked into the county jail. 16-2028

On 7/12/2016, the Ukiah area CHP was investigating a report of a stolen 1963 Ford Ranchero that had just occurred in the 1200 block of N. State St. The reporting party advised the Ranchero was last seen traveling southbound on N. State St. Officers began checking the area in an attempt to locate the Ranchero and observed the Ranchero in the parking lot of the Shell Gas Station at 585 E. Perkins St. Officers observed a Hispanic male exit the driver's seat of the Ranchero and walk up to a fuel pump as if he was preparing to purchase fuel. Officers recognized this person from prior law enforcement contacts as Miguel Angel Hernandez-Sutherland. Officers contacted Hernandez-Sutherland and were able to take him into custody without incident. CHP responded with the owner of the Ranchero and the vehicle was returned. Hernandez-Sutherland was identified by the owner of the Ranchero as the person who had stolen the vehicle. Hernandez-Sutherland was arrested and booked into the county jail. 16-2044

On 7/12/2016, Officers were in the 400 block of N. State St. when Derick Bilow, was observed stumbling as he walked into oncoming traffic. Officers contacted Bilow and observed Bilow was swaying as he stood, had a strong odor of an alcoholic beverage emitting from his person, eyes were bloodshot and watery, and his speech was slurred. Officers learned that Bilow had been drinking and was currently on summary probation out of Humboldt county for public intoxication. Bilow was arrested and booked into the county jail for public intoxication. 16-2047

On 7/13/2016, Officers were conducting a security check of the UHAUL Parking Lot, 1140 N. State St. due to multiple reports of subjects syphoning gas from the parked trucks during nighttime hours. While checking the business, Officers noticed there was a red gas can and a blue plastic tube lying on the ground underneath one of the trucks. Officers began searching the parking lot and noticed a tan GMC Yukon parked in the northwest corner of the parking lot. This vehicle was occupied by a Vincent Frease. When Officers contacted Frease, they could smell the strong odor of gas protruding from inside of the vehicle. As Officers spoke with Frease they noticed that Frease was displaying signs of recent stimulant use. Officers conducted an evaluation of Frease and believed Frease was under the influence of a CNS stimulant. Frease was placed under arrest for being under the influence of a controlled substance. Frease was booked into the county jail. 16-2064
