The Patrol Division's average response time to in-progress calls was a little over 6 minutes. The average response time to all other calls was a little over 10 minutes.

### **Highlights for the Week**

On July 14<sup>th</sup> at about 12:55 pm, UPD officers were dispatched to the 800 block of East Perkins Street regarding a domestic disturbance that was occurring inside a vehicle. Upon arrival officers contacted an adult female and a male subject, who was identified as Paul Bausemer age 28 with an address out of Boston Massachusetts. During the investigation officers learned that both had been at the Co-Op shopping and got involved in an argument. They left the store, got into their vehicle and left. The argument continued and became physical when Bausemer pulled his girlfriend's hair. Bausemer was placed under arrest for domestic assault and booked into county jail. 16-2070

On July 14<sup>th</sup> at about 10:09 pm, a UPD officer was on patrol near Wal-Mart, when he observed a subject standing at the west edge of their property. The officer recognized the subject as Christopher Filbert age 38. The officer was aware that Filbert had a misdemeanor warrant for his arrest. On July 15<sup>th</sup> at about 8:53 am, UPD officers were in the northwest portion of the Wal-Mart parking lot, dealing with a call for service, when an officer noticed a subject standing near a vehicle. The officer recognized the subject as Nicholas Lanzit age 37. The officer was aware that Lanzit had felony warrant for his arrest. Lanzit was contacted and placed under arrest for the warrant without incident, then booked into county jail. 16-2076

On July 16<sup>th</sup> at about 1:45 am, a UPD officer was dispatched to Safeway on South State Street, for a report of an intoxicated male subject near the western entrance to the store. Upon arrival the officer contacted the subject, who he recognized as Christopher Leloup age 25. Leloup was disoriented, confused, and heavily intoxicated. A records check revealed that Leloup was on probation and had 3 misdemeanor warrants for his arrest. On July 16<sup>th</sup> at about 1:57 am, a UPD officer performed an enforcement stop on a Ford Focus with Arizona license plates, in the 200 block of South State Street, for traffic violations. The driver identified himself with a Louisiana Driver's License as Gabriel Stafford age 34. As the officer spoke with Stafford, he suspected that Stafford was intoxicated and began a DUI investigation. Stafford was placed under arrest for DUI and booked into county jail. 16-2085

The officer responded and contacted a subject identified as Jennifer Judge age 30. As the officer woke Judge, he noticed she was disoriented and heavily intoxicated. On July 16<sup>th</sup> at about 8:21 pm, a UPD officer was near Safeway on South State Street, working traffic enforcement when a female pedestrian, later identified Traci Patterson-Hernandez age 37, approached the front of the officer's patrol car. Patterson-Hernandez appeared agitated and started yelling at the officer in his vehicle. The officer exited and Patterson-Hernandez continued yelling obscenities and threatened to kill the officer.
