The Patrol Division's average response time to in-progress calls was a little over 3 minutes. The average response time to all other calls was a little over 12 minutes.

Highlights for the Week

On July 27th at about 9:33 am, a UPD officer was dispatched to the 500 block of East Perkins Street, for a male subject looking through business windows. A description was provided and upon arrival the officer located the subject near Lucky's. The subject was identified as Skyler Bailey age 22 and a records check revealed that Bailey had an active misdemeanor warrant for his arrest. Bailey was placed under arrest and booked into county jail. 16-2188

On July 27th at about 10:04 am, a UPD officer was dispatched to a residence on Mulberry Street, regarding a burglary report. Upon arrival, the victim reported that sometime between July 21st and today, an unknown subject(s) broke the lock off her storage shed and stole a vintage Schwinn bicycle. 16-2189

On July 27th at about 12:15 pm, a UPD officer on patrol in the 200 block of East Perkins Street, observed a subject he knew as Carlos Morales age 22, walking in the area. The officer was aware that Morales had an active warrant for his

arrest, for violation of his probation. The officer contacted Morales and placed him under arrest without incident. Morales was booked into county jail. 16-2190

On July 28th at about 4:30 am, UPD officers were dispatched to an alarm sounding at Triple S camera in the 200 block of South School Street. Dispatch advised the responding officers that the alarm activation was an "East door glass break". Upon arrival officers found that one of the front doors to the business had been broken out. During the investigation officers reviewed surveillance video and watched a subject strike the glass door breaking it. One of the officers immediately recognized the suspect as Michael Beers age 38. Beers was known to officers and regularly loiters in the downtown Ukiah / Alex Thomas Plaza area. At about 10:53 pm, a UPD officer located Beers in Alex Thomas Plaza. A records check revealed that Beers was on probation for a prior vandalism. Beers was placed under arrest for the vandalism and booked into county jail. 16-2197

On July 28th at about 1:36 pm, UPD officers responded to Kohl's on North Orchard Avenue, regarding a theft that had just occurred. Dispatch advised responding officers that the suspect was fleeing the area on foot. As officers arrived they observed the suspect in front of Lucky's and began to pursue the suspect on foot. The suspect was caught behind Home Depot and taken into custody. The suspect was identified as Erik Elder age 48. Officers spoke with a Loss Prevention Officer from Kohl's who told them that Elder had exited Kohl's without paying for his merchandise. The Loss Prevention Officer contacted Elder outside the store and asked Elder to return to the store. Elder refused and fled the area on foot. The stolen merchandise was recovered and returned to the store. Elder was booked into county jail for shoplifting and resisting / delaying an officer. 16-2202

On July 28th at about 3:08 pm, a UPD officer was dispatched to Big Lots for a report of a male subject passed out behind the wheel of a white Nissan Altima. While en-route dispatch advised that the male adult was now driving out of the parking lot. The responding officer located the vehicle as it stopped in front of a residence on Peach Street. The officer contacted the driver, who was identified as Kenneth Peterson age 29. A records check revealed that Peterson was on probation. Peterson was found to be in possession of drug paraphernalia and placed under arrest. Peterson was booked into county jail. 16-2203

On July 28th at about 7:38 pm, a UPD officer was dispatched to the 200 block of Luce Avenue, for a report of a possible intoxicated female driver, associated with a teal van parked in front of a residence. The officer arrived and observed the female subject standing outside of the van. The officer noticed a white male adult running southbound from Luce Avenue onto South St. The officer learned the subject was possibly Billy Rickman age 43, the officer was aware that Rickman had an active felony warrant for his arrest. Responding officers gave chase as Rickman ran inside of a residence in the 200 block of Observatory Avenue. Rickman barricaded himself inside the residence and the officers could hear a female screaming. The female exited out of a window and officers forced entry inside the residence. Rickman fled out of the back the residence and officers gave chase, eventually catching Rickman in the backyard of another residence, where he was taken into custody. During the investigation that followed officers learned that Rickman had two felony warrants for his arrest. When Rickman entered the residence on Observatory he had pushed a pregnant female down. Rickman had fled into this residence with a subject named Edward Steele age 43, who assisted Rickman in barricading the door. Rickman was booked into county jail the two felony warrants, conspiracy to commit a crime, battery and resisting / delaying an officer. Later an officer located Edward Steele in the 100 block of South Main Street and placed him under arrest for conspiracy to commit a crime and resisting / delaying an officer. Steele is a convicted felon and was found to have ammunition on his person. Steele was booked into county jail for the violations. 16-2206

On July 28th at about 8:52 pm, a UPD officer was dispatched to Wal-Mart on Airport Park Blvd. to investigate a theft that had just occurred. Upon arrival the officer spoke with the Loss Prevention Officer, who reported that the suspect had entered the store twice, the first time stealing \$421 worth of merchandise and the second time stealing \$94 worth of merchandise. The suspect was located in the surrounding area. The suspect refused to cooperate with officers or identify himself. When officers attempted to handcuff the suspect he resisted and had to be physically restrained. The officer noticed the suspect was wearing a GPS ankle monitor, indicating that he was on parole. During a search of the suspect the officer found the suspect's sex registration card identifying the suspect as Bobby Roston, age 32. Roston was placed under arrest for the theft and the stolen property was recovered and returned to the store. State Parole was notified of Roston's arrest and a parole hold was placed on him. Roston was booked into county jail. 16-2207

On July 29th at about 1:43 am, a UPD Officer observed a spray painted Toyota Corolla southbound on South State Street. The officer observed Ashley Azevedo age 31, driving this vehicle. The officer was aware that Azevedo's license was suspended. The officer performed a traffic stop on the vehicle in the 700 block of South State Street and contacted Azevedo. A passenger in the vehicle was identified as Robert Curtis James, age 21. Azevedo was placed under arrest for driving on a suspended license. During a search of the vehicle the officer located an illegal loaded short barrel rifle, ammunition, and suspected methamphetamine, all linked to James. A records check revealed that James is a convicted felon. James was placed under arrest for the illegal firearm, being a felon in possession of a firearm, felon in possession of ammunition, and possession of a controlled substance while armed. James and Azevedo were booked into county jail. 16-2208

On July 29th at about 11:05 am, a UPD officer was dispatched to Rod's Shoes on East Perkins Street, for a report of a suspicious female adult yelling at customers. Upon arrival the officer recognized the female as Deborah Lawrence age 50. A records check revealed that Lawrence was on probation. Lawrence was found to be in possession of methamphetamine and placed under arrest. Lawrence was booked into county jail. 16-2210

On July 29th at about 11:45 am, a UPD officer received a report that Dylan Beck age 21 was in the 400 block of South State Street. The officer was aware that Beck had an active misdemeanor warrant for his arrest. The officer located and placed Beck under arrest for the warrant. Beck was booked into county jail. 16-2211

On July 30th at about 12:31 am, a UPD officer was dispatched to a residence in the 700 block of East Gobbi Street, regarding a report of a burglary. The victim reported that on July 29th at about 11:30 pm, she returned home after being at work of approximately 12 hours. The victim immediately noticed furniture in her living room had been slightly moved. The victim walked to her bedroom and noticed a partially consumed Arrowhead water bottle on her dresser that she had not placed there. The victim further checked the residence and found jewelry and a .380 caliber handgun had been stolen. Case is still under investigation. 16-2216

On July 30th at about 6:26 pm, a UPD officer was dispatched to the front parking lot of UPD regarding a child exchange. The reporting party believed her ex was intoxicated. Upon arrival the officer contacted Jose Hinojosa-Corona, age 38 to speak with him regarding the accusation. After speaking to Hinojosa-Corona the officer began a DUI investigation. A records check revealed that Hinojosa-Corona did not have a license. Hinojosa-Corona was placed under arrest for DUI and driving without a license. Hinojosa-Corona was booked into county jail. 16-2221

On July 30th at about 9:40 pm, a UPD officer on patrol conducted a traffic enforcement stop on a grey Chevy Pickup with New Mexico license plates, in the 1200 block of South State Street. The driver was identified as Joel Campos-Banuelos

age 25. A records check revealed that Campos-Banuelos did not have a license. As the officer spoke with Campos-Banuelos, he observed signs of intoxication and began a DUI investigation. Campos-Banuelos was placed under arrest for DUI and driving without a license. Campos-Banuelos was booked into county jail. 16-2222

On July 31st at about 10:01 pm, a UPD officer was dispatched to Safeway on South State Street, for a report of an intoxicated male subject in front of the store yelling at customers. The officer recognized the subject as Thomas Sanders, age 54. A records check revealed that Sanders was on probation with an "Abstention from alcohol" term. Sanders appeared intoxicated and an in the field breath test was completed, showing a .24% BAC. Sanders was placed under arrest for public intoxication and violation of his probation. Sanders was booked into county jail. 16-2229

On August 1st at about 4:58 pm, a UPD officer was dispatched to Lucky's on East Perkins Street, for a report of a subject wishing to turn himself in on outstanding warrants. Upon arrival the officer contacted the subject, who was identified as Steven Flores age 37. A records check revealed that Flores had two active misdemeanor warrants for his arrest. Flores was taken into custody without incident and booked into county jail. 16-2241

On August 2nd at about 10:02 pm, a UPD officer observed a subject he knew as Daniel Butler age 68 in the 1100 block of Commerce Drive. The officer was aware that Butler had an active felony warrant for his arrest and contacted him. Butler was placed under arrest for the warrant and booked into county jail. 16-2246
