The Patrol Division's average response time to in-progress calls was a little over 4 minutes. The average response time to all other calls was a little over 10 minutes.

Highlights for the Week

On August 3rd at about 10:55 am, UPD officers went to a residence in the 200 block of Ford Street, in an attempt to locate probationer Jodi Hodges age 29, who had 2 misdemeanor warrants for her arrest. Upon arrival the officers contacted Hodges and placed her under arrest without incident. Hodges was booked into county jail. 16-2257

On August 3rd at about 2:36 pm, a UPD officer was responding to an unrelated incident in the 200 block of East Gobbi Street, when he observed an adult male who he knew from prior contacts as Ronald Baumeister age 58. The officer was aware that Baumeister had an active misdemeanor warrant for his arrest. The officer contacted Baumeister and placed him under arrest for the warrant without incident. Baumeister was booked into county jail. 16-2259

On August 3rd at about 4:42 pm, a UPD officer was on patrol in the 200 block of South Orchard Avenue behind Big Lots, when he observed a subject he recognized as Carol Curtiss, age 32. The officer was aware that Curtiss had three active misdemeanor warrants for her arrest. The officer contacted Curtiss and placed her under arrest without incident. Curtiss was booked into county jail. 16-2261

On August 4th at about 3:12 am, a UPD officer on patrol observed a subject he knew as Dylan Beck age 21, walking in the 500 block of Leslie Street. The officer was aware that Beck had two misdemeanor warrants for his arrest. The officer contacted Beck near the Senior Center and advised him that he had warrants for his arrest. Beck fled from the officer and was pursued. UPD officers established a perimeter and searched for Beck. Beck was located near a residence on Peach Street and placed under arrest for the warrants. He was additionally charged with resisting / delaying an officer and violation of his probation. Beck was booked into county jail. 16-2264

On August 4th at about 9:03 am, a UPD officer was dispatched to Prime Market in the 200 block of West Mill Street, for a report of a female subject consuming alcohol inside the store. Upon arrival the female subject was identified as Andrea Gonzalez age 47, standing near the liquor isle. The officer asked Gonzalez if he could speak with her outside and she began flailing her arms and screaming. The officer was able to escort Gonzalez outside and while trying to evaluate her, she admitted to recent methamphetamine use. A records check revealed that Gonzalez was on probation. Gonzalez was placed under arrest for public intoxication and for violating her probation. Gonzalez was booked into county jail. 16-2265

On August 4th at about 1:10 pm, UPD officers were dispatched to a residence on Betty Street, regarding a domestic disturbance. UPD dispatch advised responding officers that the involved female subject was walking southbound on Betty Street, away from the residence. Upon arrival a UPD officer contacted the female subject, who was identified as Ariana White, age 25. Officers also contacted her husband, who was at the residence. During the investigation officers learned that prior to the police being called, the two were involved in a heated argument, over their relationship. The argument turned physical when White punched her husband multiple times in the face, causing him to have a bloody nose. White was placed under arrest for domestic assault and booked into county jail. 16-2266

On August 4th at about 2:59 pm, a UPD Sergeant and officer were on patrol in the 900 block of North State Street, when they performed an enforcement stop on a bicyclist. The bicyclist was identified Sean Moynahan, age 21. A records check revealed that Moynahan was on probation for prior drug offenses. Moynahan was found to be in possession of drug paraphernalia and was placed under arrest. Moynahan was booked into county jail for the violations. 16-2267

On August 5th at about 1:16 am, a UPD officer on patrol performed an enforcement stop on a red GMC Sierra pickup in the 300 block of South State Street, for traffic violations. The driver was identified as Alfredo Ceja-Gil age 34. As the officer spoke with Ceja-Gill, the office suspected that he was intoxicated and began a DUI investigation. Ceja-Gill was placed under arrest for DUI and booked into county jail. 16-2270

On August 5th at about 3:40 pm, a UPD officer was dispatched to Home Depot parking lot, on a report of an intoxicated male subject. Upon arrival the officer recognized the subject as Thomas Sander age 54. A records check revealed that Sanders was on probation with a term of "Abstention from alcohol". As the officer spoke with Sanders he was found to be extremely intoxicated. Sanders was placed under arrest for public intoxication and violation of his probation. 16-2274

Magana was found to be in possession of methamphetamine and drug paraphernalia. Magana was cited in the field for the violations. 16-2277

On August 5th at about 9:56 pm, a UPD officer performed a traffic enforcement stop on a 2014 black VW Jetta, in the 700 block of South State Street. The driver was identified as Eric Silk-Hoaglin age 25. Silk-Hoaglin was on felony probation with search terms and was driving on a suspended license. The passenger in the vehicle was identified as Lalita Bock, age 26. As the officer spoke with Silk-Hoaglin, he could smell the odor of marijuana coming from the vehicle and Bock admitted to recently smoking marijuana inside the vehicle. During a search of the vehicle an officer located two loaded firearms. Also inside the vehicle was suspected methamphetamine, heroin and drug paraphernalia, all linked to Silk-Hoaglin. Silk-Hoaglin was placed under arrest for felon in possession of a firearm, carrying a loaded firearm, felon in possession of ammunition, driving on a suspended license, possession of drug paraphernalia and possession of a controlled substance. Silk-Hoaglin was booked into county jail on the charges. Lalita Bock was found to be in possession of drug paraphernalia and cited and released in the field.

On August 6th at about 12:43 am, a UPD officer conducted a traffic enforcement stop on a white Acura RSX, in the 100 block of Warren Drive. The driver was identified as Jeremy Beebe, age 24 and a passenger as Marcos Hernandez, age 26. As the officer spoke with Beebe he believed that Beebe was intoxicated and began a DUI investigation. Beebe was placed under arrest for DUI. A records check of Hernandez revealed that he had two misdemeanor warrants for his arrest, one out of Sonoma County and the other out of Mendocino County. Hernandez was placed under arrest for the warrants. Both were booked into county jail. 16-2280

On August 6th at about 2:02 am, a UPD officer on patrol was passing a bar on East Perkins Street, when he heard a group of people yelling and point in the direction of a male subject. The officer observed the male subject step into the street and wave his hands around. The officer contacted the male subject and asked if he needed assistance. The male subject was identified as Jon Young, age 29. Young began speaking incoherently and stumbled as he walked toward the officer's police car. On August 6th at about 1:05 pm, a UPD officer was dispatched to a residence in the 1100 block of South Dora Street, regarding an assault. Upon arrival the officer contacted the adult female victim, the victim's daughter and her daughter's boyfriend, who was identified as Carlos Lopez age 24. During the investigation officers learned that all were involved in a verbal argument, that turned physical when Lopez hit his girlfriend's mother, knocking her glasses off. The victim placed Lopez under citizen's arrest for the assault and he was booked into county jail. 16-2283

On August 6th at about 2:24 pm, a UPD officer was dispatched to the corner of Ford and Sidnie Street, regarding an intoxicated subject. Dispatch advised that reporting party identified himself as Gage Hewett, age 27. Hewett stated that he was drunk. Upon arrival the officer located Hewett lying on his back on the grass of an apartment complex in the 500 block of Ford Street. Hewett was unable to stand, but completed an in the field alcohol breath test resulting in a .35 % BAC. Hewett was placed under arrest for public intoxication and booked into county jail. 16-2285

On August 7th at about 10:57 am, UPD officers were dispatched to an apartment at 610 North Orchard Avenue, regarding a domestic disturbance. UPD dispatch advised responding officers that the female party on the telephone reported that her husband had hurt her and she wanted him to leave. Upon arrival officers contacted the female and her boyfriend, identified as Luis Munguia-Garcia, age 27. During the investigation officers learned that the couple had been involved in a verbal argument over Munguia-Garcia being gone all night. The argument turned physical when Munguia-Garcia pushed the victim in the chest, causing visible scratches. Munguia-Garcia was placed under arrest for domestic assault and booked into county jail. 16-2293

On August 7th at about 7:35 pm, UPD officers were dispatched to St. Mary's Church in the 900 block of South Oak Street, regarding a male subject that had assaulted two people. UPD dispatch advised responding officers that the suspect was last seen running toward St. Mary's School and provided them with a description of the suspect. While an officer spoke with victims, other officers located the suspect hiding underneath a travel trailer in the 1000 block of Alice Avenue. The suspect was found to be intoxicated, was detained and identified as a 16 year old male who resides in the Ukiah area.

A Catholic Priest reported that upon finishing Mass, he was made aware of some satanic graffiti written in black marker on a church breezeway that had not been there prior to Mass. The Priest walked to the prayer plaza, located behind the church, where he located a 69 year old woman. The Priest and woman began praying together, when two male subjects came into the plaza, one being the 16 year old male we later detained. One of the two subjects began smoking marijuana and the Priest told the subject that this was not allowed at the church. The 16 year old pushed the Priest and both subjects left. The 16 year old soon returned and confronted the Priest and began yelling satanic slurs at him. The 69 year old woman attempted to intervene and was hit in the face by the 16 year old male, causing her to fall to the ground. As the Priest was assisting the woman, he was struck in the face by the 16 year old.

The 16 year old male was placed under arrest for public intoxication, battery and elder abuse then booked into juvenile hall. The charge of vandalism and violation of a hate crime will be reviewed by the District Attorney's Office.

Neither the Priest or the 69 year old woman required medical attention and sustained only minor injuries.

On August 9th at about 3:57 am, a UPD officer was dispatched to an apartment complex in the 300 block of Leslie Street, for a report of a male and female being loud and causing a disturbance near the laundry room. Upon arrival the officer contacted the two, one being identified as Laura Cantaroni age 19. During a records check Cantaroni was found to have a felony warrant for her arrest. Cantaroni was placed under arrest for the warrant and booked into county jail. 16-2310

On August 9th at about 6:05 pm, a UPD officer was dispatched to Safeway on South State Street, for a report of a white male adult who had ran from the store after shoplifting.
