Arrests included: 7 warrants, 1 driving on a suspended license / VOP, 1 DUI drugs, 3 public intoxication, 1 DUI, 1 VOP, 1 shoplifting, 2 conspiracy / attempt shoplift / VOP, 1 assault / DUI / driving suspended / VOP, 1 domestic assault, 2 grand thefts, 1 domestic assault / VOP

Officers investigated and took reports of: 9 found property, 6 traffic collisions, 1 burglary, 2 warrants cited in field, 5 vandalism reports, 2 sex registrations, 1 theft, 1 embezzlement, 1 death investigation apparent natural causes, 5 burglaries, 1 use of force, 1 warrant cited / possession of burglary tools, 1 cited for unlawful camping, 1 tow for expired registration, 1 mail theft, 1 tow for parking violations, 2 shoplifters cited in field, 1 hit and run traffic collision, 2 assaults, 1 cited in field for providing a false name, 1 tow for unpaid parking tickets

The Patrol Division's average response time to in-progress calls was a little under 5 minutes. The average response time to all other calls was a little over 11 minutes.

Highlights for the Week

On August 17th at about 9:45 am, a UPD officer was traveling in the 300 block of Norgard Lane, when he observed Kelly Stanton age 39. The officer was aware that Stanton had two misdemeanor warrants for her arrest, so he contacted her. As the officer began to place Stanton under arrest for her warrants she became agitated and started screaming and attempting to pull away from the officer. The officer was able to restrain Stanton and handcuff her. Stanton was transported to county jail. 16-2399

On August 17th at about 10:17 am, UPD officers were dispatched to the 100 block of North Orchard Avenue, regarding a report of aggressive panhandlers. Upon arrival officers contacted Michael James Donahe age 61. A UPD officer was aware that Donahe had a misdemeanor warrant for his arrest. On August 17th at about 7 am, a UPD officer was dispatched to an apartment complex in the 900 block of Waugh Lane, regarding vandalism. Upon arrival the officer learned that sometime in the past two days an unknown suspect used blue spray paint to spray Sureno gang graffiti on a wall of the complex. 16-2401

On August 17th at about 8:19 pm, a concerned citizen reported to UPD dispatch that she had observed a driver of a Hey Taxi cab displaying behavior that made her concerned he was under the influence of drugs. Officers located and stopped the Taxi in the 1100 block of Mulberry. The driver was identified Geoffrey Ritter age 31. As the officer spoke with Ritter, he suspected that Ritter was under the influence of a CNS stimulant and evaluated him for this. Ritter was placed under arrest for DUI drugs and booked into county jail. 16-2408

On August 18th at about 4:10 pm, a UPD officer was dispatched to Ukiah Youth Baseball League Ballpark in the 1100 block of East Gobbi Street, regarding an attempt burglary. The officer learned from the reporting party that sometime between Aug 17th and Aug 18th in the afternoon, someone tried to pry open a door and a window of the snack shack. 16-2415

On August 19th at about 1:27 am, a UPD officer was patrolling in the 600 block of East Gobbi Street, when he saw a subject he recognized as Benjamin Hoff age 33. The officer was aware that Mendocino County Probation had issued a violation of probation arrest order for Hoff. The officer contacted Hoff and placed him under arrest. Hoff was booked into county jail. 16-2418

On August 19th at about 5:27 pm, a UPD officer was dispatched to a residence in the 800 block of South Orchard Avenue, regarding a burglary report. Upon arrival the officer spoke with the victim, who reported that someone had broken into her residence. During the investigation the officer learned that just before contacting the police, the victim had returned home. The victim noticed that someone had force open a door separating her living room and garage, damaging the door, door jam and latch. Rooms in the residence had been ransacked and jewelry and cash had been stolen. The victim was unable to provide any suspect information. 16-2425

On August 19th at about 5:43 pm, a UPD officer was on patrol traveling in the 1000 block of South State Street, when he observed a subject lying on the ground. The officer contacted the subject, who he recognized as Jimmie Isenhart age 45. The officer was able to wake Isenhart. Isenhart appeared intoxicated. Isenhart completed a field breath test results .30 % BAC. Isenhart was placed under arrest for public intoxication and booked into county jail. 16-2426

On August 20th at about 12:56 am, a UPD officer performed an enforcement stop on a vehicle in the 100 block of Mason Street, for traffic violations. The driver was identified as Luis Maela age 32. As the officer spoke with Maela he suspected that Maela was intoxicated and began a DUI investigation. Maela was placed under arrest for DUI and booked into county jail. 16-2429

On August 20th at about 2:07 am, a UPD officer was dispatched to Jack in the Box on Airport Park Blvd., regarding multiple subjects refusing to leave the restaurant. Upon arrival the officer located the subjects and recognized one of them

as Justin Peacock age 30. A records check revealed that Peacock was on probation with an "Abstain from alcohol" clause. Peacock was found to be intoxicated and placed under arrest for violation of his probation. A female adult was identified as Michelle Patient age 30. A records check revealed Patient had two misdemeanor warrants and she was placed under arrest. Both were booked into county jail. 16-2430



On August 20th at about 3:31 am, UPD officers were dispatched to a burglary alarm activation at the City of Ukiah softball field snack shack. Upon arrival officers found that a door to the snack shack building was open and it's deadbolt lock damaged. It was discovered that a cash draw was missing, and no suspects were located. 16-2431

On August 20th at about 7 am, a UPD officer was dispatched to an apartment complex in the 900 block of Waugh Lane, regarding a vandalism. Upon arrival the officer learned that sometime in the past day a suspect used blue spray paint to spray Sureno gang graffiti on a wall of the complex. 16-2434

On August 20th at about 9 am, a UPD officer was dispatched to the Ukiah State Parole office on North State Street, regarding a vandalism. A passerby had reported that a window on the north side of the Parole building had been broken out. Upon arrival the damaged window was located and a Parole agent was contacted and responded to secure the building. It did not appear that anyone made entry into the building. 16-2436

On August 20th at about 8:17 pm, UPD officers were dispatched to Kohl's on North Orchard Avenue, regarding a report of a male and female who were cutting electronic tags off of merchandise, attempting to steal from the store. Upon arrival officers spoke with a loss prevention officer, who directed them to the suspect's location in the store. As officers approached, they saw the male subject attempting to conceal a small portable speaker in his back pocket. The two were suspects were detained and identified as Nicole Sanders age 21 and James Simmons age 26. They were found to have almost \$600.00 worth of store merchandise that had electronic tags removed. The cutters they were using were located and collected as evidence. A records check revealed that that Sanderson was on probation and had another theft case pending. Simmons and Sanders were placed under arrest for attempted burglary from a retail store, possession of burglary tools and conspiracy to commit a crime. Sanders was additionally charged with violation of her probation. Both were booked into county jail. 16-2443

On August 21st at about 5:14 am, UPD officers were dispatched to Jack in the Box on Airport Park Blvd., for a report of a domestic assault that had just occurred. Upon arrival an officer located an adult female victim. The victim's husband, who was identified as Alfredo Romero age 28 and was found in a grey Chevy sedan in restaurant's drive-thru. During the investigation officers learned that both the victim and Romero had been consuming alcohol at a friend's house and both were intoxicated. Romero drove them both to Jack in the Box, and while in the drive-thru they became involved in a heated argument. The victim tried to exit the vehicle and as she did Romero grabbed hold of her hair and arm, pulling her back into the vehicle. A records check revealed that Romero was on probation and his license had been suspended for a prior DUI. As the officers spoke with Romero they suspected he was intoxicated and began a DUI investigation. Romero was placed under arrest for domestic assault, DUI, driving on a suspended license and for violating his probation. Romero was booked into county jail. 16-2446

On August 21st at about 1:26 pm, a UPD officer was dispatched to the Orchard Manor Apartments in the 600 block of North Orchard Avenue, regarding the theft of a coin machine. Upon arrival the officer spoke with the property manager, who reported that a coin machine had been stolen from the laundry room of the complex. While there, a maintenance worker from a nearby apartment complex contacted the officer and reported that a coin machine had been stolen from the Orchard Village Apartment complex as well. Both machines had been ripped from walls in the laundry rooms and were last seen the day prior. 16-2448

On August 22nd at about 5:54 pm, a UPD officer was on routine patrol in the 600 block of South State Street, when he observed a subject he knew as Daniel Pierce Jr. age 24. The officer was aware that Pierce had a felony warrant for his arrest and contacted him. Pierce was placed under arrest without incident and booked into county jail. 16-2454

On August 22nd at about 10:18 pm, UPD officers were dispatched to an apartment in the 200 block of Freitas Avenue, regarding a domestic assault. Upon arrival officers spoke with an adult female victim, who reported that her boyfriend Jason Gilman age 43 had just left. During the investigation officers learned during an argument Gilman physically assaulted the victim, by chest bumping her several times before leaving the residence. Gilman was later located and placed under arrest for domestic assault. Gilman was booked into county jail. 16-2456

On August 23rd at about 2 pm, UPD officers were dispatched to Redwood Children Services on East Gobbi Street, for a report of a female subject named Kelisha Alvarez age 27 causing a disturbance. Upon arrival officers located her and her adult boyfriend on the walking path near the railroad tracks. As officer approached they observed Alvarez yelling and pushing her boyfriend backwards. Officers placed Alvarez under arrest for domestic assault. A records check revealed the Alvarez was on probation. She was additionally charged with violation of her probation. Alvarez was transported to county jail, who requested she have a medical clearance prior to being housed. Alvarez was transported to UVMC, medically cleared in the ER and then transported back to county jail, where she was housed. 16-2463
