The Patrol Division's average response time to in-progress calls was a little over 6 minutes. The average response time to all other calls was a little under 12 minutes.

Highlights for the Week

On August 31st at about 7:24 am, a UPD officer was dispatched to McCarty Manor Apartments in the 700 block of Waugh Lane, regarding a burglary. Upon arrival the officer spoke with an onsite manager, who reported that the personnel office door was locked and secured for the evening on August 30th at about 5 pm. The next morning the onsite manager noticed the front door ajar and the deadbolt latch damaged. Upon checking the office it was discovered that a Dell All-n-One computer and monitor had been stolen. 16-2544

On August 31st at about 8:15 am, a UPD officer was dispatched to Johnson Quality Tree Care on Wabash Avenue, regarding a theft report. Upon arrival the owner reported sometime between August 30th at 4:30 pm and August 31st at 7 am, three tool storage doors on vehicles parked in the corporate yard were opened and over \$5,000 worth of tools were stolen. The tools consisted of STIHL chainsaws, Husqvarna chainsaws, a STIHL Pole Pruner saw, and a STIHL handheld blower. 16-2545

On August 31st at about 11:43 am, UPD officers responded to Redwood Community Services in the 800 block of North State Street, for a report of an agitated female subject who threw a brick through a vehicle window. Upon arrival officers contacted and detained Dayniece Shillings age 20, who was visibly upset and agitated. During the investigation, officers learned that Shillings and her boyfriend had been involved in a verbal argument that turned physical when Shillings assaulted her boyfriend. The program manager at the facility attempted to calm Shillings down. Shillings picked up a large retaining wall block from a nearby planter and threw it at the program manager's vehicle, smashing the back window and damaging the roof. Shillings was placed under arrest for domestic assault and felony vandalism. Shillings was booked into county jail. 16-2547

On August 31st at about 6:21 pm, a UPD officer was dispatched to Kohl's on North Orchard Avenue, regarding a shoplifter being detained. Upon arrival the officer spoke with a loss prevention officer, who had Dana Heilner age 56 in detained. The loss prevention officer observed Heilner select a pair of shoes and put them on. Heilner walked around the store, selected other merchandise which she concealed in her purse. Heilner exited the store and was detained by loss prevention. The stolen items were recovered and Heilner was placed under arrest for shoplifting. Heilner was also found to be in possession of drug paraphernalia and was booked into county jail on both offenses. 16-2552

On August 31st at about 9:16 pm, a UPD officer was dispatched to Ukiah Valley Medical Center regarding a stolen vehicle report. Upon arrival the victim reported that he was at the hospital visiting his girlfriend. At about 9 pm, the victim went outside and saw his vehicle was missing from the parking lot. As the officer spoke with the victim, he could not find his keys and recalled setting them down earlier in a bathroom inside the hospital. The victim described his vehicle as a red 2010 Chevy Camaro, having 22 inch silver "Lorenzo" rims California License 7KAL469. 16-2554

On September 1st at about 9:55 am, a UPD officer was dispatched to the 400 block of North State Street, for a report of a male subject laying in the bushes. Upon arrival the officer recognized the subject as Thomas Sander age 54. Sitting next to Sanders was an open bottle of Vodka. Sander was found to be extremely intoxicated and placed under arrest for public intoxication. Sanders was booked into county jail. 16-2555

On September 1st at about 1:25 pm, a UPD officer was dispatched to the 100 block of Wabash Avenue, for a report of a subject on the sidewalk talking and yelling to herself. Upon arrival the officer contacted a subject named Linda Almond age 58. As the officer spoke with Almond, he suspected that she was under the influence of an illegal drug and evaluated her for it. During this evaluation, Almond was found to be in possession of drug paraphernalia. Almond was placed under arrest being under the influence of a controlled substance and possession of drug paraphernalia. Almond was booked into county jail. 16-2560

On September 2nd at about 1:36 am, a UPD officer on patrol was driving through Motel 6 parking lot on South State Street, when he observed a subject he knew as Greg Cuadra age 39. A records check revealed that Cuadra had a felony warrant for his arrest. The officer contacted Cuadra and placed him under arrest without incident. Cuadra was booked into county jail. 16-2567

On September 2nd at about 9:47 pm, UPD officers were dispatched to the 600 block of North Orchard Avenue, on a report of a domestic assault. Upon arrival the officer spoke with the adult male victim, who reported that his girlfriend has knocked out his front tooth. During the investigation the victim's girlfriend was identified as Kristin Maclean age 28. The victim and Maclean were at her apartment on North Orchard Avenue, when an argument broke out. The victim gathered his belongings and attempted to leave, but Maclean blocked the front door and would not allow him to leave.

Maclean assaulted the victim, breaking a tooth. Maclean was placed under arrest for domestic assault, battery with severe injury and blocking the victim from exiting the apartment. Child Protective Services responded and took custody of Maclean's 21 month old child. Maclean was booked into county jail. 16-2577

On September 2nd at about 10:34 pm, a UPD officer on patrol saw a subject walking in the roadway of Mazzoni Street. The officer recognized the subject as Kristine Tupper age 52 from prior contacts. The officer contacted Tupper and a records check revealed that she was on probation with terms of search and seizure. Tupper was found to be in possession of methamphetamine and drug paraphernalia. Tupper was placed under arrest for the drug violations and for violation of her probation. Tupper was later booked, cited and released with a court appearance date. 16-2578

On September 3rd at about 2:46 am, UPD officers were dispatched to the 1400 block of North Bush Street, regarding a disturbance. UPD dispatch advised responding officers that a subject was reportedly pounding on the door of an apartment. Upon arrival officers contacted Kashia Williams age 21 and Cecelia Castanon age 30, outside of an apartment. Williams and Castanon were both intoxicated, shouting and refusing to be quiet. Williams and Castanon were placed under arrest for public intoxication. Another UPD officer contacted a subject identified as Leona Delapena age 33, also outside of an apartment. Neighbors reported that Delapena had been shouting and throwing items around outside. Delapena was also intoxicated and placed under arrest for public intoxication. All three subjects were booked into county jail. 16-2581

On September 3rd at about 4:19 am, a UPD officer was dispatched to Marino's Restaurant in the 100 block of Talmage Road, to investigate vandalism. Upon arrival the officer saw that a window had been broken out by a large rock and brick that were found on the floor of the restaurant. An owner of the business responded and she and the officer reviewed surveillance video. The video captured the vandalism and the officer recognized the suspect as Jeremiah Mcosker age 38, from prior police contacts. At about 6 am, officers located Mcosker in a culvert in the 1100 block of South State Street. Mcosker was placed under arrest for the vandalism and found to be in possession of methamphetamine and drug paraphernalia. A records check revealed that Mcosker was on Post Release Community Supervision (PRCS from AB109). Mcosker was booked into jail for the violations. 16-2582

On September 3rd at about 8:22 am, a UPD officer responded to a residence in the 400 block of North Pine Street, for a report of a male subject seen on the property, in violation of domestic violence restraining order. Upon arrival the officer spoke with the adult female victim, who stated that a male subject had been seen jumping over her fence and leaving her back yard. The victim believed that the subject was her ex, Michael Parker age 38. A records check revealed that not only was there a DV order, but Parker was on probation for a prior trespassing case. Officers checked the area and located Parker in the 100 block of North Oak Street. Parker was placed under arrest for violation of his probation and violation of the court order. Parker was booked into county jail. 16-2584

On September 3rd at about 3:57 pm, a UPD officer on patrol observed a male subject in the middle of a gravel parking lot in the 1100 block of South State Street. The subject appeared to be distressed and was waving his arms around. UPD dispatch had also received a call from a citizen regarding the subject's erratic behavior and other UPD officers responded

to assist. The initial officer approached the subject, while keeping his distance, to check on the subject's welfare. The officer recognized the subject as Brett Gray age 49 from multiple prior police contacts. The officer was also aware that Gray had made threats earlier in the day toward an employee at Ukiah Hospice Thrift and Gift. The officer asked Gray if he needed any assistance. Gray was agitated, yelling and holding a rock the size of a tennis ball. The officer told Gray to drop the rock and Gray yelled for the officer to shoot him. Gray threw the rock toward the officer but missed. Gray picked up additional rocks which he threw toward officers and then fled on foot. Officers pursued Gray and were able to surround him in the 100 block of Rupe Street. An officer's Taser had to be deployed to safely control Gray and take him into custody. Gray was placed under arrest for assault on a police officer and resisting and threatening an officer. Gray was booked into county jail.

On September 4th at about 12:29 am, a UPD officer was dispatched to an apartment in the 1100 block of Mulberry Street, for a report of a suspicious incident. Upon arrival the officer spoke with the adult female resident. The victim reported that she was sleeping in her residence, when she heard a noise outside of her apartment. The victim opened the front door of her residence and saw two female adults running from the closet storage she has on her front porch. The victim said she recognized the subjects as Christine Halas age 28 and Lauren Mcentee, who both live in a nearby apartment. The victim checked and did not notice anything missing. The victim asked the officer to contact Halas and Mcentee and requested they be told to stay away from her apartment. The officer found the two and records check revealed that Halas was on probation with a term of "No alcohol". Halas was found to be intoxicated and placed under arrest for violation of her probation. Halas was booked into county jail. 16-2591

On September 4th at about 12:49 pm, UPD officers were dispatched to Kohl's on North Orchard Avenue, regarding a shoplifting that had just occurred. Dispatch advised responding officers that the female adult suspect had fled and a loss prevention officer was chasing the suspect, last scene in Home Depot parking lot. Upon arrival officers located the loss prevention officer, who told officers that the suspect had ran into the woman's bathroom of Home Depot. The suspect was found hiding in a bathroom stall and was detained. The suspect was identified as Lalita Bock age 26. Officers learned that Bock had went inside Kohl's, selected numerous items and exited without paying for the merchandise. A store loss prevention officer attempted to contact Bock and she fled. The stolen merchandize was recovered and Bock was placed under arrest for shoplifting and resisting / delaying an officer. Bock was booked into county jail. 16-2593

On September 4th at about 8:54 pm, a UPD officer was on patrol, when he performed a traffic stop on a white Ram pickup northbound Hwy 101, just north of Perkins Street. The driver was identified as Thomas Bader age 62. As the officer spoke with Bader, he suspected that Bader was intoxicated and began a DUI investigation. Upon arrival the adult victim reported that on September 3rd at about 6:30 pm, he left for a trip out of town. At this time his Nissan Sentra was parked in his driveway. The victim returned home on September 5th, to find that his vehicle had been stolen. The victim added that he had left the vehicle unlocked and there was a spare key in the ignition or cup holder of the vehicle. On September 9th at about 12:37 pm, an alert officer located the stolen vehicle unoccupied in the 800 block of Cypress. No suspects were located and the vehicle was returned to its owner. 16-2597

On September 5th at about 7:20 pm, a UPD officer was traveling on Empire Drive, when he saw a subject he knew from prior police contact as Sesario Rios age 36. The officer was aware that Rios had a felony Post Release Community Supervision (PRCS from AB109) warrant. The officer contacted and placed Rios under arrest without incident. Rios was booked into county jail. 16-2598

On September 6th at about 5:07 pm, a UPD officer was dispatched to the Comfort Inn on Airport Park Blvd., for a report of a theft that had just occurred. Upon arrival the officer contacted the adult male victim. The victim reported that at about 5 am he walked to his truck and placed a camouflage bag containing clothing and currency in the back, as he was getting ready to leave. The victim walked back to his motel room to get some additional items, returned to his truck and found the duffle bag had been stolen. The victim started looking around the area for his property and observed a subject in the bushes with a flashlight, just south of a nearby Starbucks. As the victim walked up, he saw the subject rifling through his duffle bag. The victim confronted the suspect, who was later identified as Arnold Gaham age 39. Gaham took off running from the victim, who gave chase. The victim tackled Gaham, in an attempt to detain him. Gaham got away and the victim returned to the Comfort Inn and contacted the police. While one officer was talking to the victim, other UPD units were searching the area for Gaham. Officers located Gaham at a nearby Quik Stop and he was detained. The victim positively identified the Gaham as the suspect and Gaham was placed under arrest for grand theft. 16-2600

On September 6th at about 5:14 pm, a UPD officer was dispatched to a report of an intoxicated female at Vinewood Park. It was reported that the female had been crawling through the park on her hands and knees, screaming for about an hour. Upon arrival the officer contacted the female, who he recognized as Cruz Rea age 55. Rea was found to be extremely intoxicated and placed under arrest for public intoxication. Rea was booked into county jail. 16-2606
