Officers investigated and took reports of: 6 found property, 7 outdoor grow marijuana investigations, 2 traffic collisions, 1 domestic assault, 2 CPS cross reports, 1 injury traffic collision, 2 warrants cited in the field, 1 death investigation, 1 injury traffic collision, 1 stolen vehicle, 1 assault with a deadly weapon, 1 mental health commitment, 1 sex registration, 1 illegal camping, 1 burglary, 1 vandalism, 1 burglary / vandalism, 3 city code violation cited, 2 thefts, 1 seized dog.

The Patrol Division's average response time to in-progress calls was a little under 4 minutes. The average response time to all other calls was a little under 12 minutes.

Highlights for the Week

On September 7th at about 1:32 pm, a UPD officer was on patrol in the 1200 block of Elm Street, when he observed a female subject on her knees with her head on the sidewalk. The officer contacted the female, who he recognized as Cruz Rea age 55. When Rea tried to stand, she just fell over on her side. Rea was found to be extremely intoxicated and completed a field breath test, results being .22% BAC. Rea was placed under arrest for public intoxication and booked into county jail. 16-2615

On September 8th at about 9:04 am, UPD officers responded to Ford Street, on a report of a male subject walking onto properties and looking into homes. Officers responded and on Joseph Street, located a subject who matched the description given by dispatch. The subject was identified as Alexander Wright age 27, with his Nevada driver's license. As the officer spoke with Wright, he suspected that Wright was under the influence of a controlled substance and evaluated him for this. Wright admitted to recent methamphetamine usage and was placed under arrest for being under the influence. Wright was booked into county jail. 16-2624

On September 8th at about 12:18 pm, UPD officers responded to the Express Mart, located in the 900 block of South State Street, for a report of a domestic assault. Upon arrival officers contacted the adult female victim, who had an injury to her left eye and an abrasion to her left shin. Officers requested an ambulance respond to tend to the victim's injuries. The victim reported that she has just traveled from Boonville to Ukiah with her husband, who she identified as Cory English age 45. English was dropping the victim off at her mother's residence in Ukiah, when English started yelling at the victim and told her to get out of the vehicle. As the victim tried to exit the vehicle, English physically assaulted her. The next day a MCSO Deputy in Philo located and arrested English for the domestic assault. English was booked into county jail. 16-2626

On September 8th at about 1:17 pm, UPD dispatch received a call from an employee at Redwood Coast Regional Center in the 1100 block of Airport Park Blvd., in regards to a suspicious vehicle in the parking lot of the business. The employee was able to provide the license plate of the vehicle, and a description of a male and two children that had walked away from it. UPD dispatch conducted a records check on the vehicle and found that it was reportedly associated with a parental child abduction case out of Santa Maria California. A Kevin Dirksen age 33 was listed as the suspect in the case and the two children reported abducted, were his 7 and 12 year old sons. There was also a domestic violence restraining order in place, restricting Dirksen from having contact with the children. UPD officers, Detectives and a MCSO Deputy, immediately responded to the location, saturated the area looking for Dirksen and the two children. Dirksen was located inside of Wal*Mart and taken into custody without incident. The 7 and 12 year old were also located, transported to UPD where one of our officers provided them with a meal because they were hungry. The children were then turned over to the custody of Child Protective Services. Dirksen was booked into county jail for violation of a domestic violence restraining order and a felony warrant out of Santa Barbara County for child abduction; bail set at \$100,000.

On September 8th at about 10:39 pm, UPD officers were dispatched to Lucky's in the 500 block of East Perkins Street, regarding a disturbance. Upon arrival officers contacted Anthony Kochie age 29, who had been previously told by an employee to leave the store and instructed not to return, due to prior attempted thefts. A records check revealed that Kochie had a misdemeanor warrant for his arrest, for prior drug offences. Kochie was placed under arrest for the warrant and booked into county jail. 16-2632

Bioletto was on probation for prior narcotic offenses, with terms of search and seizure. The officer performed a traffic stop on the vehicle and contacted Bioletto. As the officer spoke with Bioletto, he suspected she was under the influence of illegal drugs. Bioletto was also found to be in possession of methamphetamine and drug paraphernalia. Bioletto was cited for the violations in the field and provided with a court appearance date. 16-2633

On September 8th at about 11:38 pm, a UPD officer on patrol observed a subject in the 200 block of Mason Street, who he knew as Thomas Dean age 27. The officer knew Dean to be on CDC Parole and contacted him. Dean was found to be in possession of drug paraphernalia, suspected methamphetamine and placed under arrest for the violations. CDC Parole was contacted and a Parole warrant was issued for Dean. Dean was booked into county jail. 16-2634

On September 9th at about 10:16 pm, a UPD officer on patrol was at Alex Thomas Plaza, where the Chili Cook Off was being held. The officer was contacted by Sheriff Tom Allman, who reported a subject that was causing a disturbance. Another officer responded to assist and they contacted Daniel Delossantos age 49, who was known by the officers. A records check revealed that Delossantos was on probation with terms that included search and seizure. When officers attempted to search his person per his probation, Delossantos attempted to assault the officer and he was taken into custody. Delossantos was placed under arrest for violation of his probation and resisting / delaying an officer. Delossantos was booked into county jail. 16-2639

On September 9th at about 11:56 pm, a UPD officer was dispatched to a residence in the 600 block of Willow Avenue, to investigate an intoxicated female, who was located on the resident's porch. The officer located the female subject, who had road-rash on her hands, no shoes on and smelled strongly of alcohol. The female subject was identified as Lauren Mcentee age 27. Mcentee was placed under arrest for public intoxication and booked into county jail. 16-2642

On September 10th at about 2 am, a UPD officer performed a traffic stop on a vehicle in the 300 block of East Perkins Street, for a traffic violation. The driver was identified as Feras Asfour age 32. As the officer was talking with Asfour he suspected that Asfour was intoxicated and began a DUI investigation. Asfour was placed under arrest for DUI, but refused to provide an alcohol screen test. A local Judge was contacted and a search warrant was granted to draw a blood sample from Asfour. Asfour was taken to UVMC, the warrant was served for the blood draw and afterwards Asfour was booked into county jail. 16-2643

On September 11th at about 12:34 am, a UPD officer was conducting a security check at Redwood Children Services in the 300 block of East Gobbi Street, when he found a female subject sleeping on the south porch. RCS had requested UPD check the location during the night time hours, due to transients camping at the location and leaving syringes behind. The female subject was identified as Kelisha Alvarez age 27. Alvarez was cited in the field for illegal camping and provided a court appearance date. 16-2647

On September 11th at about 1:13 am, a UPD officer was dispatched to the area of the railroad tracks behind 139 Ford Street, for a report of subjects heard shouting at the location. Upon arrival the officer observed a female subject near the location, who was screaming and appeared to be intoxicated. As the officer attempted to contact the female subject she fled on foot, but was caught and detained. The female subject was identified as Andrea Kidd age 27. Kidd was placed under arrest for public intoxication and resisting / delaying an officer. A records check revealed that Kidd was on felony probation with a no alcohol clause and two felony warrants. On September 11th at about 2:28 am, a UPD officer responded to a physical fight reported in the area of Perkins and State Street. Upon arrival the officer contacted two subjects, one of which was identified as Andrew Anthony age 30. Anthony was found to be belligerent and intoxicated. As the officer went to place Anthony under arrest for public intoxication, Anthony attempted to resist the officer, who physically restrained him. Anthony was placed under arrest for public intoxication and resisting / delaying an officer. Anthony was booked into county jail. 16-2649

On September 11th at about 2:51 am, a UPD officer was patrolling in the 600 block of South State Street, when he heard a female subject screaming in some type of distress. As the officer attempted to locate the female, he was flagged down by a female subject who was holding a young child. The female subject was visibly upset and primarily Spanish speaking. The officer learned that the victim has been separated from her husband Luis Mendoza age 30, for the last 8 months. Before contacting the police, they became involved in a verbal argument that turned physical when Mendoza physically assaulted the victim causing visible injuries. The victim was able to flee the scene where the assault occurred. Mendoza was located in the area and found to be intoxicated. Mendoza was placed under arrest for the domestic assault and booked into county jail. 16-2650

On 9-11-16 at 11:53 PM, UPD officers were dispatched to the area of 800 bock of S. Orchard Ave. regarding multiple gunshots being fired. Simultaneously, an officer who was actively on patrol, also heard multiple rounds being fired.

Upon officers' arrival, it was determined that a disturbance had occurred between numerous people at 890 S. Orchard Ave. The disturbance involved numerous people who were at the apartment complex and as well as multiple subjects who had arrived in numerous vehicles at the location. During the disturbance, multiple shots were fired, two of which struck the apartment complex and were in the direction of multiple people. Nobody was struck by a bullet. Multiple vehicles then fled the area on S. Orchard Ave.

UPD detectives were summoned and are actively investigating the incident and pursuing all leads. UPD is not ruling out that the incident is possibly gang related.

On September 12th at about 10:59 am, a UPD officer was dispatched to a residence in the 200 block of Low Gap Road, regarding a burglary report. Upon arrival the victim told the officer that on September 11th at about 7 pm, his garage was locked and secured for the evening. This morning just before calling the police he noticed a broken window located at the rear of his garage and a padlock that had been removed from a metal storage shed on his property. The victim said that the only thing he found missing was a 8" x 3" wooden Cedar box, that had been inside his garage on a work bench. 16-2656

On September 12th at about 5:15 pm, a UPD officer was on patrol, when he observed a blue colored Chevrolet Malibu in the 300 block of Mason Street, traveling at a high rate of speed. As the vehicle passed the officer, he recognized the driver as Alexander Louis Jackson age 33, from prior law enforcement contacts. The Malibu reached a speed of approximately 75 MPH, as the officer attempted to catch up with him. The Malibu turned westbound onto East Smith Street and as the officer caught up, Jackson parked the vehicle in the 200 block of East Smith Street. Jackson exited the vehicle, walked into the middle of the roadway and took a fighting stance with his fists held up. The officer had requested a backup officer respond and gave Jackson verbal orders. Jackson calmed down, tossed the keys to the officer and made a statement that he was drunk. As the officer spoke with Jackson, he suspected that Jackson was indeed intoxicated and began a DUI investigation. Jackson was placed under arrest for DUI and later booked, cited and released with a court appearance date. 16-2661

On September 13th at about 1:09 am, a UPD officer on patrol observed a vehicle in the 700 block of South State Street. The officer recognized the driver as Sebastian Ceja age 24, and was aware that Ceja had a misdemeanor warrant for his arrest. The officer performed a traffic stop on the vehicle, contacted and arrested Ceja without incident. Ceja was booked into county jail. 16-2663

On September 13th at about 1:13 am, a UPD officer was dispatched to the 300 block of North Main Street, regarding a report of a stranger knocking on the reporting party's door. Upon arrival the officer contacted the male subject, who he recognized as Mason McGee age 22. As the officer questioned McGee, it was clear that he was intoxicated. An officer spoke with the driver, who reported that she drove into the parking lot of JC Penney's as there is a bus stop on the west edge of the parking lot. Several people exited and entered the bus, and the driver noticed that Palacios was walking around the parking lot yelling and talking to himself. The driver closed the doors to the bus, as she was frightened by his behavior. Palacios then started hitting and pulling on the front passenger double doors, with his hands trying to pry them open. After Palacios damaged the doors to the bus, he went to the driver's side and pulled on the driver side mirror, breaking it. Palacios was placed under arrest for vandalism and booked into county jail. 16-2666

On September 13th at about 2:29 pm, UPD officers were northbound in the 2200 block of North State Street when they saw a silver Honda sedan traveling southbound. The Honda sedan appeared to be spray painted and the officers were aware of a recent Ukiah-CHP BOLO regarding a stolen vehicle that matched that description, California License

2WKU266. Officers turned their vehicle around, as the Honda turned westbound onto Orr Springs Road. Officers caught up to the vehicle in the 200 block of Pinoleville Drive as it parked and a person started to exit. A female driver and two male passengers were detained. The driver was identified as Sarah Auclair age 26 and the passengers as Donald Willett age 32 and Joshua Hanover age 28. Auclair was placed under arrest for possession of the stolen vehicle / possession of stolen property. A records check revealed that Joshua Hanover had a felony warrant for his arrest for violation of his Post Release Community Supervision (PRCS / AB109). Hanover was placed under arrest without incident. A records check revealed that Willett was on probation for prior drug offences. Willett was found to be in possession of methamphetamine and placed under arrest for the violation and for violating his probation. Auclair and Hanover were booked into county jail. Willett was cited in the filed for the violations and provided with a court appearance date. 16-2674
