### **Highlights for the Week**



On September 14<sup>th</sup> at about 8:52 am, a UPD officer was dispatched to Tractor Supply Co. in the 1200 block of Airport Park Blvd., regarding an attempted theft and vandalism report. The employee reported that on September 13<sup>th</sup> at about 8 pm, the gates to the fenced outside storage yard were locked for the evening. The following morning at about 8 am, the employee arrived back to work and noticed a black utility trailer had been loaded with a large gun safe, a 5500 watt generator, three large tool boxes, and a wheeled string trimmer. Upon inspecting the surrounding fence, a damaged area was located where fence material had been cut and removed. For

an unknown reason the potential thieves did not take the loaded trailer. 16-2680

On September 14<sup>th</sup> at about 11:51 am, a UPD officer was dispatched to 600 Live Oak, regarding a civil dispute over a grey Mazda sedan. UPD dispatched advised the responding officer that the possible driver had 3 warrants for his arrest. Upon arrival the officer contacted the driver, who was identified as Tyrone Lamar age 48. A records check conformed that Lamar had three misdemeanor warrants and he was taken into custody without incident. Lamar was booked into county jail. 16-2683

On September 14<sup>th</sup> at about 4:15 pm, a UPD officer on patrol in the 200 block of Irvington Drive, observed a subject he recognized as Merrill Walrath, outside of a residence. The officer was aware that Walrath had multiple warrants for his arrest. Walrath was contacted and placed under arrest for the two felony and three misdemeanor warrants. Walrath was booked into county jail. 16-2685

On September 14<sup>th</sup> at about 8:54 pm, a UPD officer was dispatched to the 100 block of Clara Avenue to investigate a disturbance, involving two males and a female subject. Upon arrival the officer contacted the three, who were identified as Robert Galletti age 22, Sarah Jacobsen age 39 and William Williams age 24. The officer learned that the two males had been involved in a verbal argument that almost turned physical, just before the officer arrived. Williams was found to be the primary aggressor and a records check revealed that Williams was on probation with an "Abstain from alcohol" clause. Williams completed an in the field breath test, results being .25% BAC. Williams was placed under arrest for violation of his probation and booked into county jail. 16-2687

On September 14<sup>th</sup> at about 11:56 pm, UPD officers were dispatched to Safeway on South State Street, regarding a confrontation with two male adults and a female adult. All three subjects were located in the area and contacted. During the investigation one of the subjects was identified as Jeremiah Luna age 34, who immediately became confrontational with officers and had to be physically restrained. Luna was found to be intoxicated and placed under arrest for public intoxication. Luna was booked into county jail. 16-2688

On September 15<sup>th</sup> at about 3:55 am, UPD officers were dispatched to Safeway, regarding an intoxicated male subject causing a disturbance. Upon arrival an officer noticed a male subject standing in front of the west entrance to the business yelling. The officer immediately recognized the subject as Jared Kidd age 25, who is known to officers from prior contacts. The officer was aware that Kidd was on Felony probation for a prior stolen vehicle case and had a no alcohol term on his probation. While officers approached Kidd, he removed his T-shirt and tensed up when facing UPD officers, flexing his muscles. Kidd yelled to the officers "Come on!" Officers were able to physically restrain Kidd, who was found to be intoxicated. Kidd was placed under arrest for public intoxication and for violation of his probation. Kidd was booked into county jail. 16-2689

On September 15<sup>th</sup> at about 4:05 pm, a UPD officer was dispatched to the area of the railroad tracks, south of East Gobbi Street, on a report of a female adult going to the bathroom in public. UPD dispatch advised the female was described as heavy set with red hair. Upon arrival the officer noticed a subject that matched the description who he knew to be Kelisha Alvarez age 27, from prior police contacts. The officer first spoke with a female witness. The witness reported that she helps maintain the community garden for the Village Circle apartments, when she noticed Alvarez walk to the east side of the railroad tracks, pull her pants down and go to the bathroom. When asked the witness wanted Alvarez cited for the violation and was even willing to place Alvarez under citizen arrest. A records check revealed that Alvarez was on probation. Alvarez was contacted and cited for urinating in public and violation of her probation. 16-2695

On September 15<sup>th</sup> at about 8:25 pm, a UPD officer performed an enforcement stop on a vehicle in the 300 block of Talmage Road for a traffic violation. While talking with the driver about the violation, the passenger was identified as David Gonzalez-Garcia age 20. A records check revealed that Gonzalez-Garcia had a felony warrant for his arrest for robbery case. Gonzalez-Garcia was placed under arrest and booked into county jail. 16-2697

On September 15<sup>th</sup> at about 1:36 am, a UPD officer contacted a female subject in the 200 block of Talmage Road. The officer knew the subject as Sherri Neeley age 46, from prior contacts. A records check revealed that Neeley had a misdemeanor warrant for her arrest, for violation of her probation. Neeley was placed under arrest and booked into county jail. 16-2698

On September 15<sup>th</sup> at about 11:19 pm, a UPD officer performed an enforcement stop on a bicyclist in the 100 block of Talmage Road. The rider was identified as Shayla Guerrero age 27. A records check revealed that Guerrero was on probation for prior drug offences, with orders to submit to search and seizure. During a search of Guerrero, she was found to be in possession of several access cards in other people's names and an I-phone 6 that did not belong to her. When asked Guerrero said she found the access cards and did not know who the phone belonged to. Guerrero was placed under arrest for unlawful possession of access cards, misappropriation of lost property and violation of her probation. She was later booked, cited and released with a court appearance date. 16-2699

On September 16<sup>th</sup> at about 5:34 pm, a UPD officer performed an enforcement stop on a vehicle in the 100 block of North State Street, for a traffic violation. The officer walked up to the vehicle and immediately smelled a strong odor of marijuana coming from the driver's open window. The driver was identified as Francisco Alfaro age 21 and a passenger as Erick Vargas age 26. Alfaro told the officer that he did not have a license and a records check revealed that not only was his license suspended, he was on probation out of San Joaquin County. Both had recently traveled from Los Angeles to Mendocino County. Alfaro and Vargas were found to be in possession of cocaine and marijuana and placed under arrest. Alfaro was booked into county jail for transportation of marijuana for sale, possession of cocaine, violation of probation, and driving suspended. Vargas was placed under arrest for transportation of marijuana for sale and possession of cocaine. Vargas had to be cited in the field for the violations, as he needed a medical clearance to enter into jail. 16-2702

On September 16<sup>th</sup> at about 7:44 pm, a UPD officer was dispatched to the 100 block of Talmage Road, regarding an intoxicated male subject causing a disturbance. Upon arrival the officer located the subject, who he identified as Danny Ray age 51. The officer was aware that Ray was on probation, with a term of abstain from alcohol. As the officer spoke with Ray it was clear that he was intoxicated. Ray was placed under arrest for public intoxication and for violation of his probation. Ray was booked into county jail. 16-2704

On September 16<sup>th</sup> at about 10:56 pm, a UPD officer was checking the parking lot of Wal-Mart on Airport Park Blvd., when he contacted a male subject. The male subject was identified as Zackary Meadows age 30 and a records check revealed that Meadows was on probation out of Butte County for prior drug offences, subject to search and seizure and had a prior felony conviction. Meadows was found to be under the influence of a controlled substance and during a search of his person was found to be in possession of pepper spray. Meadows was placed under arrest for being under the influence of a controlled substance and for a felon being in possession of pepper spray. Meadows was booked into county jail. 16-2707

On September 17<sup>th</sup> at about 4:29 pm, UPD officers were at a residence in the 200 block of Ford Street on an unrelated call for service, when a UPD officer saw a male subject attempt to flee into the backyard. As officers looked for the subject, an officer heard a noise behind a shed and saw a piece of carpet on the ground moving. Officers located Joseph Mork age 33 underneath the carpet, who they knew from many prior police contacts. Officers were aware that Mork had a felony warrant for violation of his probation and arrested him without incident. Mork was booked into county jail. 16-2712

On September 17<sup>th</sup> at about 7:38 pm, a UPD officer was dispatched to the park in the 900 block of North Oak Street, regarding a report of a male and female subject smoking a controlled substance and refusing to leave the park. Upon arrival the officer located the two, one of which he recognized as Tina Cornwall age 22. The other subject verbally identified himself as Calvin Morgan, but was later identified as Joshua Moore age 28. Moore was detained in handcuffs and once he was properly identified, a records check revealed that he was on Post Release Community Service (PRCS / from AB109). Moore had two felony warrants for his arrest, one for violation of his Post Release Community Service and the other for drug offences. Moore was placed under arrest for providing false ID to a police officer and for the warrants. 16-2713

On September 18<sup>th</sup> at about 7:53 pm, a UPD officer was dispatched to the 100 block of North Main Street, to investigate a theft. UPD dispatch advised that a taxi driver had a female who was refusing to pay her \$400 taxi bill. Upon arrival the taxi driver reported that he picked the female fare up at the Marriott in SF and she asked to go to Ukiah. Once they arrived the fair calculated to be \$427.50. When the driver stopped at this destination, the female got out and ran. The taxi driver ran after, caught and detained the female. The female verbally identified herself as Samantha Bea, but was later identified as Natalia Owen age 18. Owen not only provided a false name, but made a false report to officers accusing the taxi driver of abducting her. Through the investigation, the officer was able to dispel Owen's claim. Owen was found to be under the influence of a controlled substance and was placed under arrest for this violation, for providing a false name to a police officer and making a false report of a crime. Owen was booked into county jail. 16-2619

On September 18<sup>th</sup> at about 10:52 pm, UPD officers were dispatched to the Hampton Inn on Airport Park Blvd., regarding a physical altercation. Upon arrival officers noticed a group of subjects standing in the parking lot of the hotel, pointing to a subject, who was later identified as Miguel Lopez age 37. The group of subjects advised officers that Lopez was the one causing the disturbance and challenging people to fight. Upon contacting Lopez it was clear that he was quite intoxicated. Lopez was placed under arrest for public intoxication, handcuffed and placed inside of a patrol vehicle. Lopez began to slam his head on the protective partition between the front and rear seats. For Lopez' safety, he was removed from the vehicle and officers tried to calm him down. Lopez had to be placed in an additional leg restraint device, so he could safely be transported to jail. Lopez was booked into county jail for public intoxication and resisting / delaying an officer. 16-2621

On September 18<sup>th</sup> at about 11:22 pm, UPD officers were dispatched to the 200 block of Norton Street, to investigate a disturbance. Upon arrival a victim reported that she was inside her residence, when she was contacted and advised that a male subject had thrown a beer bottle at her vehicle. The victim went out to investigate and found broken glass all over her back window. Witnesses who saw the incident, identified Jeremy Beebe age 25, as person who throw the beer bottle. Beebe was located and contacted by officers. Beebe was found to be intoxicated and was placed under arrest for public intoxication. Beebe resisted during his arrest and had to be physically restrained. Beebe was booked into county jail for public intoxication and resisting / delaying an officer. 16-2622

On September 19<sup>th</sup> at about 12:27 pm, a UPD officer was dispatched to the front lobby of the PD regarding a late reported vandalism. Upon arrival the officer contacted the reporting party, who was an employee of Taco Bell located in the 1200 block of North State Street. The employee reported that he works as maintenance for Taco Bell and this morning he noticed someone had vandalized one of the drive-thru signs. The employee provided the officer with video surveillance of the vandalism. Upon review the officer could see a vehicle enter the parking lot of Taco Bell on September 17<sup>th</sup> at about 12:38 am and proceed to the drive-thru. The vehicle appears to be 90's model four door Ford F250, long-bed 4wd pickup, with silver and blue two tone paint and five lights on the top of the cab. There are two signs inside the bed of the pickup. The vehicle stops and an adult male wearing a ball cap and light colored pants and shirt exits the rear driver side of the vehicle and approaches the drive-thru sign. The male subject begins to tug and pull on the sign, attempting to dislodge it from its mount. Moments later another male wearing a light colored shirt and dark pants, exits the passenger side of the vehicle and kicks the sign. The two then get back into the vehicle and leave. The damage to the sign was estimated at over \$1200.00. 16-2725

On September 20<sup>th</sup> at about 2:15 am, UPD officers were dispatched to the trailer park in the 300 block of North Main Street, on a report of a suspicious person. Upon arrival an officer spoke with a witness. The witness reported that a male subject had been seen standing next a white Ford van parked in front of one of the trailers. The witness was worried that the male subject was possibly attempting to break into the van. Shortly after calling the police, the subject ran eastbound behind a trailer and into a backyard. Officers searched and located a subject known as Norman White age 36, from prior police contacts. As officers spoke with White it was clear that he was intoxicated. A records check revealed that White was on probation. White was placed under arrest for public intoxication, prowling, and violation of his probation. White was booked into county jail. 16-2730
