The Patrol Division's average response time to in-progress calls was a little over 4 minutes. The average response time to all other calls was a little over 11 minutes.

### Highlights for the Week

On September 21<sup>st</sup> at about 7:44 am, UPD officers were dispatched to the Best Western in the 500 block of South Orchard Avenue, regarding a burglary. Upon arrival the officer spoke with an AT&T employee, who reported that someone had broken into two AT&T work trucks and stole various items. The employee told the officer that he and several coworkers were staying at the Best Western and working in the Ukiah area. On this night, at about 8 pm, their vehicles were parked and locked for the evening. The following morning the employee found that windows on the vehicles had been smashed and numerous items stolen, including a yellow telephone cable locator valued at \$1500.00. 16-2743

On September 21<sup>st</sup> at about 9:04 pm, a UPD officer contacted two male subjects in the 1300 block of South State Street. One of the subjects was identified as Jesse Blanton age 38. A records check revealed that Blanton had a felony warrant for violation of his Post Release Community Supervision (PRCS / AB109). On September 22<sup>nd</sup> at about 3:53 pm, a UPD officer was dispatched to the 1000 block of South State Street for a possible DUI driver. Upon arrival the UPD officer contacted a Ukiah CHP Officer, who reported that he was driving westbound in the 100 block of Talmage Road, when he noticed smoke coming from an orange Subaru that had front end damage. The CHP officer conducted a traffic stop on the vehicle, to check on the welfare of the driver, who was identified as Carly Glass age 29. The CHP officer noticed that Glass was possibly intoxicated. During the DUI investigation the UPD officer determined that Glass had just been involved in a traffic collision and was driving back to her residence claiming to get money for the other driver she had hit. A records check revealed that Glass was on DUI probation. Glass was placed under arrest for DUI and for violation of her probation. Glass was booked into county jail. 16-2756

On September 23<sup>rd</sup> at about 7:38 pm, a UPD officer was dispatched to a possible fight in the area of Mason Street and Clara Avenue. UPD dispatch advised that the reporting party said the subjects were associated with an older model Toyota 4Runner. The officer arrived on scene and made contact with a vehicle that matched the description. There were five individuals inside the vehicle and all parties denied being involved in any type of altercation. During the investigation one of the occupants was identified as Robert Dillon age 43. A records check revealed that Dillon had two warrants out of Solano County, one for an assault with great bodily injury and the other for vandalism. Dillon was placed under arrest without incident and booked into county jail. 16-2763

On September 23<sup>rd</sup> at about 11:06 pm, a UPD officer conducted an enforcement stop on a black SUV in the 700 block of South Oak Street. The driver was identified as Steven Amato age 56 and the passenger as Rachael Cunnann age 41. As the officer spoke with Amato he suspected that Amato was intoxicated and began a DUI investigation. A records check revealed that Amato's license was suspended and he was on probation for a prior DUI and drug offence. Amato was placed under arrest for DUI, driving suspended and for violation of his probation. A records checked that Cunnann was on felony probation for a prior burglary, with orders to abstain from alcohol. Cunnann submitted to a field breath test results being .17 % BAC. Cunnann was placed under arrest for violation of her probation. Amato was booked into county jail and Cunnann was booked, cited and release with a court appearance date. 16-2765

On September 24<sup>th</sup> at about 1:06 am, a UPD officer was conducting a security check at a business in the 1200 block of Airport Park Blvd., The business had been the victim of a recent burglary. As the officer was driving through the rear driveway, he observed a large piece of cardboard standing on its edge against the southwest corner of the building. The officer saw the face of a male subject looking at the officer through a gap between the edge of the cardboard and the male appeared to be trying to hide. The officer exited his patrol car and once he could completely see the male subject, he recognized him as Nicholas Commander age 38, from prior police contacts. A records check revealed that Commander was on probation for a prior assault with a deadly weapon case and had terms of search and seizure. Commander was found to be in possession of methamphetamine and pepper spray. Commander was placed under arrest for possession of a controlled substance, felon in possession of pepper spray and for violating his probation. Commander was booked into county jail. 16-2766

On September 24<sup>th</sup> at about 12:45 pm, a UPD officer was dispatched to a residence in the 200 block of Arlington Drive, for a report of a female threatening her roommate with a hammer. The officer was aware of this residence, because he had responded it for disturbance calls three times in the previous week. All three times it was reported that a subject named Jerriann Barnes age 54 had made verbal threats towards others and was walking around the house with a hammer. Upon arrival the victim reported that she was helping her friend move out of Barnes's house. On this date, Barnes had come out of her bedroom holding a hammer and was acting in an aggressive manner, causing the victim to fear for her safety. Later the victim was pushed and yelled at by Barnes and the victim wanted Barnes prosecuted for the assault. When officers

went to detain Barnes, she attempted to pull away from them and had to be physically restrained. Barnes was placed under arrest for battery and for resisting / delaying an officer. Barnes was booked into county jail. 16-2772

On September 24<sup>th</sup> at about 12:38 pm, a UPD officer was dispatched to the 200 block of North Orchard Avenue, regarding subjects camping inside the MTA bus stop. Upon arrival the officer contacted two subjects who were identified as Thomas Galindo age 40, and Thomas Sanders age 54. A records check revealed that Galindo was on probation with an abstain from alcohol clause. Galindo was found to be intoxicated and placed under arrest for violation of his probation. A records check revealed that Sanders had a misdemeanor warrant for violation of his probation and he was placed under arrest. Both were booked into county jail. 16-2773

On September 24<sup>th</sup> at about 5:46 pm, a UPD officer was dispatched to the Forest Club Bar in the 200 block of North State Street, for a report of a physical fight. Upon arrival the officer noticed three male subjects in front of the location on the sidewalk. One of the subjects was belligerent and officers learned that he had been trying to start fights. This subject was identified as Solomon Allard age 25. Allard was found to be extremely intoxicated and was placed under arrest for public intoxication. Allard was booked into county jail. 16-2776

On September 24<sup>th</sup> at about 10:05 pm, UPD officers were dispatched to the Forest Club Bar in the 200 block of North State Street. A female adult had called 911 and reported that she was not being allowed inside the bar. UPD dispatch told the responding officers that the female adult had called 911 on three separate occasions. Upon arrival officers contacted the female, who was identified as Tatiana Sanders age 39 from Florida. An employee of the bar told officers that Sanders had recently been inside the bar, was intoxicated causing problems and had been asked to leave. Sanders was told she was not welcome inside the bar anymore. An Officer asked Sanders to leave and she agreed not to return. At about 10:28 pm, UPD officers were dispatched back to the Forest Club Bar on a report that Sanders returned. Sanders was placed under arrest for public intoxication and booked into county jail. 16-2778

On September 25<sup>th</sup> at about 1:01 am, a UPD officer conducted an enforcement stop in the 700 block of South State Street, for traffic violations. The driver was identified as Michael Koroma age 21. As the officer spoke with Koroma, he suspected that Koroma was intoxicated and began a DUI investigation. Koroma was placed under arrest for DUI and later booked, cited and released with a court appearance date. 16-2779

On September 25<sup>th</sup> at about 2:22 am, a UPD officer was driving through the parking lot of Lucky's on East Perkins, when he heard what sounding like someone climbing the chain link fence that surrounds Chipotle. The officer exited his patrol vehicle, and noticed a men's mountain bike near the chain link fence that surrounds the building. The officer called for another unit to respond to assist, as the officer climbed up on a concrete wall to look into the fenced construction site. The officer observed a male subject lying on the ground attempting to conceal himself. The officer verbally called out to the subject and verbally directed the subject to approach the cover officer who had arrived. The officers recognized the subject as Zebulon Couthren age 41. A records check revealed that Couthren was on felony probation from a prior unlawful imprisonment case and he had terms of search and seizure, no marijuana, and no alcohol. Couthren was found to be in possession of marijuana and drug paraphernalia. Couthren was placed under arrest for violation of his probation and booked into county jail. 16-2780

On September 25<sup>th</sup> at about 3:34 pm, a UPD officer was dispatched to BJ's Embroidery & Screenprint in the 200 block of East Smith Street, for a report of a broken front glass door. Upon arrival the officer noticed that the front door to the business had been smashed and glass was on the sidewalk. The officer spoke with a nearby local citizen, who stated that he left the New Life United Pentecostal Church at about 1 pm and did not notice the damage at that time. The citizen returned at about 3:30 pm and noticed the front door was smashed. Officers checked the interior and no one was located. The owner of the business was contacted and responded. The owner estimated that about \$300 cash was stolen and provided no suspect information. 16-2785

On September 25<sup>th</sup> at about 10:06 pm, a UPD officer on patrol in the 600 block of Joseph Street, observed a subject he knew as Eric Silkhoaglin age 26. The officer conducted a records check and found that Silkhoaglin had a misdemeanor warrant for a past resisting arrest case. The officer contacted and placed Silkhoaglin under arrest without incident. Silkhoaglin was booked into county jail. 16-2787

On September 25<sup>th</sup> at about 11:17 pm, a UPD officer was on patrol in the 500 block of Mason Street, when he observed a subject he know as Joshua Keys age 25. The officer was aware that Keys had an active felony probation pick up order and contacted him. Keys was placed under and booked into county jail. 16-2790

The officer was aware that Keyser had two misdemeanor warrants for his arrest for violation of his probation. On September 26<sup>th</sup> at about 8:19 pm, UPD officers were dispatched to the 1100 block of Mulberry Street, regarding a verbal altercation between a male and two female subjects. the bus driver was able to drive away from the male subject and was waiting behind JC Penny. An Officer arrived and contacted the female bus driver. The bus driver told the officer that she had stopped the bus in JC Penny parking lot and exited, in order to assist a handicapped veteran in a wheelchair get off the bus. While working the handicapped lift, a male subject approached and asked the driver if she had a cigarette lighter. The male subject was later identified as Ruben Herrera age 47. The bus driver told Herrera she did not and he became very agitated. The bus driver was scared and as soon as possible she got back into the bus and closed the doors. Herrera yelled profanities at her and started punching and kicking the double doors of the bus. The bus driver drove away and contacted the police. Near the bus stop where the incident took place, officers located Herrera, who was seated on the ground next to an open bottle of Rum. As the officers contacted Herrera, he immediately became belligerent toward the officers and physically resisted officers, while calling the bus driver vulgar names as he was being detained. A records check revealed that Herrera was on probation. Herrera was placed under arrest for public intoxication, violation of his probation and resisting an officer. 16-2812

On September 27<sup>th</sup> at about 4 pm, a UPD officer was in the 200 block of Clara Avenue, when he saw a male subject seated in the driver seat of an SUV. The officer recognized the subject as Rodolfo Ceja, who had 2 felony and 1 misdemeanor warrant for his arrest. The officer contacted Ceja and placed him under arrest without incident. Ceja was booked into county jail. 16-2813

On September 27<sup>th</sup> at about 8:28 pm, a UPD officer was dispatched to Kohl's regarding a shoplifter who had just fled the store and was last seen southbound on North Orchard Avenue on a yellow mountain bike. As the officer arrived he searched the surrounding area and located the suspect, behind an enclosed electrical station near JC Penny. The officer recognized the subject as Kyle Gillespie age 33. The officer was aware that Gillespie had an active felony warrant for his arrest and placed him in custody without incident. The officer learned from Kohl's employee that Gillespie has stolen a pair of JBL headphones from the store. During a search of Gillespie, he was found to be in possession of methamphetamine. Gillespie was booked into county jail for shoplifting, possession of drug paraphernalia, violation of his probation, and the warrant. 16-2816

On September 27<sup>th</sup> at about 10:30 pm, a UPD officer was dispatched to the Co-op in the 700 block of South State Street, regarding a man down in the parking lot. The officer contacted and woke up the man, who was identified as Anderson Mannon age 24. As the officer spoke with Mannon, it was clear that he was extremely intoxicated. Mannon was placed under arrest for public intoxication and booked into county jail. 16-2817
