A records check revealed that Jarvis has a misdemeanor warrant for her arrest. Jarvis was placed under arrest and booked into county jail. 16-2884

On October 6<sup>th</sup> at about 8:01 pm., a UPD officer was dispatched to Low Gap Park, regarding a possible intoxicated male subject. Upon arrival the officer contacted the subject, who was identified as Christopher Lopez age 27. Lopez had been drinking alcohol and a records check revealed Lopez had a misdemeanor warrant for his arrest. Lopez was placed under arrest and booked into county jail. 16-2890

On October 6<sup>th</sup> at about 8:55 am, a UPD officer responded to an apartment complex in the 800 block of Waugh Lane, on a report of a subject dressed as a clown frightening residents. Upon arrival the officer contacted and spoke with Bryan Lockwood age 25. The officer spoke with Lockwood regarding his behavior, which was causing fear among residents. A records check revealed Lockwood to be on probation and a search revealed that he was in possession of drug paraphernalia. Lockwood was cited in the field for the violations and provided with a court appearance date. 16-2891

On October 6<sup>th</sup> at about 9:33 pm, UPD officers were dispatched to a residence in the 100 block of Evens Street, regarding a male subject causing a disturbance refusing to leave. Upon arrival officers learned that a subject named Sacramento Hernandez age 22 had gotten angry and kicked a hold in his father's \$1,200 television. Hernandez' father wanted him arrested for the vandalism. Hernandez was contacted and placed under arrest for the vandalism then booked into county jail. 16-2892

On October 7<sup>th</sup> at about 3 pm, a UPD officer was dispatched to a report of a male subject acting erratic at the pocket park in the 100 block of North Oak Street. Upon arrival the officer made contact with a male subject, who was speaking loudly and ranting about needing to talk to his parole officer. The subject was identified as John Dalkin age 45. A records check revealed that Dalkin had a felony warrant for violation of his parole. Dalkin was placed under arrest for the warrant and booked into county jail. 16-2897

On October 7<sup>th</sup> at about 10:11 pm, UPD officers were dispatched to in front of Wells Fargo Bank on South State Street, on a report of a male subject screaming that he had a knife and wanted to kill people. Upon arrival the officer located the male in the parking lot of Windmill Café. The male subject was extremely agitated, screaming ethnic slurs at the officer and stated he hated his wife. The officer recognized the subject as Kendall Travis age 47 and detained him. A records check revealed that Travis was on probation. Travis was found to be under the influence of drugs and alcohol. Travis was placed under arrest for public intoxication and for violation of his probation. Travis was booked into county jail. 16-2898

On October 7<sup>th</sup> at about 11:23 pm, UPD officers were dispatched to the area of the Perkins Street Bar, for a report of a male subject causing a disturbance. Upon arrival officers located the subject in the area and identified him as Dallas Nelsen age 38. Nelsen was found to be extremely intoxicated and placed under arrest for public intoxication. On October 8<sup>th</sup> at about 2:11 am, a UPD officer performed an enforcement stop on a white Chevy Blazer in the 100 block of Pomeroy for traffic violations. The officer contacted the driver, who was identified as Alejandro Gonzalez age 23. As the officer spoke with Gonzalez he suspected that Gonzalez was intoxicated and began a DUI investigation. Gonzalez was placed under arrest for DUI. Two heavily intoxicated passengers in the car were contacted and identified as Eduardo Contreras-Nunez age 24 and Jose Sandoval-Reyes age 22. Upon contact Contreras-Nunez identified himself as Amarury Contreras. A records check revealed that Contreras-Nunez was on probation. Contreras-Nunez was placed under arrest for public intoxication, falsely identifying himself and violation of his probation. Sandoval-Reyes was placed under arrest for public intoxication. Gonzalez was booked, cited and released with a court appearance date, while Contreras-Nunez and Sandoval-Reyes were booked into county jail. 16-2901

On October 8<sup>th</sup> at about 2:33 pm, UPD officers were dispatched to Kohl's on North Orchard Avenue, for a shoplifting incident. Dispatch told officers that the male subject was running westbound toward Home Depot, wearing a white shirt and black pants. A UPD officer located the suspect in the parking lot of Home Depot, but when he attempted to contact the suspect he fled. The suspect was caught and detained by UPD officers. The suspect was identified as Richard Ortiz age 31 and a records check revealed that he was on probation. During the investigation officers learned that Ortiz and a 17 year old female subject, selected merchandize that they concealed on their person. Ortiz and the juvenile exited the store making no attempt to pay for the store merchandise. Two store employees went outside and contacted Ortiz and juvenile. Ortiz pushed one of the employees out of the way and fled the area. The juvenile accompanied the employees back into the store. Ortiz was placed under arrest for robbery, resisting arrest and violation of his probation. Ortiz was booked into county jail. The store declined prosecution of the Juvenile and she was released to a relative. 16-2903

On October 8<sup>th</sup> at about 3:21 pm, a UPD officer was dispatched to a report of vandalism that had occurred in the parking lot of the movie theater in the 600 block of South State Street. Dispatch advised the responding officer that a male subject identified as Reginald Nunez age 31, had broken out the back window of the his girlfriend's vehicle and fled the area. Upon arrival the officer spoke with the adult female victim, who was standing outside of her vehicle with her 7 and 8 year old children. The victim reported that she had taken her two sons to the movie theater and after the movie and placed her children in the back of her vehicle. The victim got into the driver's seat and her boyfriend Reginald Nunez got into the passenger seat. The two got into a verbal argument and she asked Nunez to exit the vehicle, because she did not want to argue in front of the children. Nunez exited the vehicle, was angry and threw his metal water bottle through the back window of the victim's vehicle, causing broken glass to go all over her children. Nunez fled the area on foot. At about 9:30 pm, UPD officers located Nunez and placed him under arrest for vandalism and child endangerment. Nunez was booked into county jail. 16-2904

On October 9<sup>th</sup> at about 2:36 am, a UPD officer was dispatched to 100 Cresta Drive, for the report of a suspicious male subject in his underwear. Upon arrival the officer located the subject who was identified as Zachary Scott Simons age 29. A records check revealed that Simons was on probation. As officers spoke with Simon it was clear that he was intoxicated. Simons was placed under arrest for public intoxication and booked into county jail. 16-2907

On October 9<sup>th</sup> at about 11:04 am, a UPD officer was dispatched to the Ukiah Natural Foods in the 700 block of South State Street, regarding a subject causing a disturbance. Upon arrival the officer contacted the subject, who was known as John Palacios age 47 from prior police contacts. The business was hosting an event with live music, tents, and employees were cooking food and serving the crowds of people. The manager was contacted and reported that Palacios was yelling at customers, causing complaints and being disruptive at the event. The manager wanted Palacios to leave. The officer talked with Palacios, who displayed bizarre behavior, was angry and yelling as he left. At 11:43 am the officer was

dispatched back to the business, in regards to Palacios returning and again causing a disturbance. Palacios was re-contacted and placed under arrest for trespassing. Palacios was booked into county jail. 16-2909

On October 9<sup>th</sup> at about 4:15 pm, a UPD officer was dispatched to a residence in the 600 block of Leslie Street, on a report of a stolen vehicle. At about 9:30 pm, a UPD officer was dispatched to UVMC in regards to Mitchell being medically cleared, but refusing to leave. Mitchell was resistive toward officers and placed under arrest for public intoxication and resisting / delaying an officer. Mitchell was booked into county jail. 16-2919

On October 11<sup>th</sup> at about 9:14 am, a UPD officer on patrol observed a male run eastbound across the 400 block of South State Street. The officer recognized the subject as Thomas Dean age 27. The officer was aware that Dean was on Parole so he contacted him.
