Highlights for the Week

On January 4th at about 9:24 am, a UPD officer was dispatched to Mendocino Community Health Clinic on South Dora Street, regarding a burglary. Upon arrival the officer spoke with the reporting party, who was an employee for the clinic. The employee reported that sometime between December 29th and January 2nd, someone made entry and stole over \$2900 worth of equipment that included card and biometric readers. 17-0031

On January 4th at about 11:46 am, a UPD officer conducted an enforcement stop on a green Cadillac in the 1200 block of South State Street. The driver was identified as Luis Zamora age 20, a local resident. A records check revealed that Zamora was on probation and his license was suspended. Zamora was placed under arrest and booked into county jail. 17-0034

On January 4th at about 12:32 pm, a UPD officer was dispatched to the Yokayo School, regarding possible subjects camping inside of a shed. Upon arrival the officer contacted the subjects, who he knew as Erik Elder age 49 and Hope Jarvis age 20, both transients. The officer found that the side panels of the shed had been removed to gain access and both had been camping inside. On January 4th at about 1:25 pm, UPD officers were dispatched to Social Services on South State Street, regarding a possible domestic violence incident. While responding, officers were informed that the male and female had left together in a blue Toyota, which was located in front of Safeway. Officers contacted the two, one of which was identified as Eric Wing age 34, out of Upper Lake. The other was identified as Wing's ex-girlfriend, an adult female out of Nice. During the subsequent investigation officers learned that the two were at Social Services to get a new EBT card. Upon returning to their vehicle, Wing and his ex-girlfriend got involved in an argument. There was a physical altercation, but officers were unable to determine who the primary aggressor was. A records check revealed that the ex-girlfriend was the protective person in a restraining order, which Wing had violated. Wing was placed under arrest for the court order violation and was booked into county jail. 17-0037

On January 4th at about 7:13 pm, a UPD officer performed a traffic stop on a vehicle in the 100 block of Hospital Drive, for a traffic violation. The driver was identified as Jose Virgen age 24, a local resident. As the officer spoke with Virgen, he suspected that Virgen was under the influence of drugs and alcohol and began a DUI investigation. Virgen was placed under arrest for DUI alcohol / drugs and booked into county jail. 17-0039

On January 5th at about 10:48 am, UPD officers were dispatched to an apartment in the 600 block of Mason Street, regarding a domestic assault. Upon arrival officers contacted the two subjects, one identified as Michael Patton Jr. age 25. During their investigation, the officers learned that Patton Jr. had been involved in a verbal argument with his 20 year old girlfriend and mother to his child. During the argument Patton Jr. physical assaulted his girlfriend, but she was not injured. Patton Jr. was placed under arrest for the domestic assault and booked into county jail. 17-0044

On January 5th at about 8:46 pm, a UPD officer was in the 300 block of East Gobbi Street, when he observed 2 subjects behind Farmers Insurance on East Gobbi Street. The officer contacted the two, one of which was identified as Tony Paul age 57 and a 37 year old female. Officers were made aware that Paul had recently been released from jail on his own recognizances (O.R.) and that a term of his release was that he was to have no contact with this 37 year old female. Paul was placed under arrest for the court order violation and booked into county jail. 17-0055

On January 6th at about 2:04 am, a UPD officer was in the 600 block of East Perkins Street conducting a security check on the South Side of Chevron Gas station, when he observed a group illegally camping in the city. The officer contacted the group, one of which he knew as Charles Hensley age 53, a local transient. The officer was aware that Hensley had two misdemeanor warrants for his arrest. Hensley was placed under arrest and booked into county jail. 17-0056

On January 6th at about 12:35 pm, a UPD officer was dispatched to Safeway on South State Street, regarding a shoplifter in custody. Upon arrival the officer learned that James Lowe age 37 out of Clearlake, had been detained. Lowe had entered the store, selected items and exited without paying for them. On January 6th at about 2:17 pm, a UPD officer contacted 3 male subjects near the railroad tracks in the 600 block of Mason Street. The officer noticed an open twelve pack of beer near their feet. One of the subjects was identified as John Varney age 52, a local transient. A records check revealed that Varney was on probation with an abstention from alcohol clause. Varney was found to have been consuming alcohol and was placed under arrest for violation of his probation. On January 6th at about 8:08 am, a UPD officer was on patrol in the 300 block of East Perkins Street, when he observed a group of individuals sitting on the south wall of Walgreens drug store. The officer had earlier received information from Walgreens store manager, that they had been having problems with individuals loitering, smoking marijuana and harassing customers. The officer contacted the subjects, one of which was identified as Aubrey Thomas age 48, a local transient. A records check revealed that Thomas had a misdemeanor warrant for prior drug offences and he was placed under arrest. Thomas was booked into county jail. 17-0070

On January 7th at about 1:30 am, a UPD officer performed an enforcement stop on a vehicle in the 600 block of East Perkins Street, for a traffic violation. The driver was identified as Aurelio Alcaraz age 21. The officer suspected that Alcaraz was intoxicated and began a DUI investigation. On January 8th at about 12:36 pm, UPD officers responded to the Russian River Cemetery in the 900 block of Low Gap Road, regarding a possible burglary in progress. While responding, officers were advised the suspects were fleeing eastbound toward Frank Zeek School. Officers contacted the three, who were caught climbing over a fence from the cemetery to the school. The subjects were identified as Donald Styron age 33 a subject out of Oklahoma, Vance Madson age 19 and Olivia Mixon age 18, both local transient. During the subsequent investigation officers learned that the three were involved in forcing entry into a building at the cemetery. All were placed under arrest for burglary and booked into county jail. 17-0083

On January 8th at about 2:40 pm, a UPD officer was dispatched to a disturbance in the 100 block of North Main Street, regarding a disturbance. Upon arrival the officer contacted a subject named Peter Elder age 49. A records check revealed that Elder had a misdemeanor warrant. Elder was cited in the field for the warrant and provided a court appearance date. 17-0084

On January 8th at about 6:38 pm, a UPD officer was dispatched to a traffic collision in the parking lot of Lucky, in the 500 block of East Perkin Street. Upon arrival officers found that the driver of a black Ford pick-up had collided with a parked car. The driver was identified as Gabriel Araiza age 38, a local resident. Araiza appeared intoxicated and was found to be DUI, because of recent drug usage. A records check revealed that Araiza was on probation with a term of shall not operate a motor vehicle while under the influence of drugs. After medically cleared, Araiza was placed under arrest for DUI and for violating his probation. Araiza was booked into county jail. 17-0086

On January 8th at about 8:50 am, UPD officers were dispatched to a residence in the 1000 block of North Oak Street, regarding a report of a suicidal subject who had drank bleach. Upon arrival the officers spoke with the adult male. The adult male reported that he had been released from a hospital, was depressed and wanted to hurt himself. The male subject was detained and transported to UVMC, where a mental health professional was contacted and responded to take custody of him. 17-0088

On January 9th at about 8:34 am, a UPD officer was driving in the 1200 of North State Street, looking for a subject that had been reportedly walking into traffic. The officer located the subject, who was identified as Steven White age 39, a local transient. As the officer spoke with White, he suspected that White was under the influence of illegal drugs and evaluated him for this. White was placed under arrest for being under the influence of a controlled substance and was booked into county jail. 17-0089

On January 9th at about 3:59 pm, a UPD officer responded to the 100 block of Waugh Lane, for a report of a male subject urinating in the bushes. Upon arrival the officer contacted the male subject, who was found sitting on a duffle bag on the sidewalk. The subject was identified as Dustin Roat age 25, out of the Clearlake area.
