### Statistics

**Arrests included:** 7 for warrants, 5 for public intoxication, 4 for driving under the influence, 3 for being under the influence of a controlled substance and/or possession of drug paraphernalia, 3 for resisting or delaying an officer, 2 for violation of parole, 2 for Domestic Violence, and 1 each for shoplifting, possession of a controlled substance, prowling, threats, violation of a court order, brandishing a weapon, assault with a deadly weapon, and possession of a dangerous weapon. Of these arrests 5 were additionally charged with violation of probation/parole and 1 was additionally charged with resisting arrest.

**Officers investigated and took reports of:** 6 traffic collisions, 7 suspected child or Elder abuse, 3 counterfeit money, 4 vandalisms, 4 thefts, 2 vehicle theft, and 1 each of found property, missing person, fraud, violation of court order, and identity theft.

The Patrol Division's average response time to in-progress calls was 5 minutes. The average response time to all other calls was 17 minutes.

### Highlights for the Week

On 1/12/17 at about 1:36 PM, Ukiah Police Officer stopped a vehicle in the 700 blk of S. State St. for an expired registration. During this traffic stop the officer learned that two of the occupants of the vehicle, Sean Moynahan and Alicia Cruz, had warrants for their arrest. Both Moynahan and Cruz were arrested without incident. 17-0132

On 01/12/17, at about 3:52 PM, Ukiah Police Officers responded to Michaels, 1215 Airport Park Blvd, regarding an unwanted person in the parking lot. On arrival Officers were able to locate this subject, who was identified as Jennifer Cram. During the contact with Cram, Officers learned that Cram had a warrant for her arrest and she was currently on probation. Cram was arrested without incident and while searching her incident to this arrest she was found to be in possession of drug paraphernalia. Cram was booked into the Mendocino County jail for the warrant, possession of drug paraphernalia and violation of her probation. 17-0133

On 1/12/17 at about 10:43 PM, Ukiah Police Officer contacted Heath Brandon Jarvis. During this contact, the Officer learned that Jarvis had three active misdemeanor warrants for his arrest. As the Officer went to place Jarvis under arrest for the warrants, Jarvis lunged forward pulling away from the Officer. As Jarvis lunged forward he turned to face the Officer

attempted to strike the Officer's face with a closed fist. The Officer forced Jarvis to the ground where he continued to resist the Officer's attempts to place him under arrest. As the Officer continued to struggle with Jarvis, a U.S. Army recruiter that was inside the Armed Forces Recruiting Center observed the confrontation and came to the assistance of the Officer. With the assistance of the United States Army recruiter Jarvis was taken into custody without further incident. Once Jarvis was taken into custody the Officer learned that Jarvis was currently on probation. Jarvis was booked into the county jail for violation of probation the warrants and resisting an officer. 17-0135

On 01/12/17, at about 11:11 PM, Ukiah Police Officers responded to 778 S. State St. regarding a male subject loitering around a residence. Upon the Officer's arrival they observed a male subject, identified as Bradley Maxfield, standing outside of the above listed address between two vehicles. Officers contacted Maxfield and saw that he was displaying symptoms commonly associated with recent drug use. Officers conducted an evaluation of Maxfield and suspected Maxfield was under the influence of a controlled substance. Due to this the Officers went to place Maxfield under arrest at which time Maxfield fled from the officers. Maxfield was chased for a short distance and tackled to the ground where he was taken into custody without further incident. Maxfield was found to be currently on probation and was booked into the county jail for being under the influence, resisting arrest and violation of probation. 17-0136

On 1/13/17 at about 6:06 PM, Ukiah Police responded to an injury traffic collision at the intersection of N. Orchard Ave. and Clara St. Upon arrival Officers contacted one of the involved drivers, who was identified as Bardo Luis Valdez. While speaking with Valdez about how the collision occurred, Officers observed that he was displaying symptoms commonly related to alcohol intoxication. Officers also conducted a records check of Valdez and learned that he was currently on probation for a prior DUI. Officers had Valdez perform Field Sobriety Tests (FST's) to determine whether he was under the influence of alcohol. Valdez complied and completed a series of FST's. After completing the FST's, Officers believed Valdez was in violation of the DUI laws. Valdez was placed under arrest and booked into the Mendocino County jail for DUI and violation of probation. 17-0147

On 01/14/17 at about 2:19 AM, Ukiah Police Officers responded Jack in the Box, 1115 Airport Park Blvd, regarding a possible DUI driver in the drive through. Upon Officers arrival, they observed that a Mendocino County Deputy had stopped the vehicle as it pulled out of the drive through. Officers contacted the driver, identified as Tevin Durell Marizette. While speaking with Marizette, Officers observed that Marizette displayed symptoms commonly related to alcohol intoxication. Officers had Marizette perform Field Sobriety Tests (FST's) to determine whether he was under the influence of alcohol. Marizette complied and completed a series of FST's. After completing the FST's, Officers believed Marizette was in violation of the DUI laws. During this time Officers also learned that Marizette was currently on probation. Officers placed Marizette under arrest without incident. Marizette refused to submit to further, so Officers obtained a warrant and obtained further testing from Marizette to determine his level of intoxication. Marizette was booked into the county jail for violation of DUI and violation of probation. 17-0149

On 1/15/17 at about 11:59 hours, Ukiah Police Officers responded to the Quest Mart, 915 N. State St, regarding a report of a shoplifting. Upon arrival, Officers learned that a subject entered the store and selected a 16 oz. Bud Light and a 24 oz. 4 Loko Sour Apple and then left the store without paying for the two items. The store clerk attempted to stop the suspect, but the suspect struck the clerk twice on the side of the head. The suspect then fled the scene dropping the merchandise. Officers viewed the store surveillance system and obtained a description of the suspect. A search of the area was conducted and Officers located a subject matching the description in the 200 block of Clara Ave. This subject was identified as William Williams. While speaking with Williams regarding this incident, Officers noticed he displayed symptoms commonly related to alcohol intoxication. A records check of Williams was conducted and Officers learned Williams was currently on

probation for a prior shoplift. Upon further investigation Williams was identified as the suspect in the theft from the Quest Mart. Williams was arrested without incident for robbery and violation of probation. Williams was booked into the Mendocino County jail. 17-0159

On 1/15/17 at about 2:10 PM, Ukiah Police responded to a traffic collision in the 200 block of N. Main St. Upon arrival, Officers contacted one of the involved drivers, identified as Valerie Boutiette. While speaking with Boutiette about how the collision occurred, Officers observed that she was displaying symptoms commonly related to alcohol intoxication. Officers also conducted a records check of Boutiette and learned that she was currently on probation for a prior DUI. Officers had Boutiette perform Field Sobriety Tests (FST's) to determine whether she was under the influence of alcohol. Boutiette complied and completed a series of FST's. After completing the FST's, Officers believed Boutiette was in violation of the DUI laws. Boutiette was placed under arrest and later released on a promise to appear for DUI and violation of probation. 17-0160

On 01/15/2017, at about 11:19 PM, Ukiah Police stopped a bicycle being ridden by Donovan Parrish in the 800 Block of S. State Street. Upon contact with Parrish, Officers knew from prior law enforcement contacts that Parrish was currently on probation. Based on terms of probation, Officers conducted a search of Parrish's person. During this search Parrish was found to be in possession of a dangerous weapon, which was concealed on his person. Parrish was arrested without incident and booked into the Mendocino County jail for violation of probation and possession of a dangerous weapon. 17-0163

On 01/16/17 at about 11:36 AM, Ukiah Police Officers responded to Safeway, 653 S. State St. to conduct extra patrol in the parking lot due to recent and ongoing complaints of transients leaving garbage and harassing customers. Upon arrival Officers observed, Jennifer Black and Robert Douglas sitting on the east side of Safeway. Officers noticed that Black and Douglas were drinking from an open alcoholic beverage container. Due to this Officers contacted the two and learned that Douglas was on Post Release Community Service (PRCS). While speaking with Black, Officers noticed she was attempting to conceal a glass pipe commonly used to smoke methamphetamine. Based on this Black was detained and as she stood up a second pipe was located directly behind her. Black was placed under arrest without incident. During a search of Black's person and property a third pipe was located along with a small amount of suspected methamphetamine.

After placing Black under arrest, Officers continued to speak with Douglas and noticed that he was displaying symptoms commonly related to recent drug use. Due to this Officers conducted an evaluation of Douglas and based on this evaluation believed that Douglas was under the influence of a controlled substance. Due to Douglas' PRCS status, Officers contacted the Mendocino County Probation Dept. and advised probation of the above matter. Probation placed a hold on Douglas for violation of his PRCS terms. Both Black and Douglas were booked into the Mendocino County jail for their respective charges of possession of drug paraphernalia, possession of an illegal substance, and violation of PRCS. 17-0169

On 01/17/17, at about 12:21 AM, Ukiah Police contacted Pete Kavanaugh in the 800 Block of Cypress Ave. after observing him standing by a vehicle, which had its door open. During the contact with Kavanaugh officers learned that he was currently on PRCS. Officers conducted a records check of Kavanaugh and confirmed that Kavanaugh was currently on PRCS and subject to search. Officers conducted a search and found that Kavanaugh was in possession of a glass methamphetamine pipe, and an illegal weapon. Kavanaugh was arrested without incident and booked into the Mendocino County jail for possession of a dangerous weapon, possession of drug paraphernalia and violation of his PRCS terms. 17-0173

On 01/17/17, at about 9:39 AM, Ukiah Police Officers responded to 727 S. State St. for a report of a female in the lobby causing a disturbance. Upon arrival, Officers observed Ashley Ireland lying face down on the lobby floor and was handcuffed. Standing next to Ireland were two Welfare Fraud Investigators. Officers learned that Ireland had come into the building and while there caused a disturbance. While an employee attempted to speak with Ireland, Ireland became more irate, which caused the employee to move away from Ireland. As the employee walked away, Ireland attacked the employee from behind. Ireland grabbed the employee's hair and slammed the employee's head into the wall one time. Ireland then tried to drag the employee, but the employee was able to get free and get behind a secure door. During the investigation, Officers also learned that when Ireland entered the business she was making threats that she was in possession of a knife and was going to cause injury to people inside. It was for this reason the two Investigators responded and took Ireland into custody without incident. During a search of Ireland, she was found to be in possession of a knife. Ireland was booked into the Mendocino County jail for battery on a public official and threats. 17-0175

On 01/18/17, at about 8:11 PM, Ukiah Police Officers responded to Savings Bank of Mendocino County, 1100 Airport Park Blvd. regarding a physical fight in progress. Upon arrival Officers observed four male subjects in the parking lot of the bank. As the Officers arrived, three of the subjects ran eastbound across Airport Park Blvd. while the fourth subject remained sitting in the parking lot. While Officers contacted the fleeing subjects at the Quick Stop, an Officer contacted the seated subject and learned he had been assaulted by two of the three seen fleeing.

The victim reported to Officers that he was leaving Walmart when the three male subjects approached him. The victim reported that the three were starting a verbal argument with him over a prior incident. Not wanting to be involved in a confrontation, the victim tried to avoid the three by walking past them and asking them to "Leave me alone." Two of the subjects, one being a minor and the second subject identified as Daylee Watson began chasing after the victim as he fled from the group. As the victim fled from the minor and Watson he was struck by a bottle on the back. The victim believed the bottle was thrown by the minor. Upon reaching the parking lot of the bank the two had caught up to the victim.

While in the parking lot the victim reported that Watson removed a pocket knife from his pocket and brandished it threateningly as he started walking towards the victim. At this time Officers began arriving in the area and the suspects fled. Based on the victim's statement and evidence located the minor was placed under arrest for assault with a deadly weapon and later booked into the Mendocino County Juvenile Hall. Watson was found to be on probation and placed under arrest and booked into the Mendocino County jail for brandishing a weapon and violation of probation. 17-0185

On 01/19/17, at about 3:16 AM, Ukiah Police Officers responded to Best Western Inn, 555 S. Orchard Ave. for a report of a suspicious female banging on doors. Upon arrival, Officers contacted Dena Morris and determined she was responsible for causing the disturbance. While speaking with Morris, Officers learned that Morris was currently on probation and was not allowed to consume alcohol. Morris displayed symptoms commonly related to alcohol intoxication. Morris was placed under arrest without incident and booked into the Mendocino County Jail for violation of her probation. 17-0186

During this reporting period the Ukiah Police have taken and investigated three separate incidents regarding counterfeit money. Please be aware when conducting cash transactions and pay special attention to the bills being provided. Here are eight ways one may be able to identify a counterfeit bill.

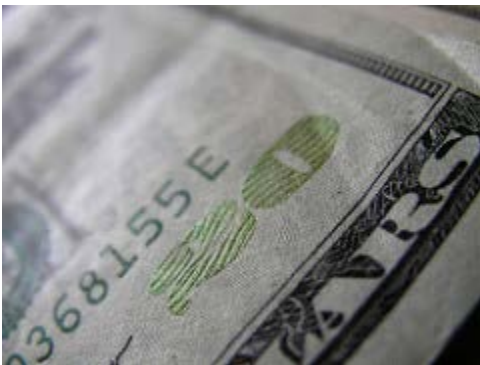

### 1. Color shifting Ink

One of the first things to look for when checking to see whether or not a bill is authentic, is to see if the bill denomination on the bottom right hand corner has the right color shifting ink. All denominations of \$5 or more have this security feature, going back to 1996. Take this \$20 for example, the 20 on the bottom right hand corner will have a copper color when you are looking straight at it. But, if you rotate the top of the bill down so that the bill looks flatter to your eye, it will turn more of a greenish color. See example images below. The left image from a more top-down view is clearly more of a copper color. But, when it is shifted to a flatter plane like the bill on the right, the denomination is much greener.



On the new \$100 bills, the inkwell also has color shifting ink, turning green and becoming extra visible when shifted to a flatter visual plane (example shows both copper color and green)

### 2. Raised Printing

All authentic US reserve notes have raised printing. You can see the difference in depth on the picture to the right when it is magnified. Many times, counterfeiters have a tough time duplicating this kind of printing method. To detect raised printing, take your fingernail and run it carefully down the collar/jacket. You should feel some vibration on your nail from the ridges. If not, then you better do an in-depth check on the bill.



### 3. Blurry Borders, Printing, or Text

If you notice significantly blurry borders, printing, or text, it is an automatic red flag. Authentic bills are extremely detailed, made using die-cut printing plates that are capable of impressively fine lines. Printers are rarely capable of the same level of detail. Take a close look, especially at the borders, to see if there is any blurring. Another thing to be watching for, is micro-printing. Authentic bills have super fine text located at various places on the bill, as shown on the left. Many times, counterfeiters do not have sophisticated enough printing equipment to duplicate micro-printing finely enough to where it is actually readable. If you get a magnifying glass or put the bills under some other form of magnification, you can generally tell pretty quickly whether or not the micro-printing is authentic. If it is unreadable, then it is probably counterfeit.



### 4. Red and Blue Threads (see picture)

If you take a close look at an authentic bill (as seen on the right), you will see that there are small red and blue threads woven in and out within the fabric of the bill. Printers try to reproduce this effect by printing red and blue threads onto the bill in a similar pattern. But, a close look will often reveal that such printing is merely surface level, tipping you off to a counterfeit.

### 5. Watermark

The next security feature to look for is the characteristic watermark. In many of the new bills, the watermark is actually a replica of the face on the bill. In some, it is only an oval spot.

There are several things to keep in mind when examining a watermark.

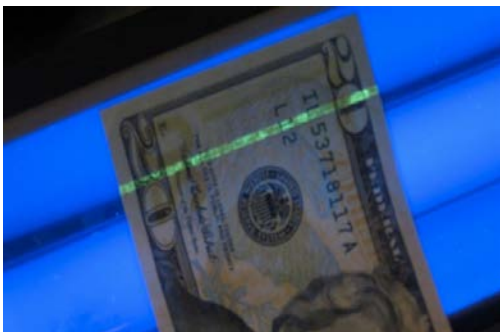
- The watermark should only be visible when you hold it up to the light
- The watermark should be on the right side of the bill
- If it is a face, the watermark face should exactly match the face on the bill (Sometimes counterfeiters use lower bills and just reprint, in which case the face wouldn't match)
- If there is no watermark or the watermark is visible without being held up to the light, the bill is most likely a counterfeit

### 6. Security Thread

The security thread is one of the most distinctive security indicators of an authentic bill. If you hold any bill up to the light, you will see a security strip on an authentic bill. It will have "USA" and the Bill's denomination, aka "USA 20" running vertically on the bill. The ultimate test, is to put the bill under a uv or black light and make sure the bill glows the correct color. This extra security measure was originally added to provide a quick way for bar owners (one of the businesses most commonly targeted to dispose of counterfeit bills) to check the legitimacy of a bill.

Here are the location and colors of the security threads on different bills:

- \$5 – Right side. Glows blue under UV light
- \$10 – Right side. Glows orange under UV light
- \$20 – Far left hand side. Glows green under UV light
- \$50 – Right around the middle. Glows yellow Under UV light
- \$100 – On left side. Glows pink under UV light



### 7. Security Ribbon (On New \$100 only)

The newly printed \$100 has an extra security feature. There is a visible blue security ribbon down the right middle of the bill that is 3D. If you move it back and forth, you will actually see the number 100 and a variety of little bells will move from side-to-side as the bill shifts.

### 8. Serial Numbers should correspond to Printing Year/Series

The last thing to check on a bill, is to make sure the serial number matches the supposed series/run year printed on the bill. Each letter that starts a serial number for a bill corresponds to a specific year (letter to year correspondence detailed below). Just be sure to check and make sure the series year stated is a correct match with the letter that starts the serial number, and vice versa (shown above) Here are the letters and the corresponding years/runs they should match with.

1. E = 2004
2. G = 2004A
3. I = 2006
4. J = 2009
5. L = 2009A
