The Patrol Division's average response time to in-progress calls was just over 5 minutes. The average response time to all other calls was just under 19 minutes.

Highlights for the Week

On March 9th at about 11:05 am, UPD officers were dispatched to New Beginnings in the 500 block of Low Gap Road, regarding an 8th grade student who had tied a hairband around her neck, attempting suicide. Upon arrival, officers contacted and detained the student. After evaluating the student, she was detained for a mental health evaluation and transported to Ukiah Valley Medical Center ER. A mental health professional was contacted and responded, taking custody of the juvenile. 17-0697

On March 9th at about 2:55 pm, UPD officers were dispatched to the area of Ross on East Perkins Street, regarding a physical altercation in progress. Dispatch advised responding officers that one subject was being attacked by multiple subjects. An officer arrived in the area and observed two subjects he recognized from prior contacts. These two subjects were pointing to and chasing a third. The officer responded to and contacted this third subject, who was wearing an ankle monitor and bleeding slightly front the side of his face. This subject was identified as Javier Pena-Martinez, a 35-year-old male out of Santa Rosa. Pena-Martinez was detained and a records check revealed that he was on probation out of

Sonoma County. During the subsequent investigation, officers learned that Pena-Martinez and another unidentified male subject had been inside JC Penny's on North Orchard Avenue. Pena-Martinez and this other unidentified subject took over \$1,000 worth of jeans and exited the store. A citizen saw the theft and tackled Pena-Martinez outside of the store. The other male dropped the stolen merchandize he was carrying and fled. Pena-Martinez got away from the citizen and was chased, before being located and stopped by law enforcement. The stolen merchandize was recovered and Pena-Martinez was placed under arrest for Grand Theft. Pena-Martinez was booked into county jail. 17-0700

On March 9th at about 9:06 pm, a UPD officer performed an enforcement stop on a vehicle in the 200 block of West Gobbi Street, for traffic violations. The officer contacted the driver, who was identified as Michael Erostico, a 28-year-old local resident. As the officer spoke with Erostico, he suspected that Erostico was intoxicated and began a DUI investigation. A records check revealed that Erostico's license was suspended for a prior DUI and he had a misdemeanor warrant. Erostico was placed under arrest for DUI, driving suspended and for the warrant. Erostico was booked into jail for the violations. 17-0704

On March 9th at about 10:11 pm, UPD officers were on patrol in the 300 block of Mason Street, when they contacted a male subject. The male subject was identified as Bruce Cartwright, a 24-year-old male out of Willits. A records check revealed Cartwright had two felony warrants and a felony parole pick up order for his arrest. Cartwright was taken into custody without incident and booked into county jail. 17-0705

On March 9th at about 3:44 am, UPD officers were conducting a security check of CVS on South Orchard Avenue, for subjects illegally camping, in response to continued complaints. Upon arrival, officers located a male subject camping, who they recognized as Scotty Willis, a 33-year-old local transient. Willis was aware of the city's camping ordinance and cited for the violation. 17-0706

On March 10th at about 6:06 pm, UPD officers were dispatched to Wal-Mart on Airport Park Blvd., for a report of a possible shoplifter inside the store. A description was provided and officers contacted the subject, who was identified as James Lowe, a 37-year-old transient originally out of Missouri. A records check revealed that Lowe was on probation, with a term that included stay away from Wal-Mart. Lowe was found to be in possession of a glass methamphetamine-smoking pipe. Lowe was placed under arrest for violation of probation and for possession of drug paraphernalia. Lowe was booked into county jail. 17-0710

On March 10th at about 10:58 pm, UPD officers were dispatched to the 1100 block of Mulberry Street, regarding a male subject screaming outside of the location. Upon arrival, officers located a male subject who they recognized as Jared Kidd, a 25-year-old local transient and known habitual drunkard. Kidd was found to be belligerent and intoxicated. Kidd was placed under arrest for public intoxication and booked into county jail. 17-0711

On March 10th at about 9:49 pm, UPD officers were dispatched to McCarty's Auto in the 900 block of North State Street, regarding a burglary in progress. The reporting party was watching the suspect on video surveillance and provided a description of him. Upon arrival, an officer located the suspect who was attempting to hide from officers behind a Coca Cola vending machine. The subject was identified as Keith Driver, a 41-year-old subject originally out of Missouri. A records check revealed that Driver was on probation, had a misdemeanor warrant for theft and a felony warrant for burglary, both out of Sonoma County. During the subsequent investigation officers learned that Driver used tools in an attempt to break into the vending machine, which damaged its lock. Driver was placed under arrest for his warrants,

violation of probation, possession of burglary tools, attempted theft, vandalism, and violation of his probation. Driver was booked into county jail. 17-0712

On March 10th at about 11:28 pm, UPD officers were conducting security checks behind Big Lots, in the 200 block of South Orchard Avenue, in response to complaints of illegal campers. During this, officers observed a male subject behind the closed business. Officers contacted the male, who was identified as Ryen Delgado, age 32. A records check revealed that Delgado was on probation for prior drug offences, with terms of search and seizure. Delgado was found to be in possession of heroin and drug paraphernalia. Delgado was placed under arrest for possession of a heroin, possession of drug paraphernalia and violation of his probation. Delgado was booked into county jail. 17-0713

On March 11th at about 1:30 pm, a UPD officer was dispatched to the bus stop across the street from the Library, in the 100 block of North Main Street, for a report of vandalism in progress. A description of the female subject was provided and the suspect was contacted in the area. The suspect was identified as Heather Michael, a 35-year-old transient. Michael was found to be confused and intoxicated. No permanent damage was found to the bus stop and Michael was placed under arrest for public intoxication. Michael was booked into county jail. 17-0716

On March 11th at about 6:58 pm, UPD officers were dispatched to Walgreens in the 300 block of East Perkins Street, for a report of an intoxicated male subject sleeping inside the store. Upon arrival, officers located the subject inside the store and woke him. The subject was identified as Antonio Collins, a 40-year-old male subject out of Fort Bragg. Collins was found to be intoxicated and placed under arrest for public intoxication. Collins was transported to jail, were officers were told Collins would need a medical clearance before he could be housed. Collins was transported to UVMC ER, medically cleared and returned to the jail, where he was booked on the violation. 17-0718

On March 11th at about 7:44 pm, a UPD officer was dispatched to UVMC ER, regarding a patient causing a disturbance and being combative. Upon arrival, officers contacted the subject, who they recognized as Pedro Reynaga, a 35-year-old transient. The officers leaned that Reynaga had been transported to the ER by ambulance, because he had fallen, hit his head and was intoxicated. Reynaga was being combative with ER staff, had now been medically cleared for incarceration and could be discharged. A records check revealed that Reynaga was on probation for a prior alcohol related offence. Reynaga was placed under arrest for public intoxication and violation of his probation. Reynaga was booked into county jail. 17-0719

On March 11th at about 8:32 pm, UPD officers performed an enforcement stop on a vehicle in the 400 block of Leslie Street. The driver verbally identified herself as Ana Hernandez age 43. During the subsequent investigation, the officer learned that the driver had lied about her name. Through law enforcement records, the driver was identified as being Anita Jimenez, a 42-year-old local resident who had two misdemeanor warrants for violation of her probation. Jimenez was placed under arrest for providing false ID to a police officer and the warrants. Jimenez was booked into county jail. 17-0720

On March 12th at about 3:51 am, UPD officers were conducting a security check of the Train Depot property, in response to ongoing complaints regarding illegal camping and associated problems with that activity. During this check, the officer contacted William Holt, a 52-year-old local transient. A records check revealed that Holt had two misdemeanor warrants, one for theft and the other for drinking alcohol in public. Holt was cited for the violations and provided with a court appearance date. Another officer contacted three subjects who were illegally camping. The subjects were identified as

On March 13th at about 5:55 am, UPD officers were again conducting a security check of the Train Depot property. A UPD officer contacted Susan Widmer-Feliz, a 58-year-old transient, who was camping on the property. Widmer-Feliz was cited for the camping violation and provided a court appearance date. Another officer contacted 53-year-old William Barry and 37-year-old Bobby Gray, both transients. Both were cited for the camping violation and provided court appearance dates. 17-0731 and 17-0732

On March 13th at about 7:01 am, a UPD officer was dispatched to an address in the 600 block of Kings Court, for a report of subjects illegally camping. Upon arrival, three subjects were found camping, 39-year-old Kellie McCosker, 39-year-old Corey Davey, and 41-year-old Jaqueline Davey, all transients. All three subjects were cited for the camping violation and provided with court appearance dates. 17-0734

On March 13th at about 8:14 am, a UPD officer was dispatched to Chase Bank, in the 700 block of South State Street, for a report of a subject camping and blocking an entrance to the bank. Upon arrival, the officer found the camper, who was identified as Richard Suggs age 33. Suggs was cited for the camping violation and provided with a court appearance date. 17-0735

On March 13th at about 12:07 pm, UPD officers were dispatched to the 1200 block of Airport Park Blvd., for a report of a female, who appeared to have been assaulted. Upon arrival, the female was identified as Mary Schaefer age 32. During the subsequent investigation, the officer learned that Schaefer had not been assaulted, but a records check revealed that she had 3 no cite misdemeanor warrants. Schaefer was placed under arrest and booked into county jail. 17-0740

On March 14th the Ukiah Police Department's Special Enforcement Team, with the assistance of the City of Ukiah Streets department, removed a dumpster load of trash from the Train Depot property.

On March 14th at about 1:30 pm, a UPD Officer responded to a residence on Waugh Lane, regarding a juvenile female who had reportedly taken pills the previous evening, in an attempt to harm herself. Upon arrival, the officer contacted the juvenile and after an investigation, detained her for a mental health evaluation. The female subject was transported to UVMC ER and a mental health professional was contacted, responded and took custody of her. 17-0753

On March 14th at about 9:03 pm, a UPD officer was patrolling when he contacted a male subject on Hamilton Street. The officer knew the subject as Ryan Dickerson, a 37-year-old transient. The officer was aware that Dickerson had three misdemeanor warrants for his arrest. Dickerson was placed under arrest and booked into county jail. 17-0757

On March 14th at about 11pm, UPD officers were dispatched to a residence in the 1100 block of North Bush Street, regarding an adult female who was having mental health issues and had locked herself inside a bathroom. Upon arrival, officers contacted the female, who admittedly was suicidal. The female subject was detained and transported to UVMC ER. A mental health professional was contacted, responded and took custody of the subject. 17-0759

On March 14th at about 11:38 pm, a UPD officer was conducting a security check of the Train Depot property, in response to ongoing complaints regarding illegal camping and associated problems with that activity. During this time, the officer contacted a subject he knew as Peggy Rand, a 39-year-old transient. A records check revealed that Rand had a
