Statistics

Arrests included: 1 hit and run, 5 public intoxication, 5 warrants, 1 DUI, 1 burglary, 1 theft, 2 violation of probation, 2 parole violation, 1 reckless driver, 2 possession of controlled substance/ possession of drug paraphernalia/VOP, 2 domestic assaults, 4 obstructing a peace officer, 1 assault, 1 battery/VOP, 3 possession of drug paraphernalia, 1 possession of controlled substance/probation violation, 1 under the influence of a controlled substance/ possession of controlled substance/possession of drug paraphernalia/VOP, 1 Sale of controlled substance/possession of controlled substance/possession of marijuana for sale/possession of drug paraphernalia/VOP.

Officers investigated and took reports of: 10 found property, 7 thefts, 4 traffic collisions, 3 CPS cross reports, 2 mental health detentions, 1 sex registrant, 1 found contraband, 1 graffiti, 1 cat bite, 1 death investigation, 1 vehicle towed for expired registration, 1 domestic violence investigation.

The Patrol Division's average response time to in-progress calls was just over 5 minutes. The average response time to all other calls was just over 27 minutes.

Highlights for the Week

On March 15th at approximately 10:53 am, officers were dispatched to the 100 block of Marlene St. for a report of a hit and run traffic collision. The suspect vehicle was described as a Silver Toyota SUV. Upon arrival, a witness provided officers with a description of the suspect. Officers later located the suspect in the 400 block of E. Gobbi St. The suspect was identified as Artavious Coleman, a 31-year-old resident. Coleman admitted to driving the vehicle and leaving the scene of the accident. Coleman was placed under arrest for the hit and run and booked into county jail. 17-0763

On March 15th, at approximately 4:06 pm, officers were dispatched to the 400 block of W. Perkins St. for a single vehicle traffic collision. Upon arrival, officers located a white Audi sedan in the roadway and a telephone pole, which had been sheared off at the base. No occupants were injured. 17-0770

On March 15th, at approximately 8:18 pm, UPD officers were patrolling the 400 block of Leslie St. when they noticed a male subject looking in to a vehicle. UPD officers stopped to contact the subject. UPD officers located two subjects, a male and a female, associated with the vehicle. The male subject, later identified at Rafael Mata a 36-year-old Ukiah resident, provided the UPD officer with a false name. A UPD officer recognized the subject from prior contacts as Rafael Mata. UPD Officers identified the female subject as Violet McAlister, a 54-year-old transient. A records check revealed both subjects to be on probation. UPD Officers searched the male subject and he was found to be in possession of

methamphetamine. UPD officers then searched McAlister and her vehicle. Officers located methamphetamine as well as a glass methamphetamine-smoking pipe in McAlister's vehicle. Mata was placed under arrest for false impersonation, violation of probation, possession of methamphetamine, and being under the influence of a controlled substance. McAlister was placed under arrest for violation of probation, possession of methamphetamine, and being under the influence of a controlled substance, and possession of drug paraphernalia. 17-0771

On March 16th, at approximately 11:43 pm, UPD officers were patrolling the 600 block of S. State St. when they noticed a male subject, later identified as Christopher Leloup, a 26 year old transient, standing outside of the business. A records check revealed Leloup was on probation and had a "No contact with Safeway" term listed. Leloup was arrested for violation of his probation and booked into the county jail. 17-0784

On March 17th, at approximately 3:38 pm, a UPD officer was dispatched to a male causing a disturbance in the roadway in the 800 block of Yosemite. Upon arrival, the UPD officer located Jared Kidd, a 25-year-old transient, yelling, stumbling in the roadway. The UPD officer determined Kidd to be intoxicated and placed him under arrest for public intoxication. Kidd was booked into the county jail. 17-0789

On March 17th, at approximately 11:07 pm, UPD officers were patrolling the 200 block of Hospital Dr. when they contacted a male subject. The male subject was identified as Steven Simpson, a 42-year-old county resident. A records check revealed Simpson had a felony warrant for his arrest. Simpson was taken into custody without incident and booked into the county jail. 17-0795

On March 18th, at approximately 8:32 pm, a UPD officer was patrolling the 300 block of E. Gobbi St. when he contacted a female subject. The female was identified as Debra Bauer, a 54-year-old Ukiah resident. A records check revealed Bauer was on probation. Bauer advised the UPD officer that she was in possession of methamphetamine. The UPD officer conducted a search of Bauer and located the methamphetamine as well as several bags of marijuana and drug paraphernalia. Bauer was placed under arrest for sales of a controlled substance, possession of controlled substance for sale, possession of marijuana for sale, possession of drug paraphernalia and violation of probation. Bauer was booked into the county jail. 17-0804

On March 21st, at approximately 10:21 am, a UPD officer was patrolling the 600 block of N. State St. when he noticed a white Acura sedan. The UPD officer recognized the passenger in the sedan, Andrew Martinez a 27-year-old Ukiah resident, from prior law enforcement contacts and knew the subject was wanted for a parole violation. The UPD officer conducted an enforcement stop on the vehicle in the 900 block of N. State St. The UPD officer then arrested Martinez for the parole violation and Martinez was booked into the county jail. 17-0825

On March 21st, at approximately 3:56 pm, Officers were on an unrelated incident in the 700 block of S. State St. During that time, they located a male subject sleeping in the back of a vehicle. UPD Officers contacted the male subject, identified as Michael North a 28-year-old transient. It was determined that North had not reported to his Parole officer as required. North was arrested for his parole violation and booked into the county jail. 17-0831




